# SUBJECT: SAFER CAERPHILLY SCORECARD

## 1. PURPOSE OF REPORT

1.1 The purpose of this report is to inform and update members of the development of the Safer Caerphilly scorecard.

## 2. SUMMARY

2.1 Welsh Government has implemented a significant reform of the role of Local Service Boards that has affected the way in which statutory plans and partnerships work. This includes the development of a Single Integrated Plan based on an outcomes methodology, owned by the Local Service Board. This Plan builds on and replaces the separate statutory plans, which were in place – Children and Young People, Health Social Care and Well-Being, and Community Safety. Caerphilly County Borough Council's Single Integrated Plan "Caerphilly Delivers" was approved by Full Council on 23rd April.

## 3. LINKS TO STRATEGY

3.1 A Safer Caerphilly is a key outcome within the Single Integrated Plan – Caerphilly Delivers.

# 4. THE REPORT

## 4.1 Single Integrated Plan – Caerphilly Delivers

- 4.1.1 Through the production of a Unified Needs Assessment which analysed local data, and an extensive consultation process, five key outcomes were established:
  - Prosperous Caerphilly
  - Safer Caerphilly
  - Learning Caerphilly
  - Healthier Caerphilly
  - Greener Caerphilly
- 4.1.2 Each Outcome has a lead officer, who will be a senior manager from a partner organisation, and will be responsible for the development, implementation and delivery of an action plan to address the Priorities under their designated Outcomes.

4.1.3 In relation to Safer Caerphilly the lead officer is the Local Policing Unit Commander, Superintendent Brandon Williams. Supt Williams is supported in this work by the Safer Caerphilly Delivery Group, the membership of which reflects the statutory partners listed in the Crime and Disorder Act 1998.

# 4.2 Safer Caerphilly Scorecard

4.2.1 The Safer Caerphilly Delivery Group has developed a Scorecard for the Safer Caerphilly outcome, which is attached as Appendix 1. The scorecard details all of the objectives under each priority that the Partnership will work towards to achieve the overall outcome. The scorecard will be updated quarterly and reported on to the members of the Delivery Group who will monitor progress against the targets. The scorecard could also be reported on at each of the Crime and Disorder Scrutiny Committee meetings if requested.
