#### 1. APOLOGIES FOR ABSENCE

Apologies for absence were received from Councillors Mrs E.M Aldworth, Mrs G.D. Oliver and J. Simmonds, together with Mrs B. Davies (UCAC), Miss H. Marsh (ASCL), Mr C. Parry (NAHT), Captain C. Di-Palma (Salvation Army), Rev E. Williams (Baptist Union of Wales) and Ms R. Bradshaw (Co-opted Member).

#### 2. DECLARATIONS OF INTEREST

Mrs N. Boardman (NUT) declared an interest in Agenda Item 7 (Caerphilly School Inspection Reports Analysis - Autumn 2015-Summer 2016), and Miss H. Bartley (ATL) declared an interest in Agenda Item 9 (Revised GCSE Specifications for Religious Education Update). Details are minuted with the respective items.

#### 3. MINUTES - 14TH JUNE 2016

RESOLVED that the minutes of the Caerphilly SACRE meeting held on 14th June 2016 be approved as a correct record and signed by the Chair.

#### 4. SCHEDULE OF MEETINGS 2016-17

SACRE noted the dates of the next two meetings:-

The Spring Term meeting will be held on Thursday 16th March 2017 – venue and time to be confirmed. Trinity Fields School or alternatively another primary school in the county borough were suggested as potential venues and it was agreed that the Clerk to SACRE would inform Members once arrangements are secured.

The Summer Term will be held on Monday 19th June 2016 (2pm) at Blackwood Comprehensive School.

#### MEMBERSHIP UPDATE 2016-2017

Mrs Vicky Thomas (RE Consultant to SACRE) referred Members to the current list of SACRE membership as contained within the agenda papers.

It was noted that Mr Eddy Mushayanyama (Race Equalities Wales) had recently resigned from Caerphilly SACRE owing to work commitments. Members placed on record their thanks to Mr Mushayanyama for his valued contribution to SACRE and wished him well for the future.

Mrs Thomas explained that this co-opted position had originally been allocated to VALREC (which had since disbanded and had been superseded by Race Equalities Wales). It was agreed that the Clerk to SACRE would seek a replacement co-opted member from Race Equalities Wales or an equivalent equalities organisation.

SACRE noted the contents of the report.

# 6. CAERPHILLY SACRE ANNUAL REPORT 2015-16 AND PROGRESS REPORT OF SACRE DEVELOPMENT PLAN 2015-2018

Mrs Thomas presented the draft Caerphilly SACRE Annual Report for 2015-2016 for Members' consideration and approval prior to its submission to the Welsh Government's Department for Education and Skills (DfES) by 31st December 2016.

The Annual Report outlined the activities of SACRE during the academic year 2015-2016 and Members' comments were welcomed on its contents. The RE Consultant referred Members to the executive summary of advice given by SACRE, and highlighted specific issues and the actions taken by SACRE to ensure it met all its statutory requirements.

Members were asked to check the Annual Report for accuracy and amendments were noted in respect of the list of presentations given to SACRE throughout the academic year. It was agreed that the final version of the Annual Report be submitted to DfES and circulated electronically to WASACRE (who will include the Annual Report on their website), together with schools and other relevant parties.

Subject to the above amendments, it was unanimously agreed that the SACRE Annual Report for 2015-2016 be approved.

Members were also referred to the Caerphilly SACRE Development Plan for the academic years 2015-2018, which has identified the key issues that need to be addressed in respect of RE provision across all schools in the county borough. A copy of the current Development Plan was included within the SACRE Annual Report, which summarised the actions identified, outcomes required and progress made in respect of RE provision during the academic year 2015-2016.

Having fully considered the report, Members noted the content and progress of the SACRE Development Plan 2015-2018 to date.

# 7. CAERPHILLY SCHOOL INSPECTIONS REPORT ANALYSIS AUTUMN 2015-SUMMER 2016

Mrs Nicola Boardman (NUT) declared an interest in this item as her school was referenced in the report. In that there was no decision being taken on this item, the interest was deemed to be personal and not prejudicial, and she remained in the meeting room during consideration of the item.

Councillor John Taylor (Chair) gave his apologies to SACRE and left at this point in the meeting owing to a prior engagement. Mrs Janet Jones presided as Chair for the remainder of the meeting.

The report outlined the main RE findings derived from the Estyn inspection of fourteen Caerphilly schools between Autumn 2015 and Summer 2016. The analysis focused on comments in relation to spiritual development and collective worship. The context of the report was explained to SACRE and that the focus of SACRE's remit was on RE and collective worship findings and not the general inspection results of the school, which could significantly vary in other areas.

Mrs Thomas provided a detailed summary of the findings for each of the inspected schools, including details relating to spiritual development, the quality of collective worship and whether the school met statutory legal requirements in relation to collective worship. Other comments and issues were also outlined in the findings.

The report explained that the Estyn Common Inspection Framework notes that inspectors should only report on instances where the school does not comply with statutory requirements relating to collective worship. It was therefore assumed that as Estyn had not noted any instances of non-compliance, all schools inspected met statutory requirements in relation to collective worship. Additionally, SACRE were pleased to note that eight of the Estyn inspections commented on the quality of collective worship in schools

A number of positive outcomes were derived from the analysis and detailed to SACRE Members, including the finding that pupils usually have appropriate opportunities to reflect and develop their spiritual awareness. Pupils learn about global citizenship in weekly assemblies, and visits by clergy members to the school and by pupils to the church for services (such as harvest festival) are helpful in providing worthwhile opportunities to enhance pupils' spiritual development and moral well-being. Assemblies promote pupils' moral awareness well with clear messages, such as the importance of treating everyone equally. One report observed that collective worship develops pupils' understanding of other beliefs.

It was noted that following inspection of St James Primary, Estyn made a number of recommendations, including that the school should develop curriculum planning to ensure systematic coverage of all subjects in Key Stage 2. Discussion took place on this matter, with SACRE keen to ascertain as to whether this recommendation includes the subject of Religious Education, and what action is being taken on the matter if this is the case. Mrs Jacquelyn Elias (Service Manager – Additional Learning Needs) suggested that it may be beneficial to explore this matter with the school once the newly appointed headteacher has taken up her post in the Spring Term.

It was agreed that a letter would be sent to St James Primary School in the meantime to establish whether this recommendation encompasses the teaching of RE. It was also noted that SACRE had recently responded to the school regarding a query on the statutory requirements for RE and the recommended subject time allocation for pupils at primary level.

Discussion took place regarding the Estyn inspection findings for the two secondary schools inspected. During the inspection of Ysgol Gyfun Cwm Rhymni, Estyn commented on some "interesting assemblies" in relation to the quality of collective worship. Members suggested that it could be useful for inspectors to provide more detail in such cases in order for ideas to be shared as an example of good practice. Mrs Thomas explained that guidance is currently being produced by her RE associates which will encompass the provision of collective worship in schools.

SACRE were pleased to note the positive findings relating to the teaching of RE at Blackwood Comprehensive School, including promotion of SMSC, the provision of a broad and balanced curriculum, learning about sustainable development and global citizenship, and pupil awareness of diversity and respect for minority groups. Mrs Nicola Boardman (RE Coordinator at the school) also summarised details of the in-depth inspection process that had been carried out at the school and across the RE department.

Members noted the analysis of the Estyn inspection reports in relation to Religious Education and the actions arising from these.

#### 8. RE AND THE NATIONAL CURRICULUM: UPDATE

The report outlined the latest developments regarding the review of assessment arrangements and the National Curriculum in Wales, which was announced by the Minister for Education and Wales on 1st October 2012.

In February 2015, Professor Donaldson released his report and recommendations via the document "Successful Futures – Independent Review of Curriculum and Assessment Arrangements in Wales". In October 2015, "A curriculum for Wales – a curriculum for life" was released, which outlines the plan for taking forward these recommendations.

Pioneer schools and stakeholders will have a say in the shape of the curriculum via a series of meetings. Curriculum Pioneers will define an Area of Learning and Experience framework, and New Deal Pioneers will focus on the pedagogy and leadership needed to deliver the requirements of the new curriculum as it develops.

Welsh Government held a meeting with WASACRE Officers on 13th September 2016, where it was established that there are 3 strands involved in the shaping of this curriculum (attending induction events, high level areas of learning and experience (AOLE) design and subject specific design). WASACRE have been asked to support WG by advising on reading material, attending meetings across the country on this matter, and identifying schools that exemplify good practice in RE. The timeline and other documents in respect of the curriculum reform are available on the Welsh Government website.

SACRE noted that a Policy Forum for Wales Keynote Seminar, entitled "The New National Curriculum for Wales – developing the Content of the Areas of Learning and Experience" took place in Cardiff on 13th October 2016. Mrs Thomas explained that she would make enquiries as to the outcomes arising from this seminar. Additionally, the National Advisory Panel for RE (NAPfRE) have begun the process of drawing up guidance document called "What makes good RE" for the Pioneer Network to consider when working on the shape of the RE curriculum. This is still ongoing and will provide guidelines on RE in schools.

During the course of the ensuing debate, Mrs Thomas explained that there are indications that the shape of the new curriculum in respect of RE will become more apparent in the New Year. Once further information is received in this regard, and subject to the advice from Welsh Government and WASACRE, then SACRE will be in a position to consider whether to initiate a review of the Caerphilly Agreed Syllabus for Religious Education. This document was last updated in 2008, and in 2013 a Standing Conference of Caerphilly SACRE endorsed the readoption of the Agreed Syllabus with an understanding that it be reviewed once further

information is received in relation to the assessment and National Curriculum review. SACRE also discussed the composition of the Pioneer Network and expressed a need for it to be widened to call in specialist expertise in specific areas as and when required.

Following consideration of the report, SACRE noted the latest developments relating to the position of RE in the curriculum.

#### 9. REVISED GCSE SPECIFICATIONS FOR RELIGIOUS EDUCATION: UPDATE

Miss Helen Bartley (ATL) declared an interest in this item as she has written part of the new specification referenced in the report. In that there was no decision being taken on this item, the interest was deemed to be personal and not prejudicial, and she remained in the meeting room during consideration of the item.

The report summarised the latest situation regarding proposed changes to specifications and assessment practices for Religious Studies (RS) at GCSE and GCE (AS and A) Level. SACRE agreed that any information should be shared with schools as soon as possible after receiving any updates from WJEC to help RE departments in their planning and preparation of schemes of work and for teaching the revised specifications.

The A/AS level specifications have been approved and are in place for first teaching from September 2016. The GCSE specifications were delayed and therefore deferred by Qualifications Wales until first teaching in 2017. However, there has been an issue for those schools that start the GCSE courses early (such as Year 9) because they will need to start teaching from the new specifications in September 2016, and therefore they have been anxiously awaiting an outline of the new GCSE specification.

In September 2016 a number of updates were received from Lynda Maddock at WJEC regarding the revised GCSE specification. SACRE subsequently wrote to all secondary schools and SACRE members to inform them of the latest situation regarding the specifications. A copy of this information was appended to the report. The first update outlined details of the draft specification and provided advice on resources available via the Edequas website. The second update provided a link to sample chapters from the textbook that has been written for the Edequas specification, which has a significant deal of overlap with the draft Welsh specification, particularly in relation to the Philosophical/Ethical themes sections.

Mrs Thomas advised Members that the revised GCSE specification was officially approved on 12th October 2016 and has now been placed on the WJEC website.

Caerphilly SACRE were pleased to learn of the latest progress made in respect of the revised GCSE specification and noted the contents of the report.

#### 10. INCLUSIVE SACRES AWARD

Consideration was given to the report, which outlined details of the Accord Coalition's Inclusivity Award 2017. This year, award nominations have been ring-fenced to SACREs and the award is seeking to reward those SACREs that work hardest in their area towards boosting the growth of inclusion, cohesion and mutual understanding between those of different religions and beliefs. Further information regarding the award and a nomination form were appended to the report.

Mrs Thomas explained that this is a very positive award which recognises the hard work of SACREs and that she wanted to bring it to the attention of Members. However, there would be limited opportunity to evidence Caerphilly SACRE's role in the growth of inclusion, cohesion and mutual understanding between different religions and beliefs across the county

borough, especially given that Caerphilly SACRE has experienced difficulty in finding representatives from non-Christian faith groups. Mrs Thomas was therefore of the view that it would not be conducive for Caerphilly SACRE to apply for this award.

Members thanked Mrs Thomas for bringing the award to their attention and noted the contents of the report.

#### 11. HOLOCAUST MEMORIAL DAY 2017

The report informed Members of the resources available to schools in order to commemorate Holocaust Memorial Day 2017.

The RE Consultant advised that the theme for 2017 is "How can life go on?" which refers to the continuing aftermath of the Holocaust and of subsequent genocides. Further information on the theme and free educational resources are available through the Holocaust Memorial Day (HMD) website at <a href="https://www.hmd.org.uk/content/for-educators">www.hmd.org.uk/content/for-educators</a>.

Reference was made to commemorative events that took place across the county borough during Holocaust Memorial Day 2016 to remember the victims of the Holocaust and other atrocities. It was agreed that the Clerk to SACRE would forward the details of this year's events to SACRE Members once they are finalised.

Members noted the theme and resources available to schools in order to commemorate Holocaust Memorial Day 2017 and it was agreed that the Clerk to SACRE would write to all schools to make them aware of these resources and encourage them to commemorate the event.

#### 12. CORRESPONDENCE

The Clerk to SACRE summarised a number of updates that had been circulated to all secondary schools in the county borough regarding the revised criteria for GCSE specifications.

Secondary schools received a congratulatory letter from SACRE in respect of their examination results in Religious Education for Summer 2015. A letter was also sent to all secondary schools outlining the results of the WASACRE survey in respect of the Welsh Baccalaureate.

All primary schools were provided with advice on the correct use of the Incerts Assessment Programme software, together with information on RE teaching resources (an Autumn/Harvest Topic Pack from Books at Press). SACRE also provided advice to a primary school in response to a query that had been received regarding the study of Paganism.

SACRE were pleased to note the volume of correspondence sent on their behalf and were of the view that schools are being kept fully updated on all developments relating to Religious Education.

# 13. WASACRE - FEEDBACK FROM THE WASACRE MEETING IN RHYL, DENBIGSHIRE ON 23RD JUNE 2016

Members were updated on the discussions and deliberation of WASACRE at its meeting in Rhyl on 23rd June 2016. A copy of the draft minutes was included in the meeting papers.

At the WASACRE meeting, discussion took place regarding the results of the Welsh Baccalaureate Survey recently sent to all schools across Wales. Concerns were raised that a

number of respondents (including two Caerphilly schools) had stated that since the implementation of the new Welsh Baccalaureate, their school did not provide statutory Religious Education according to the Locally Agreed Syllabus for RE at Key Stage 4.

WASACRE agreed that a presentation made at the meeting in respect of survey responses be forwarded to SACREs for circulation to their schools. It was also agreed that information be sent to SACREs regarding the schools who may not be meeting current statutory requirements for RE and that feedback be requested on local authorities' actions and progress on this matter.

Additionally, WASACRE sought advice from Welsh Government who outlined the action that should be taken in this respect. In the first instance SACREs are advised to formally inform/advise the Local Authority. If the situation remains the same and the school or schools involved continue to not meet the statutory requirement for RE, SACREs are advised to inform the Wales Association of SACREs. WASACRE is advised to write to the Local Authority involved to advise/remind them of their duty and to pass this information on to Welsh Government. An email from the Clerk to WASACRE was tabled at the SACRE meeting which summarised this advice.

Discussion took place on this matter and it was agreed that the Clerk to SACRE would write to all secondary schools in Caerphilly in relation to the statutory requirement at Key Stage 4. The letter will seek acknowledgement of its contents from the Headteacher or Head of RE at each school to ensure that this information has been received and understood by the appropriate persons. Additionally, Mrs Thomas confirmed that she would contact the two schools who had indicated they are not meeting the statutory requirement to confirm that they have understood and answered the survey question correctly, and if so, to address the course of action to be undertaken in this respect. Discussion also took place on the Short Course and the planning that needs to be undertaken by RE teaching staff in order to ensure it fulfils the requirements of the Agreed Syllabus.

SACRE noted the discussions and deliberations of WASACRE at the Rhyl meeting.

#### 14. REPRESENTATION AT FORTHCOMING WASACRE MEETINGS

Members were advised of the date and time of forthcoming WASACRE meetings and sought nominations for representation from Caerphilly SACRE.

Councillor Mrs E. Hawthorn, Mrs J. Jones, and Mrs V. Thomas expressed an interest in attending the WASACRE meetings on 18th November 2016 (Carmarthenshire) and 3rd March 2017 (Usk). Councillor J. Taylor had also indicated earlier in the meeting that he might be able to attend these meetings. Mrs J. Elias volunteered as a reserve attendee for these meetings, They will be contacted with the agenda papers nearer to the meeting date and asked to confirm attendance. The Clerk to SACRE will inform WASACRE of the attendees.

Discussion took place regarding attendance at WASACRE meetings and ways of encouraging attendance. The RE Advisor outlined the importance of adequate representation from all SACREs and urged Members to attend WASACRE meetings whenever it is geographically feasible for them to do so.

The presiding Chair thanked the Members of Caerphilly SACRE for their attendance at the meeting.

SUBJECT: ANALYSIS OF EXAMINATION RESULTS 2016

#### A PURPOSE OF REPORT

To inform members of the attainment at GCSE and A/AS level of Caerphilly pupils in Religious Studies and Religious Education for 2016.

#### **B** BACKGROUND

The information for 16 year- olds currently relates to those electing to follow a course in religious studies in Years 10 and 11 or A/ AS level and to those following GCSE short course in Religious Studies as the schools' provision for RE as part of the basic curriculum.

It should be noted that definitive conclusions cannot be drawn because the figures represent raw scores and do not necessarily reflect the selectivity of the entry and in some cases the numbers are too small to be statistically significant.

#### C RECOMMENDATIONS

- 1. That SACRE note and discuss the examinations results for 2016
- 2. To consider circulating the findings to secondary schools in the Authority.

#### PLEASE NOTE:

THE RESULTS RECORDED HERE ARE FOR THOSE PUPILS ENTERED FOR THE EXAMINATIONS. THEY DO NOT NECESSARILY REFLECT THE NUMBER OF PUPILS FOLLOWING THE EXAMINATION COURSE NOR DO THEY INDICATE HOW WELL PUPILS ARE PERFORMING RELATIVE TO THEIR ABILITY.

- The overall % of A\*- A grades was 27.7% which is slightly below 2015 but better than 2014 and is better than the Consortia figure (23.9%) and comparable with the All Wales figure (27.8%).
- The overall % of A\*- C grades was 71.1% which is comparable with previous performance and better than the Consortia figure (66.3%). It is comparable with the All Wales figure (72%).
- The overall % of A\*- G grades was 97.8% and is comparable with previous performance and better than the Consortia figure (96.7%) and comparable with the All-Wales figure (97.8%).

#### Conclusions

- Results continue to be good and compare well with previous performance.
- Results are better than Consortia figures at all grade boundaries and comparable with All Wales figures at all grade boundaries.

- The overall % of A\*- A grades of 13.8% is below 2015 performance but better than 2014 performance. It is better than the Consortia (12.8%) and the All Wales (11.4%) figures.
- The overall % of **A\*- C grades was 45.8%** is below previous performance. It is better than the Consortia figure (42.1%) and comparable with the All Wales figure of 45.4%.
- The overall % of A\*- G grades was 92.9% is better than 2015 but below 2014 performance. It is better than the Consortia (88.6%) and the All Wales (90.6%) figures.
- A significant number continue to be entered for short course and this is very
  encouraging because it provides pupils with the opportunity for accreditation for their
  KS4 study. We must also bear in mind that pupils do not usually opt to follow the
  Short Course but it is delivered as part of the statutory requirements for RE.

- There were 84 entries from 9 schools one more school than previous years. The

EAS to appoint lead schools for Religious Studies to provide support for non-core WJEC GCSE subjects first teaching September 2017. The successful department/s will receive £4,900 to develop a support programme for the new GCSEs.

#### Memo from James Kent 8/2/17

Despite only having limited interest from schools, EAS were able to secure two schools to lead in this area - both of whom submitted strong applications. These are both schools who deliver to large cohorts at KS4 with good outcomes for learners within this subject area:

- Rhian Davies King Henry VIII
- Clare Lane Ebbw Fawr LC

JK will meet with the schools in February to determine the forward work plan - but it is likely to include:-

- 1. Identification of key areas of challenge for practitioners.
- 2. Focussed development of resources to support the above (following consultation with other lead practitioners across Wales to avoid duplication of effort).
- 3. The leading of half termly network meetings for schools in all EAS LA areas dates TBC. This will be an opportunity to share good practice (resources and pedagogies) and develop an understanding of the requirements of the new Specifications (assessment etc.).
- 4. Teachmeet events to share thinking and practice (probably at least one teach-meet style event (twilight) open to all practitioners to share most effective lesson ideas).

Despite a likely cut in the GCSE grant to Consortia for the next financial year, EAS are looking to sustain funding for non-core subjects as part of our business planning processes. Whilst the role will largely focus on GCSE for the first year, there will also be scope for the group to begin looking at the emerging thinking development in the new Curriculum, as they emerge.

WASACRE representatives, namely Phil Lord, Libby Jones and Gill Vaisey, have represented WASACRE at regular Stakeholders' meetings with Welsh Government to discuss the new curriculum.

The National Advisory Panel for RE (NAPfRE) has drawn up a draft document outlining some guidelines on *What makes good RE* for WASACRE representatives to submit to the pioneer network for consideration when working on the shape of the RE curriculum. This has been submitted to Manon Jones\* of Welsh Government for information to be shared at some point with the pioneer schools working on the Humanities AOLE (Areas of Learning and Experience).

Strand 2: Subject specific design and developing the Areas of Learning and Experience. Representatives from the pioneer schools will consider the strands within each area of learning and experience. This is where the in depth subject specific knowledge will be required.

\* Manon Jones (Curriculum Division of Welsh Government) is responsible for the pioneer schools and two areas of learning and experience (AOLE), Humanities and Language and Literacy

#### Timescale

- Pioneer School launch 17th January 2017
- Humanities AOLE meeting with Manon Jones 18th January 2017
- Pioneer schools will meet to discuss the way forward with their AoLE in February/ March 2017.
- The first expected output is expected to be a set of principles which demonstrate how the Humanities AoLE links with the 4 purposes.
- The second output is likely to be the specifics and detail of the AoLE
- The third output is likely to be when separate disciples work alone or togetherperhaps forming sub groups or focus groups.

WASACRE have a meeting with The Minister for Education (Kirsty Williams) on 2nd March 2017 and will pose a question around the status of the Agreed Syllabus in the light of the proposal that RE becomes part of the Humanities AoLE.

#### STATUTORY REQUIREMENTS FOR RELIGIOUS EDUCATION

Caerphilly Standing Advisory Council for Religious Education (SACRE) has asked me to bring to your attention the statutory requirements for Religious Education in state maintained schools. As the curriculum review is getting under way it seems that some schools are confused as to the status of agreed syllabuses in schools.

As I am sure you are aware Religious Education is part of the basic curriculum and therefore sits outside the National Curriculum. The RE curriculum is locally determined by the local authority and its SACRE. This means that there is a statutory requirement for LAs to provide Religious Education according to an agreed syllabus. With regard to the position of the Caerphilly agreed syllabus it was re-adopted in 2013 and therefore the current syllabus stays in place with an understanding that the syllabus will be reviewed once the shape of the new Donaldson curriculum is defined. There would need to be a change in legislation for the delivery of RE according to an agreed syllabus to be rescinded.

Professor Donaldson report Successful Futures - Independent Review of Curriculum and Assessment Arrangements in Wales recommended that Religious education should form part of the Humanities Area of Learning and Experience, and should remain a statutory curriculum requirement from reception.



SACRE is aware that the Pioneer schools are now meeting in order to shape the new curriculum. The projected time line for Strand 3, where the *defining and elaborating* of each Area of Learning and Experience (AOLE) and the in-depth subject specific details will be shaped, is from January 2017. Until such time as the detail of the AOLE are shaped and a review of the agreed syllabus takes place then SACRE wish to ensure that schools understand that **coverage of the programmes of study of the locally agreed syllabus is the main statutory requirement.** 

I attach a copy of the current Caerphilly agreed syllabus for RE and the programmes of study for KS2 can be found on pages 20-21 and the detail of that worked out in Annex 3 pp37-39.

As regards the **Foundation Phase** three broad areas of People, Beliefs and Questions are studied. The detail of that is worked out in Annex 2 pp 34ff under the topic titles of Themselves, Other People and Living Things. This provides a good base for RE in the Foundation Phase.

#### STATUTORY REQUIREMENTS FOR RELIGIOUS EDUCATION

Caerphilly Standing Advisory Council for Religious Education (SACRE) has asked me to bring to your attention the statutory requirements for Religious Education in state maintained schools. As I am sure you are aware Religious Education is part of the basic curriculum and therefore sits outside the National Curriculum. The RE curriculum is locally determined by the local authority and its SACRE. This means that there is a statutory requirement for LAs to provide Religious Education according to an agreed syllabus and monitor that statutory requirements are being adhered to by schools. With regard to the position of the Caerphilly Agreed Syllabus for RE it was re-adopted in 2013 and therefore the current syllabus stays in place with an understanding that the syllabus will be reviewed once the shape of the new Donaldson curriculum is defined. There would need to be a change in legislation for the delivery of RE according to an agreed syllabus to be rescinded.

Professor Donaldson report Successful Futures - Independent Review of Curriculum and Assessment Arrangements in Wales recommended that Religious education should form part of the Humanities Area of Learning and Experience, and should remain a statutory curriculum requirement from reception.



SACRE is aware that the Pioneer schools are now meeting in order to shape the new curriculum. The projected time line for Strand 3, where the *defining and elaborating* of each Area of Learning and Experience (AOLE) and the in-depth subject specific details will be shaped, is from January 2017. Until such time as the detail of the AOLE are shaped and a review of the agreed syllabus takes place then SACRE wish to ensure that schools understand that **coverage of the programmes of study of the locally agreed syllabus is the main statutory requirement.** 

I attach a copy of the current Caerphilly agreed syllabus for RE where you can see the programmes of study for all key stages in the secondary school on pages 22-31.

SACRE is particularly interested in the delivery of **Religious Education at KS4** where there appears to be some confusion regarding statutory requirements. SACRE would like to draw your attention to the statutory programme of study which can be found on pages 30-31. Many schools in Wales are providing statutory RE by following either a GCSE Short Course or a GCSE Full Course or a combination of the two courses. SACRE wish to inform you that **this would fulfil statutory requirements** as long as **all** pupils are receiving religious education whether or not they are entered for accreditation.

In 2016, the Wales Association of SACREs conducted a survey of the impact of the Welsh Baccalaureate Qualification (WBQ) on Religious Education in schools across Wales. SACRE understands that some schools are delivering RE at KS4 within the WBQ and believe that coverage of the Global Citizenship element of WBQ is sufficient to cover the RE requirements. Caerphilly SACRE would like to ensure that schools understand that the Global Citizenship unit alone would not be sufficient to cover all aspects of the agreed syllabus KS4 programme of study. The WASACRE survey showed that in some cases WBQ had some positive impact when schools increased the time allocation for RE within the WBQ so that all aspects of the agreed syllabus could be covered. However, that has to be measured against those schools who commented that the introduction of the WBQ was having a negative effect on RE such as loss of Short Course accreditation, over use of non specialists in the teaching of RE and RE subject specific skills being sacrificed to cover the more generic skills of WBQ.

SACRE would like schools to confirm receipt of this information by completing the attached pro forma below and returning to the Clerk to SACRE. The pro-forma concentrates on delivery at KS4 in particular because this is the area identified as of most concern to teachers of RE and also identified as raising issues in the WASACRE survey. Schools providing this information enables the LA and its SACRE to fulfil its monitoring role of RE in the curriculum and be assured that statutory requirements according to the agreed syllabus for RE are being met.

#### 1. Introduction and welcome

Chair of WASACRE, Phil Lord, welcomed members to Carmarthenshire. The Leader of the Council, Emlyn Dole, welcomed WASACRE to the Council Chamber. Members enjoyed the performance of the choir from Ysgol Gynradd Llangennech. Emlyn Dole shared his support for SACREs and recognised the importance of WASACRE and of RE in Wales in a climate of educational change. He acknowledged Carmarthenshire takes RE seriously and ensures a holistic education, which aims to develop empathy, tolerance and respect. As such it employs a Challenge Advisor to provide training and practical help to implement effective RE.

#### 2. Quiet reflection

PL led a reflection, asking members to consider the need to work towards unity within communities. RE is in a position to remind people of this responsibility.

#### 4. NAPfRE presentation

Dr. Llinos Jones, Headteacher, Ysgol Gymraeg Bro Myrddin presented on collective worship in the secondary school. Assemblies are organised so that all pupils have the opportunity to participate in and deliver a daily act of collective worship. They share ideas and celebrate success as well as reflect. During questions the Headteacher was thanked by a WASACRE member who had previously been a teacher at the school. PL expressed WASACRE's thanks and reflected that newly built secondary schools have no communal space and would, therefore, find it difficult to develop a sense of community via bringing all pupils in a school together. Comments included the positive contribution collective worship could make to a pupil's experience in a secondary school and the good practice that could be shared from the presentation provided by Bro Myrddin.

# 5. Minutes of meeting held in Rhyl, 23 June

The minutes were accepted as a true record of the meeting. Proposed by Huw Stephens and seconded by Edward Evans.

#### 6. Matters Arising.

VT said the new GCSE had been approved and was on WJEC website. She informed WASACRE that concerns had been raised at SACREs that there were training

T5: Eitem 5 - Incerts: Hysbysodd GV yr aelodau fod LJ wedi gofyn am ddatganiad gan Lywodraeth Cymru y gallem ei ddefnyddio i ddweud wrth Incerts fod y disgrifyddion lefel o fewn y meysydd llafur cytûn yn statudol. Fodd bynnag, nid oedd yr ateb gan Lywodraeth Cymru yn mynd i'r afael â'r cwestiwn gwreiddiol. Awgrymodd PYCAG y dylem fynd yn ôl at y ddeddfwriaeth wreiddiol sy'n datgan fod y Meysydd Llafur Cytûn yn statudol, ac felly bod y Lefelau oddi mewn iddynt yn statudol. Dywedodd Rheinallt Thomas fod swyddogion yn y Cynulliad yn ymwybodol fod gan CYSAG hawl i fabwysiadu'r Fframwaith Cenedlaethol, ond dim ond ar lefel leol gan GYSAGau unigol y gellir gwneud hyn yn lleol, nid yn genedlaethol. **T6. Bagloriaeth Cymru** - Cafwyd trafodaeth am ganlyniadau peidio â chyflwyno AG statudol, sydd yn broblem fwy eang nag yng Nghyfnod Allweddol 4 yn unig. Mae yna gyfrifoldeb lleol i sicrhau fod y Maes Llafur Cytûn yn cael ei weithredu. Nodwyd fod rhai Ysgolion Arloesi yn ansicr am statws y Maes Llafur Cytûn. Dywedwyd wrth CCSYAGauC fod hyn wedi cael ei drafod yng nghyfarfod PYCAG. Mae rhai CYSAGau

issues as there was an increase in content and more emphasis on textual concepts. Dan Foster – Head teacher representing Torfaen SACRE expressed concern that the cost of training by the WJEC has risen rapidly. Schools are finding this difficult because of financial constraints. Tudor Thomas agreed but said that training for new specifications was free. He said schools are on tight budgets and that representation is needed to WJEC suggesting that it carries a responsibility for schools in Wales in particular as it is the sole Examination Board in Wales. The WJEC are offering one free training place for all schools on four dates during this academic year.

**ACTION:** PL agreed to find the link to RE Ideas on the Peniarth website. Copies going back as far as 2000 have been made available by REMW. Every SACRE Clerk should have a copy of the list of RE Ideas publications to share with SACREs.

**P 4. Item 4.** The reply was sent to Lynda and LJ maintained email contact with WJEC regarding this issue. However, the letter to QW was not sent due to the Specification being accredited during the Autumn term.

**P4. Item 5 Humanists on SACRE** – Kathy Riddick from Wales Humanists has been invited to attend the Carmarthenshire meeting following a letter she sent to WASACRE highlighting this issue.

P5: Item 5 – Incerts: GV informed members that LJ had requested a statement from Welsh Government that we could use to inform Incerts that the level descriptions contained within agreed syllabuses are statutory. However, the response from Welsh Government did not address the original question. NAPfRE suggest we should go back to the original legislation which states that the Agreed Syllabuses are statutory and, therefore, the Levels within them are statutory. Rheinallt Thomas said officers in the Assembly are aware that it is the right of every SACRE to adopt the National Framework, but that this can only be done legally at a local level by individual SACREs, not at a national level. He also said Welsh Government must go forward carefully if RE is placed within humanities as RE has to be determined locally. GV proposed that WASACRE should make a second request to WG for a statement on the status of an agreed syllabus. This will be followed up by officers.

**P6.** Welsh Baccalaureate – A discussion was held on the consequences of not delivering statutory RE, which isn't just an issue at Key Stage 4. There is a local responsibility to ensure the Agreed Syllabus is being implemented. It was noted that some Pioneer Schools are confused as to the status of the Agreed Syllabus. WASACRE were told that this was discussed at the NAPfRE meeting. Some SACREs intend to write to

Roedd CYSAG Sir Fynwy yn teimlo y byddai'n werth cael darlun ehangach o'r hyn sy'n digwydd ledled Cymru, gan fynegi pryderon am yr ysgolion nad oedd wedi ymateb i'r arolwg. Holodd Dan Foster a allai camddealltwriaeth o natur statudol maes llafur cytûn olygu y byddai'r Ysgolion Arloesi yn gweithredu'n anghyfreithlon. Byddai'r llythyron gan GYSAGau yn helpu i'w hatgoffa am natur statudol y Maes Llafur Cytûn. Mae Swyddogion Awdurdod Lleol yn eistedd ar GYSAGau a nhw ddylai fod y cyswllt â'r ysgolion. Dywedodd un athro gynrychiolydd ei fod yn ymwybodol nad yw un ysgol yn ei ALl yn cydymffurfio â'r rhwymedigaeth statudol i AG oherwydd y Fagloriaeth. Gallai hwn fod yn llwybr llithrig ac mae angen i GYSAGau weithredu arno. Atgoffodd PL yr aelodau eu bod wedi cael eu cynghori gan Lywodraeth Cymru ynghylch y broses ar gyfer delio ag ysgolion nad ydynt yn cydymffurfio ac y dylai CYSAGau fod yn dilyn honno. Pryder Tudor Thomas oedd, oherwydd y newidiadau ym manylebau TGAU, fod y cynnwys wedi mynd yn drymach a bod hynny'n pryderu'r gymuned AG yng Nghymru gan mai dim ond AG arwynebol iawn y gall rhai ysgolion fod yn ei chynnig bellach.

Cytunwyd na fyddai CCYSAGauC yn ail-anfon yr arolwgi ysgolion ond y dylai pob CYSAG ddilyn hyn gyda'u hysgolion eu hunain ac adrodd yn ôl i CCYSAGauC. Awgrymodd MM y dylai CYSAGau geisio sicrhau fod yr arolwg yn mynd yn syth at y pennaeth adran ac nid at ysgrifenyddes yr ysgol neu'r pennaeth.

#### 7. Cyflwyniad - Cefnogaeth i ysgolion i gyflwyno'r manylebau TGAU Astudiaethau Crefyddol newydd a rôl Ymarferwyr Arweiniol

Cyflwynwyd gan Tonia Antinarzi sydd ar secondiad i ERW fel Arweinydd Dysgu pynciau Di-Graidd. Cyfrifoldeb Tonia yw gweithio gydag ymarferwyr arweiniol i sefydlu rhwydweithiau a sefydlu cefnogaeth i'r pynciau di-graidd. Sefydlwyd ymarferwyr arweiniol i AG ym mhob un o'r rhanbarthau. Maen nhw'n gweithio i greu adnoddau i gefnogi gweithredu TGAU newydd

schools reminding them of the obligation to follow the Agreed Syllabus. It was felt that there should be a consistent message sent out by SACREs across Wales.

Action: VT has written letters from her SACREs to schools reminding them of their statutory requirements and has agreed to share this with NAPfRE members so that they and their SACREs can consider whether to they should write something similar to their schools.

GV raised the issue that only 70 responses were received to the Welsh Bacc Survey and asked whether WASACRE would follow this up to get a fuller picture. Monmouthshire SACRE felt it worthwhile to get broader picture of what is happening across Wales, expressing concern about schools that had not responded to the survey. Dan Foster asked whether a misunderstanding of the statutory nature of an agreed syllabus could mean that Pioneer Schools could be acting illegally. The letters from SACREs would help in reminding them of the statutory nature of the Agreed Syllabus. Local Authority Officers sit on SACRE and they should be the link to schools. A teacher representative said that he is aware that one school in his LA is not complying with its statutory obligation for RE because of the Welsh Baccalaureate. This could be a slippery slope and SACREs have to act on it. PL reminded members that they have been advised by Welsh Government of the process for dealing with schools that are not complying and that SACREs should be following that. Tudor Thomas raised concern that due to the changes in GCSE specifications, the content has become heavier and that is worrying for the RE community in Wales as schools may now only deliver token RE.

It was agreed that WASACRE would not re-send the survey to schools but that each SACRE should follow-up with their own schools and feedback to WASACRE. MM suggested that SACREs should try to ensure that the survey goes directly to heads of department and not the school secretary or the headteacher.

# 7. Presentation - Support for schools in delivering the new GCSE specification for Religious Studies and the role of Lead Practitioners

Presented by Tonia Antinarzi who is seconded to ERW as Leader of Learning of Non-Core subjects. Tonia's responsibility is to work with lead practitioners to establish networks and to establish support for the non core subjects. Lead practitioners for RE have set up in each of the regions. They are working to create resources to support the implementation of the new

Atebodd Tonia, er na allai CBAC gadarnhau'r gwaith, byddent yn gallu gwirio eu bod ar y trywydd iawn. Cadarnhaodd PL y byddai cyflwyniad gan ymarferwr arweiniol yng nghyfarfod haf CCYSGauC ac y gallai pawb edrych ymlaen at gael diweddariad ar ddiwedd y broses.

#### 8. Diweddariadau:

**Diweddariad: Adolygiad Cwricwlwm** - Adroddodd BJ fod nifer o ysgolion yn ceisio dychmygu sut bydd Cwricwlwm Donaldson yn edrych. Mae'r ysgolion arloesi'n gobeithio y bydd Cam 2 yn dechrau ym mis

WJEC GCSE and are beginning to share information and resources via Hwb. Resources will be translated into Welsh and Quality Assured. Lead practitioners are keen to hear from classroom teachers who would like to work together to create resources. A SACRE rep raised concerns that increased content of the new specification could mean that that grades may not be as high if they are expected to deliver GCSE Religious Studies in an hour a week. VT asked whether there was an intention to share resources wider to other consortia. Tonia affirmed this and said that links are already being made with EAS in Newport. Alison Lewis, a Lead Practitioner, highlighted the difficulty in getting schools to use Hwb but said that the resources are there if they want access to them. Tonia said that the launch of Lead Practitioners was on 21st Oct and they have already made a lot of progress. A member asked if there had been involvement from SACREs in this process. Tonia confirmed this and is interested in hearing from schools with strong RE departments, especially Welsh language schools. Tonia will share the details of the lead practitioners for RE with WASACRE. Lead practitioners have written to all schools in the area to draw attention to the work they are doing. They are conducting a survey to map strengths.

BJ said that lead practitioners in North Wales have been getting organised and preparing resources. She asked whether they are doubling up on the work in Wales and whether they would benefit from working with colleagues across Wales. Tonia said that she sees her job as coordinating links with other consortia. A member asked who would be Quality Assuring. Tonia advised us that, whilst the WJEC can't endorse the work, they were able to check that they were on the right track. She also reported to WASACRE that they would also be using teachers in the area and Mary Parry, the Advisor. Everything should be ready by the end of June. Tonia will follow up those who aren't involved. MM asked when the GCSE books would be made available. He highlighted the issue that the books only cover 3 religions Christianity, Judaism and Islam, VT agreed that there was an issue that there are no resources for Eastern Religions. Tonia said that the whole course was being mapped out and that it has covered all religions. PL said that there will be a presentation from a lead practitioner in summer WASACRE meeting and we look forward to an update at the end of the process.

#### 8. Updates:

**Update: Curriculum Review** – BJ said that many of the schools are trying to imagine what the Donaldson Curriculum will look like. Pioneer schools are hoping that by January Step 2 will begin and they will develop

Diweddariad: Canllawiau ar Reoli'r Hawl i Dynnu Disgyblion o Addysg Grefyddol. Dywedodd GV fod y ddogfen bellach yn destun ymgynghoriad gan amryw o sefydliadau, cynrychiolwyr ffydd ac addysgwyr. Mae hi wrth ei bodd â'r gefnogaeth a'r ymateb cadarnhaol i'r ddogfen. Cynhyrchwyd y ddogfen i ddechrau mewn ymateb i gais am ganllawiau yn y maes hwn gan bennaeth, ond mae'r ddogfen wedi esblygu ac mae bellach ar gyfer rhieni, athrawon a phawb sydd â diddordeb. Rhannodd GV y ddogfen gyda chydweithwyr

models for their Areas of Learning and Experience across Wales. BJ informed WASACRE that Phil Lord, Libby Jones and Gill Vaisey had represented WASACRE at regular Stakeholders' meetings with Welsh Government to discuss the new curriculum. There is also a meeting to be held with officers of the Welsh Government on 14<sup>th</sup> December. The role of WASACRE in the curriculum review process will be discussed.

A member highlighted a concern about the slow progress in the development of the new curriculum and said that Welsh Government has not given any suggestion of what the curriculum will look like. It was brought to the attention of WASACRE that some schools are under impression they don't have to follow the Agreed Syllabus. BJ also raised the issue of lack of time for teacher training on what good RE is. This is especially important to non-specialists. BJ suggested that we need to scrutinise the contribution of the pioneer schools and would welcome having an input into that. NAPfRE are preparing a document entitled "What is Good RE" to share with schools and are meeting before the end of term to finish this. Members of WASACRE are informed of the progress of the new curriculum and regularly feed back to members.

WASACRE have a meeting with The Minister for Education on 2<sup>nd</sup> March 2017 and will pose a question around the status of the Agreed Syllabus.

WASACRE have had correspondence from Carmarthenshire SACRE raising concerns about what RE will look like in the new curriculum and what the role of SACRE will be.

A member spoke about the concerns of the Presbyterian Church about the uncertainty of what is happening. They have sent a letter to Carmarthenshire SACRE and WASACRE as well as to Kirsty Williams because they are concerned about how Christianity will be taught in the new curriculum. RT suggested that Church Schools might find it difficult to become part of this curriculum and that the Church in Wales and the Roman Catholic Church should use its links to the Welsh Government to discuss this.

PL asked how RE would work if it is based in the humanities curriculum and suggested that it is important to keep a watching brief on that.

Update: Guidance on Managing the Right of Withdrawal from Religious Education. GV said that the document is now out for consultation with a variety of organisations, faith representatives and educationalists. She is delighted with the support and positive tone in which the document is being received. The document was initially produced in response to a request for guidance in this area from a headteacher, but the document has evolved and is now for parents, teachers and all parties. GV shared the document with

#### **Update on REC**

GV said that Rudi Lockhart, CEO of REC, has been actively talking to MPs to ensure they understand what RE is. REC reps attended Party Political Conferences for the Labour and Conservative Parties to raise the profile of RE and to build good relationships with MPs. It was suggested that local SACREs should be informing their local politicians about standards achieved in GCSE locally as this is something they will care about.

REQM have a new manager, Linda Rudge.

There is a minimum subscription for REC of £250 but the average being given is £370.

There was a presentation on new resources at the conference.

- 1. Understanding Christianity Project: The National Society aim to raise standards in the teaching of Christianity following a survey which highlighted inadequacies. A resource and two day training package has been created for teachers who will be provided the pack of resources at the end of the course. They are training people to deliver the courses and GV will be attending.
- 2. Understanding Humanism: The Humanist Association has created a website with excellent resources for moral and social education as well as RE. They are hoping to translate all resources into Welsh.
- 3. The Board of Deputies of British Jews has produced a book to support Judaism GCSE Religious Studies: The Definitive Resource by Clive Lawton to help teachers with the quality of education on Judaism.

**Update: EFTRE** – PL attended the conference in August. The conference discussed what RE looks like across Europe and most countries take a confessional approach. There was discussion about how students are seen as commodities for economic growth with documentation from systems across Europe showing a move away from wellbeing and holistic and spiritual approaches.

PL will attend the Exec meeting of EFTRE next week in Finland.

**Update: Welsh Government contact meeting -** WASACRE are keeping in contact with WG via regular meetings. The next meeting is in December. Discussions have included 10/94 and the Agreed Syllabus. There has also been discussion on the Welsh Bacc and the new

A Level resources for the new curriculum -MP raised the issue of this need, suggesting that we might seek funding for lead teachers to create resources to share in the same way lead practitioners are working on resources for GCSE. She suggested WASACRE and/or the REMW might consider funding this work. TT suggested that the WJEC have a role to play in this. He said that there are textbooks available written by chief examiners. The WJEC is a benefactor and they need to benefit from it and could perhaps act as a coordinator. BJ said that there are new GCSE and A level and groups working together voluntarily. She would be interested in other groups working together in a more formal sense providing a network of sharing good practice who are able to produce resources which is fully endorsed by WJEC. Someone would need to manage this. PL asked who their employer would be. A member suggested using the Hwb to share resources. It was suggested that two or three teachers could coordinate it. JM discussed the financial issues and suggested that it would be difficult for WASACRE to fund this alone and would need to work with others. GV suggested asking REMW if they could also provide some funding and that we might also think about asking other organisations to help. RT said the residual balances of REMW do not match that of WASACRE but that this could be discussed in the next meeting of REMW.

TT felt strongly that as the WJEC is a profit making organisation and it is their product that they should be key players.
