1. TO APPOINT A CHAIR AND VICE CHAIR FOR THE ENSUING YEAR

It was moved and seconded that Councillor A. Gair be appointed as Chair of the Grants to the Voluntary Sector Panel for the ensuing year and by a show of hands this was unanimously agreed.

RESOLVED that Councillor A. Gair be appointed as Chair of the Grants to the Voluntary Sector Panel for the ensuing year.

It was moved and seconded that Councillor R. W. Gough be appointed as Vice Chair of the Grants to the Voluntary Sector Panel for the ensuing year and by a show of hands this was unanimously agreed.

RESOLVED that Councillor R. W. Gough be appointed as Vice Chair of the Grants to the Voluntary Sector for the ensuing year.

2. APOLOGIES

Apologies for absence had been received from Councillors M. Davies, A. Farina- Childs, D. Hardacre, A. Higgs, L. Jeremiah, Mrs A. Leonard, Mrs G. D. Oliver, D. W. R. Preece and J. E. Roberts.

3. DECLARATIONS OF INTEREST

Councillor R. Gough declared a personal interest in agenda item 5 (5.2.2 of the report), as Chair of Llanbradach Community Centre Management Committee.

Councillor C. Andrews declared a personal interest in agenda item 5 (5.1.8 of the report), as Valley Daffodils is one of the Mayor's charities and her friend volunteers for them.

It was noted that these items had been approved by the Head of Financial Services & S151 Officer under delegated powers and were reported to the Panel for information only.

4. MINUTES – 24TH MARCH 2021

RESOLVED that the minutes of the Grants to the Voluntary Sector Panel held on 24th March 2021 (minute nos. 1 – 4) were received and approved as a correct record.

5. APPLICATIONS FOR FINANCIAL ASSISTANCE

The report provided the Grants to the Voluntary Sector Panel with details of the applications for financial assistance received between 1st January 2021 and 31st March 2021 relating to the 2020/21 financial year and applications for financial assistance received between 1st April 2021 and 31st May 2021 relating to the 2021/22 financial year. The Panel was also asked to consider two applications from individuals in relation to the Welsh Church Acts Fund.

Members were advised of the budget allocations for both the Voluntary Sector budget and the Welsh Church Acts Fund budget and provided with details of applications received and approved by the Head of Financial Services & S151 Officer under delegated powers between 1st January and 31st May 2021.

A Member enquired as to whether the grant allocation could be increased for the first Grants to the Voluntary Sector Panel held in the next financial year due to the consequences of Covid-19 in the current financial year. The Head of Financial Services & S151 Officer informed the Panel that a service review is being undertaken in relation to all grants across the Council, however it was agreed that the situation will be monitored over the next six months and it may need to be considered outside of the review.

A Member raised concerns regarding the projected level of Discretionary Rate Relief payments for 2021/22. The Head of Financial Services & S151 Officer informed Members that the Discretionary Rate Relief Policy was amended a few years ago and some larger organisations no longer qualify or can only access a proportion of the funding. Members were advised that, moving forward the Head of Financial Services & S151 Officer may consider separating the Discretionary Rate Relief budget so that there would be a definitive budget every year for grants to organisations. However, this would be part of the wider service review and appropriate recommendations would be made in due course.

The Grants to the Voluntary Sector Panel noted the applications received that met the criteria for Financial Assistance and the Welsh Church Acts Fund, which have already been approved by the Head of Financial Services & S151 Officer under delegated powers, and which are reported to the Panel for information.

PUBLIC INTEREST TESTS

Members considered the public interest test certificate, in relation to Appendix 2 of the application for financial assistance, from the Proper Officer and concluded that on balance the public interest in maintaining the exemption outweighed the public interest in disclosing the

information. By a show of hands this was unanimously agreed.

Members considered the public interest test certificate, in relation to Appendix 3 of the application for financial assistance, from the Proper Officer and concluded that on balance the public interest in maintaining the exemption outweighed the public interest in disclosing the information. By a show of hands this was unanimously agreed.

RESOLVED that in accordance with Section 100A(4) of the Local Government Act 1972 the public be excluded from the remainder of the meeting because of the likely disclosure to them of exempt information as identified in paragraphs 12 and 14 of Schedule 12A of the Local Government Act 1972.

EXEMPT MATTER

Members of the Panel were asked to make a recommendation for approval or otherwise in relation to requests for funding from two individuals under the Welsh Church Acts Fund. This recommendation will then be considered and approved by the Head of Financial Services & S151 Officer under delegated powers.

Following consideration and discussion, it was moved and seconded that the recommendation in the Officers report be approved. By way of electronic voting, this was unanimously agreed.

1. PURPOSE OF REPORT

- 1.1 To inform the Panel of the applications for Financial Assistance received between 1st June and 30th September 2021.
- 1.2 To seek Panel views on one application for Financial Assistance that does not meet the general criteria.
- 1.3 To inform the Panel of the applications for Welsh Church Acts Fund received between 1st June and 30th September 2021.
- 1.4 To inform Panel members of funding withdrawn from two previously approved Welsh Church Acts Fund projects and the reasons for this course of action.
- 1.5 To seek Panel views on one application from an individual in relation to the Welsh Church Acts Fund.

2. SUMMARY

- 2.1 The report advises Panel members of the budget allocations for both the Voluntary Sector budget and the Welsh Church Acts Fund budget. It provides details of applications received and approved by the Head of Financial Services & S151 Officer under delegated powers between 1st June and 30th September 2021. It also provides details of funding withdrawn from two previously approved projects under the Welsh Church Acts Fund and the reasons for this. Finally, it seeks Panel views in relation to one application for Financial Assistance that does not meet the general criteria, and one application received from an individual under the Welsh Church Acts Fund, with the purpose of making a recommendation to the Head of Financial Services & S151 Officer for approval or otherwise.

3. RECOMMENDATIONS

- 3.1 Panel members note the applications received that meet the criteria for Financial Assistance and the Welsh Church Acts Fund, which have already been approved by the Head of Financial Services & S151 Officer under delegated powers, and which are reported to the Panel for information.
- 3.2 Panel members make recommendations for approval or otherwise in relation to one application for Financial Assistance that does not meet the general criteria, and one application from an individual under the Welsh Church Acts Fund. This recommendation will then be considered and approved or otherwise by the Head of Financial Services & S151 Officer under delegated powers.

4. REASONS FOR THE RECOMMENDATIONS

- 4.1 To ensure that the applications received under this report are determined in accordance with the Council's scheme of delegation criteria.

5. THE REPORT

5.1 GRANTS TO THE VOLUNTARY SECTOR BUDGET

- 5.1.1 The Grants to the Voluntary Sector budget for 2021/22 is shown in the table below:

- 5.1.2 The projected Discretionary Rate Relief for 2021/22 is **£194,757.97**, which is £6,597.97 over the budget available for 2021/22. Allowing for the projected spend on Discretionary Rate Relief, the available balance for schemes is £130,608.23, which includes carry forward balances. Spend of £900 in 2021/22 was reported at the last Panel meeting, leaving a balance of **£129,708.23**.
- 5.1.3 Between 1st June and 30th September 2021, seven new General Criteria awards have been made totalling **£890**. These have been approved by the Head of Financial Services & S151 Officer under delegated powers and are reported to the Panel for information only. The awards are summarised in the table overleaf.

5.1.4 In the period between 1st June and 30th September 2021, one application has been received that is outside the general criteria as set out in Appendix 1. The application is attached at Appendix 2, and Panel Members are requested to make a recommendation as to whether this application should be supported, and if so the amount of funding to be awarded. This recommendation will then be considered by the Head of Financial Services & S151 Officer and approved or otherwise under delegated powers.

5.1.5 After the awards detailed in the table above have been considered, the amount remaining in the current financial year is **£128,818.23**, less any award recommended under 5.1.4.

5.1.6 As previously agreed by the Panel, grants awarded during the 2021/22 financial year that exceed the budget allocation will be funded from the brought forward balances.

5.2 WELSH CHURCH ACTS FUND

5.2.1 The total Welsh Church Acts Fund budget available for 2021/22 is **£146,248.14**. This consists of the annual allocation from Monmouthshire County Council (**£63,840**) and unallocated sums from previous years (**£82,408.14**).

5.2.2 Between 1st June and 30th September 2021, two applications have been received totalling **£9,743.44**. These have been approved by the Head of Financial Services & S151 Officer under delegated powers and are reported to the Panel for information only. The awards are summarised in the table below:

5.2.3 Since the last Panel meeting a total of £10,000 has been withdrawn from two previously approved projects for the reasons given below, and this funding has been recycled back into the pot to be used for other projects:

- a. ORG19/WCF015 Pontlottyn Allotment Association – grant was not spent within the 18-month timeframe (£5,000 grant awarded)
- b. ORG20/WCF008 Agape Community Church, Ty Sign – Cabinet decided not to grant the organisation a lease for the land to build the new centre, so project unable to proceed (£5,000 grant awarded)

5.2.4 Since the last Panel meeting one application has been received from an individual in relation to the Welsh Church Acts Fund. A copy of this application is attached at Appendix 3, and it is recommended that these are treated as exempt from publication and Panel members consider excluding the press and public when discussing Appendix 3 during the meeting. Panel members are asked to consider the application and make a recommendation as to whether to support the applicant and if so, the level of grant to be awarded. The recommendation will then be considered and approved as appropriate by the Head of Financial Services & S151 Officer under delegated powers.

5.2.5 Taking into account the £10,000 recycled back into the funding pot since the last Panel meeting and the new awards made, and if the grants awarded in previous years but not yet drawn down spend to the maximum amounts allocated, there will be a balance of **£130,619.70** remaining, less any award in relation to 5.2.4 above.

5.3 **Conclusion**

The report summarises all allocations made under the Grants to the Voluntary Sector and Welsh Church Acts Fund budgets between 1st June and 30th September 2021. It also asks Panel members to make recommendations in relation to one Financial Assistance application not meeting the general criteria, and one application received from an individual in relation to the Welsh Church Acts Fund.

6. **ASSUMPTIONS**

6.1 There are no assumptions as the 2021/22 budget has been confirmed, together with carried forward underspends from previous years.

Main objectives of the organisation:

Llamau's mission is to end youth homelessness and homelessness amongst women in Wales. We work with some of the most vulnerable and disenfranchised groups in our community, who face complex barriers to independence; including those with experiences of care, domestic abuse and childhood trauma - shown to significantly increase the risk of health-harming behaviours in adulthood.

Our work aims to prevent homelessness from happening in the first place, provides safe accommodation for those experiencing homelessness and, crucially, supports people to develop the skills and confidence to leave homelessness behind for good.

Examples of our services include:

- Prevention: for example; information and advice services, Youth Homelessness Helpline, Family Mediation and other early intervention support;
- Housing-related support: for example; domestic abuse refuges, supported accommodation for young people, supported lodgings, LGBTQ+, Gender and Care Leaver specific supported accommodation
- 'Move on' services: for example; Learning, Training and Employment programmes and outreach services for those living within the community

In Caerphilly specifically, Llamau supports almost 50 young people with experiences of homelessness at any one time, through our five 24 hour supported accommodation projects and our Housing First, Support Lodgings and Floating Support schemes.

Purpose for which grant is sought?

Research shows that the physical health and wellbeing of those who have experienced homelessness are poorer than that of the general population. They often face significant health inequalities and barriers to accessing health services and support. Furthermore, Llamau/Cardiff University's research found that young homeless people are more likely to experience poor mental health than their peers. Nine out of ten young homeless people met the criteria for at least one psychiatric disorder, compared to one in three 16-24 year olds in the general population. Almost three quarters (73%) met criteria for two or more psychiatric disorders, which compares to only 12.4% of the general population. Young people supported by Llamau are also more likely to have experienced Adverse Childhood Experiences (ACEs) including maltreatment or trauma; emotional abuse; parental drug/alcohol abuse; and/or parental incarceration. To compound these challenges, young people have been placed firmly in the firing line of the Covid-19 crisis. A survey by our in-house Psychologists into the specific impact of Covid-19 on the well-being of the people Llamau support highlighted that mental health had worsened by nearly a third (32%) across the organisation.

With your support, Llamau will address the specific barriers and stigmas to taking part in sports that homeless young people have told us they face – cost, fear of looking stupid, worries about their appearance and being around unfamiliar people. We will improve young peoples' access to activity through the purchase of sports/fitness equipment.

Young people living in our 24 hour supported accommodation projects in Caerphilly have told us that during periods of lockdown they became frustrated that the pandemic was keeping them indoors and inactive. They would like to purchase sports equipment that they can use at home and in the local community with their peers and Support Workers. These will include games sets for playing team games together, yoga mats and weights and the young people would love a multigame table.

The aim of the project is to improve the health and wellbeing of young people with experiences of homelessness in Caerphilly. The capital items we purchase will enable young people to experience:

- Increased motivation to engage in physical activity and improved access to sports equipment and sessions, at home and in the community
