Option 2 be approved – Asylum Dispersal begin with a smaller number (5) family properties and evaluate the success after 12 months.</li> <li>2. Relocation of Afghan Nationals – request to be revisited within a few months to enable new systems and internal policies for asylum dispersal to be put in place and to reduce additional pressure on private sector housing supply.</li> <li>3. Cabinet to be advised of the situation for Afghan national relocation over the summer months and support be extended if the capacity of services and available housing supply can absorb this scheme. Any agreement to participate would not be the subject of public reports.</li> </ol>	Unanimously
