They wished them every success in their new role.

#### 4. RETIRING MAYORS REMARKS

The retiring Mayor, Councillor L. Gardiner, spoke of his numerous and varied activities during his year of Office and referred to the number of events he has attended. He was pleased to announce that £17,200 had been raised for his charities, Ty Hafan Children's Hospice and Macmillan Nurses.

He expressed his appreciation at the assistance given to him by Members and Officers, particularly those whose duties brought them into regular contact with him.

Members paid tribute to the way in which both he and his consort, Alma, and the Deputy Mayor, Councillor Mrs D. Price, had carried out their duties during the term of Office.

#### 12. LEADER OF THE MAIN OPPOSITION GROUP - COUNCILLOR C.P. MANN

It was noted that Councillor C.P. Mann will receive a senior salary payment as Leader of the main opposition Group.

#### 13. LEADERS STATEMENT

Councillor K.V. Reynolds provided Members with an overview of some of the achievements and events over the last twelve months, an update on some of the investments and outlined projects planned over the coming months. He paid tribute to the role undertaken by both Members and Officers over the past year and thanked them for their hard work and dedication.

He referred to the financial situation that has been faced over the past year and to the difficult decisions that had been taken. The savings required had been achieved, with over 80% being from efficiencies in administration and less than 20% from proposals which affected front line services. He expressed his appreciation to those members of the public who took part in the extensive budget consultation, which was extremely helpful in reaching the final budget.

In view of the fact that the austerity programme will continue there will be several more years of very difficult budgets. In that it is expect that over £25m more savings will be required over the next four years, he advised that it is essential to continue to look for ways to be more efficient in order to safeguard essential services. It is intended that Members will be invited to take part in early discussions in preparation for next year's budget and a three year financial plan.

With regards to education, Councillor Reynolds advised that as part of the 21st Century School buildings programme, November saw the official opening of the £20m development at Y Gwindy, which is a unique combination of refurbishment and new build for a modernised Welsh Medium Primary and Secondary School. Work also started on the new Islwyn High School at Oakdale which will provide a much-improved replacement for Oakdale and Pontllanfraith Comprehensive Schools and tendering for works for a new primary school in Rhymney to replace the Pontlottyn and Abertysswg Primary Schools has commenced. It was noted that the contractors for these major school projects are also contributing considerable wider community benefits through local chain partners and including the employment of local

people through full time employment, apprentice opportunities, work experience places and management trainee places.

There is also a continuing commitment to invest in education and in March, it was agreed to invest more than £4m over the next 3 years on school improvements across a large number of schools, as part of the Education Capital Programme. There is also a commitment to raising standards and Officers continue to work with schools to achieve this.

Investment in the Housing Stock to meet the Welsh Housing Quality Standard by 2020 continued in 2015/16 with £25m spent on the programme with over 1500 homes benefitting. Work is also progressing on environmental projects as part of the programme. Outside the WHQS investment, the day-to-day repairs service has been modernised using the latest mobile technology, the Anti-Poverty Strategy launched and support staff continue to assist where required. A special project at Lansbury Park dedicated to employment, health, education, family support, housing and environmental projects in the area is being taken forward.

Councillor Reynolds advised that job creation and regeneration remains a high priority and made reference to the £1.2b City Deal for this area and the development of a new Metro public transport system for the region. Workshops for Members to discuss the emerging plans for this City Deal will be arranged in the near future.

Over the past year local business have been supported, with assistance provided for 25 new business start-ups and grant aid provided to support the creation of 81 new jobs and safeguard 334 existing jobs. Works have started on the construction of a major new factory on the Oakdale Business Park. Local Town Centres continued to receive investment with works completed in Newbridge and Bargoed. Improvements were completed at Llancaiach Fawr which hosted a very successful Urdd Eisteddfod last year and this year, the South Wales Armed Forces Day event will come to Caerphilly at the end of June.

With regards to social services, the positive feedback from the Care and Social Services Inspectorate Wales (CSSIW) as part of its annual performance evaluation review reinforces the commitment to providing quality Social Services to all sections of the community. This year an additional £2.5m has been allocated for those services. Cabinet recently agreed to invest in a new therapeutic service and March saw the delivery of 4 new mini buses for the transportation of vulnerable clients on behalf of Social Services. Caerphilly was designated as a 'dementia friendly community' and the Winding House Museum became Wales' first 'dementia friendly museum'.

With regards to the Future Generations and Wellbeing Act, Councillor Reynolds advised that it is intended to establish a cross-party Future Generations Advisory Panel to steer and guide the work over the next two years and thereafter through planning delivery and into the next cycle of the statutory requirements.

With regards to recycling, all indications show that we are on course to hit our 58% recycling target. In relation to other services, Leisure Services welcomed 1.4m customer visits, Library Services 218,000 visitors (loaning over 134,000 items) and 35,260 visitors took advantage of free computer sessions. In addition, the new Centre for Sporting Excellence in Ystrad Mynach has hosted 20 international and 28 representative matches during the first year of its operation. Partnerships have been secured with Gwent Dragons and the Welsh Football Association. The Welsh Ladies Senior Team and Cardiff City Ladies Team are now using the centre and we are working closely with Coleg-y-Cymoedd, and the Welsh Football Association supporting the Women's Youth Team in scholarships with the College.

£1.2m of funding was secured for a series of transport and road projects across the borough which provided safer routes in the community, road safety initiatives, traffic calming schemes and public transport improvements.

Reference was then made to the progress on the governance action plan and most recently to the review of the scrutiny processes, whereby Scrutiny Committees will be able to advise and influence Cabinet before key policy decisions are made.

Councillor Reynolds was pleased to announce that despite continued austerity measures, customer satisfaction remained high. In response to the biennial household survey, 78% of residents stated that they were either satisfied or very satisfied with the services provided. He also reminded Members that Caerphilly was one of the first Welsh authorities to respond to the Syrian refugee crisis, taking in two young families who were fleeing the Syrian war zone.

In closing Councillor Reynolds advised that he had only mentioned some of the services provided and as such he could not accurately reflect the work of over 9000 staff operating across 600 different service areas. He apologised to those areas that he had not specifically mentioned.

#### REPORTS OF OFFICER

Consideration was given to the following report.

#### 14. CONSTITUTIONAL MATTERS

Consideration was given to the report which outlined matters that require consideration in accordance with the Council Procedure Rules and provided an update on changes and amendments to legislation affecting the Council's Constitution. Members were also asked to note and adopt the amended Code of Conduct for Members as set out in Appendix 1 to the report and to delegate authority to the Interim Head of Legal Services and Monitoring Officer to make the necessary changes to the Council's Constitution to give effect to the changes referred to in the Report.

Members were advised that the Council's Procedure Rules require the Annual Meeting to appoint at least one Overview and Scrutiny Committee, a Standards Committee and such other Committees the Council considers appropriate to deal with the matters which are neither reserved to the Council nor are executive functions. In noting the provision for the appointment to a number of Committees as detailed in the report, it was not proposed that any changes be made to the current committee structure.

The Interim Head of Legal Services and Monitoring Officer then detailed the proposed changes to the terms of reference for the Policy and Resources Committee, the Democratic Services Committee and the Standards Committee as set out in the report (there being no other changes proposed to the existing terms of reference for the remainder of the Committees set out in Part 2 of the Constitution).

With regards to the Policy and Resources Scrutiny Committee, and in accordance with the requirements of the Well Being of Future Generations (Wales) Act 2015 (which requires the Council to designate a Scrutiny Committee to scrutinise the work of the Public Service Board), it is proposed that this role is undertaken by the Policy and Resources Committee when sitting as the Crime and Disorder Scrutiny Committee. In that it is seen that there is also an important role for a cross-party group of Elected Members it is recommended that the Sustainable Development Advisory Panel be formally re-established as a cross-party Future Generations Advisory Panel to steer and guide the work over the next two years and thereafter through planning delivery and into the next cycle of the statutory requirements. It is proposed that the new Panel be chaired by the Cabinet Member for Regeneration Planning and Sustainable Development and that the Cabinet Member be also designated as "Future Generations Champion".

Reference was then made to the establishment of a Cross-Party Working Group to review the Council's Constitution with a view to implementing the All Wales Model Framework Constitution, which was a framework document prepared by lawyers in conjunction with the Welsh Local Government Association (WLGA) and the Local Government Lawyers Group (LLG). Due to various difficulties with the IT software package, it has not been possible to Implement the framework across Wales and as such, it is proposed that the working party be disbanded and that the Interim Head of Legal Services and Monitoring Officer provide six monthly updates to the Democratic Services Committee on the Council's Constitution.

In relation to the Standards Committee, and as a result of Regulations that have amended Statutory Instruments, it is proposed that changes to the Standards Committees (Wales) Regulations 2001, the Local Government Investigations (Functions of Monitoring Officers and Standards Committee) (Wales) Regulations 2001 and Local Authorities (Grant of Dispensations) (Wales) Regulations 2001 be reflected in the constitution and the existing terms of reference of the Standards Committee be amended accordingly.

Reference was then made to the Local Authorities (Model Code of Conduct) (Wales) (Amendment) Order 2016. The Order (which came into force on 1st April 2016) amends the Model Code of Conduct for Local Government Members set out in the Local Authorities (Model Code of Conduct) (Wales) Order 2008, details of which were outlined in the report. Particular reference was made to the transfer of responsibility for maintaining the register of interests of Members of community/town councils from the Monitoring Officer of the principal Local Authority to the "Proper Officer" of each community/town council, with effect from 1st May 2016, Reference was also made to Paragraph 15 of the Model Code, which clarifies that any interest disclosed for the first time must be entered in the register, to the omission of paragraph 6(1)(c), the removal of paragraph 10(2)(b) and minor changes in accordance with the Co-Operative and Community Benefit Societies and Credit Unions Act 2010 (Consequential Amendments) Regulation 2014.

Members were advised that the Council is required to consider the amendments and adopt the Model Code within six months of the date on which the Order was made. As the Order was made on 27th January 2016, a revised Code must be adopted by 26th July 2016. Members noted the current Code of Conduct appended to the report with the amendments made under the Order track changed in bold italics.

It was noted that there is a requirement to decide the allocation of seats to political groups in accordance with the Political Balance Rules contained in the Local Government and Housing Act 1989 and the Local Government (Committees and Political Groups) Regulations 1990 as amended. In that there has been no change to the political balance of the Authority the current allocations will remain as present.

It was moved and seconded that the recommendations in the report be approved. By show of hands this was unanimously agreed.
