### **1. DECLARATIONS OF INTEREST**

### **2. MINUTES**

RESOLVED that the minutes of the Cabinet meeting held on 17th April 2012 (minute nos. 754-762; page nos. 371-374) be approved and signed as a correct record.

**MATTERS ON WHICH EXECUTIVE DECISIONS WERE REQUIRED**

**4. YSBYTY YSTRAD FAWR HIGHWAY IMPROVEMENTS COMPULSORY PURCHASE ORDER 2011**

The report sought approval to confirm a Compulsory Purchase Order (CPO) for the land required to implement Phase 2 and Phase 4 of the Ysbyty Ystrad Fawr Highway Improvements Project.

The extent of the land that is included within the CPO and is required to implement phases 2 and 4 of the highway project is shown coloured pink and blue on Appendix B to the report.

RESOLVED that for the reasons contained in the officer's report, the Caerphilly County Borough Council (Ysbyty Ystrad Fawr Highway Improvements, Route A472 Classified Road) Compulsory Purchase Order 2011, be confirmed and notices thereof be duly given and published.

**5. MAINTENANCE OF COMMUNITY ASSETS FUNDING 2012/2013**

Approval was sought for the allocation of funding from the Maintenance of Community Assets Budget for 2012/2013. The £400,000 budget, which the Authority receives from Welsh Government by way of a deprivation grant, has in previous years been allocated to a number of different community orientated projects.

The proposed allocation of this budget results from an internal bidding round from relevant functional areas of service. The key proposals are set out in paragraph 4.7 of the report.

RESOLVED that for the reasons contained in the officer's report, the suggested allocation of funds referred to within the report, be approved.

**6. DETERMINATION OF CATCHMENT AREA FOR WOODLAND TERRACE, NEW TREDEGAR**

Councillor G. Jones declared an interest in this item as a school governor of White Rose Primary School and Phillipstown Primary School.

A formal request had been received from the local ward members that Woodland Terrace, New Tredegar be moved into the catchment area of White Rose Primary School. The report summarises the results of the consultation process recently completed in respect of this proposal, to which there had been no objection.

RESOLVED that for the reasons contained in the officer's report, Woodland Terrace, New Tredegar be moved into the catchment area of White Rose Primary School with effect from 1st September 2013.
