1. PURPOSE OF REPORT

1.1 To determine Caerphilly County Borough Council's dates for the academic years 2013/14, 2014/15 and 2015/16.

2. SUMMARY

2.1 The School Term and Holiday dates for the Academic years 2013 to 2016 proposed have been established to try and ensure that there are common dates across Wales. 16 of the 21 other Welsh Authorities have adopted the same dates. The other 5 Authority dates are not yet known.

- 4.1 Cabinet, at its meeting in July 2011, agreed school term and holiday dates for the 2012-2013 academic year.
- 4.2 The proposed dates for 2013-2016 have recently been circulated with an 8 day response period given.
- 4.3 It is recommended to adopt the dates for 2013/2016 as outlined in the attached Appendix. 16 of the 21 other Welsh Authorities have already adopted the proposed dates, this included 4 of the 5 Central South Consortium and 2 of the other 4 South East Consortium.
