## 49. MINUTES - 4TH AND 11TH SEPTEMBER 2012

RESOLVED that subject to it being noted that minute no. 37 (dated 4th September 2012) in relation to the former Nelson Boys and Girls Club should reflect that it had also been agreed that the site would be leased to Nelson Development Trust rent free for the first two years, the minutes of the Cabinet meetings held on 4th September (minute nos. 34 - 41; page nos. 16 - 19) and 11th September 2012 (minute nos. 42 - 47; page nos. 20 - 22) be approved and signed as correct records.

## 51. MARKHAM COLLIERY (WEST OF RIVER SIRHOWY) PROPOSED PURCHASE - REVISION TO ACQUIRING PROVISION

Consideration was given to the report which sought to amend the legislation under which the compulsory acquisition of land is progressed from that previously agreed by Cabinet. Members were advised that at its meeting on 8th March 2011 Cabinet had agreed to compulsory purchase land at the former Markham Colliery under the provisions of the Planning and Compulsory Purchase Act 2004. The report sought authorisation to compulsory acquire the same area under provisions contained in the Countryside Act 1968.

RESOLVED that for the reasons contained in the Officer's report:-

- (i) in pursuance of the powers contained in Section 7 (4) of the Countryside Act 1968 and all other enabling powers, a Compulsory Purchase Order of the land described in the report and identified on the plan displayed at the meeting to be known as the Caerphilly County Borough Council (Former Markham Colliery, West of River Sirhowy, Markham Redevelopment) Compulsory Purchase Order 2012 be made and sealed by the Council. Notice thereof be duly given and published and the same be submitted to the National Assembly for Wales for confirmation;
- (ii) notwithstanding the above decision, and pending the making of the Compulsory Purchase Order, Officers be authorised to seek to acquire the land by agreement with the interested parties.

# 52. PART ONE OF THE MENTAL HEALTH MEASURE: THE PROVISION OF PRIMARY MENTAL HEALTH SERVICES

Consideration was given to the report which sought Local Government and Health Board ratification of the Mental Health (Wales) Measure part one scheme in advance of the required submission date to Welsh Government of 1st October 2012. The Health Social Care and Wellbeing Scrutiny Committee considered the report on 11th September 2012 and endorsed the scheme for submission to Welsh Government prior to its consideration by Cabinet.
