Dafydd Treharne, Vale of Glamorgan

I have an honours degree in Welsh and in Religious Studies and a MEd in Pastoral care.

I worked for the BBC from 1963-66 as a studio manager with attachment to Religious broadcasts taking part in radio programmes as such Y Ddolen and introducing such TV programmes as Dechrau Canu.

I was appointed head of RE and Humanities at Stanwell Comprehensive Penarth and in 1974 became a specialist adviser for RE in South Glamorgan and later added responsibility for Welsh medium Education and Pastoral Care and Guidance to my role in 1979.

During this time I serviced and chaired SACRE South Glamorgan and was a Welsh representative on the England Wales association of RE advisers and chair of NAPfRE .As soon as I was appointed to South Glamorgan we produced a new agreed syllabus.

I retired from my advisory work in 1996 but since then I have regularly inspected under contract for Ofsted (in the 90s only) and for Estyn covering in the main, Welsh, RE, Special Needs and Guidance in primary, secondary and special schools.

This inspection commitment will end soon with the introduction of a new inspection system due in Sept 2010

Ever since my retirement I have been chairman of a Welsh medium primary school in the Vale, have served on SACRE and also as treasurer of the Vale Governors Association and I still serve as the Welsh medium schools representative on the county's Education Funding (Budget) Committee and the Equalities Forum.

Mi weithiais i'r BBC rhwng 1963-66 fel rheolwr stiwdio yn gysylltiedig â darlledu Crefyddol mewn rhaglenni fel Y Ddolen a chyflwyno rhaglenni teledu fel Dechrau Canu.

Mi gefais fy mhenodi'n bennaeth AG a'r Celfyddydau yn Ysgol Gyfun Stanwell Penarth ac yn 1974 dod yn ymgynghorydd arbenigol AG yn Ne Morgannwg ac yn ddiweddarach ychwanegu cyfrifoldeb dros Addysg cyfrwng Cymraeg a Gofal Bugeiliol a Chyfarwyddyd i'm rôl yn 1979.

Yn ystod yr amser yma mi wnes wasanaethu a chadeirio SACRE De Morgannwg ac yn gynrychiolydd Cymraeg ar gymdeithas ymgynghorwyr Lloegr Cymru a chadeirydd NAPfRE. Cyn gynted ag y cefais fy mhenodi i Dde Morgannwg mi gyflwynom ni faes llafur newydd cytûn.

Mi ymddeolais o'm gwaith ymgynghorol yn 1966 ond ers hynny rwyf wedi arolygu'n gyson o dan cytundeb i Ofsted (yn y 90au'n unig) ac i Estyn gan gynnwys yn bennaf Cymraeg, AG, Anghenion Arbennig a Chyfarwyddyd mewn ysgolion cynradd, uwchradd ac arbennig.

Fe ddaw'r ymrwymiad arolygaeth i ben yn fuan gyda chychwyn trefn arolygaeth newydd i fod ym Medi 2010.

Ers f'ymddeoliad rwyf wedi bod yn Gadeirydd ysgol cyfrwng Cymraeg yn y Fro, wedi gwasanaethu ar SACRE ac hefyd yn drysorydd Cymdeithas Llywodraethwyr y Fro ac rwy'n dal i fod yn gynrychiolydd ysgolion cyfrwng Cymraeg ar bwyllgor (Cyllideb) cronfa Addysg y sir a'r Fforwm Cydraddoldeb.
