# THE ANNUAL REPORT OF CAERPHILLY STANDING ADVISORY COUNCIL FOR RELIGIOUS EDUCATION

2010- 2011

## SECTION 1: INFORMATION ABOUT SACRE

### 1.1 DUTY TO ESTABLISH SACRE

All Local Education Authorities (Local Authorities) are required to constitute Standing Advisory Council for Religious Education (SACRE) within their local area.

### 1.2 COMPOSITION OF SACRE

Representation on SACRE is required as follows:-

- Such Christian and other religious denominations as, in the opinion of the local authority, will appropriately reflect the principal religious traditions in the area
- Associations representing teachers
- The Local Education Authority

The Local Authority determined that the SACRE should comprise of six elected members, five representatives of religious bodies and six representatives of teachers' associations. In addition, the Authority allowed for two other individuals to be co-opted.

### 1.3 MEMBERSHIP OF SACRE

The list of members of Caerphilly SACRE is set out in Appendix 1. Every effort has been made to seek representation from non-Christian communities.

### 1.4 FUNCTIONS OF SACRE

- To advise the local authority on worship and the religious education to be given in accordance with the agreed syllabus including methods of teaching, advice on materials and the provision of training for teachers
- To consider whether to recommend to the local authority that its current agreed syllabus should be reviewed by convening an Agreed Syllabus Conference.
- To consider whether the requirement that religious worship in a county school should be 'broadly Christian in nature' should be varied (determinations)
- To report to the local authority and the Department for Children, Education, Lifelong Learning and Skills (DCELLS) on its activities on an annual basis.

### 1.5 MEETINGS

SACRE met on four occasions during the academic year 2010-11.

Wednesday September 29<sup>th</sup> 2010  
Monday December 6<sup>th</sup> 2010  
Monday February 14<sup>th</sup> 2011  
Tuesday June 14<sup>th</sup> 2011

SACRE has resolved that, where possible, meetings will be held at alternative venues such as schools or places of worship. During the academic year 2010- 2011 members visited two schools and two churches.

## **1.6 DEVELOPMENT PLAN**

SACRE adopted a development plan as a basis for its activities for the period 2010 - 2013. A year on year progress report is included in the plan. The plan can be found in Appendix 3.

## **EXECUTIVE SUMMARY**

Summary of the advice given to the local authority by SACRE

### **RELIGIOUS EDUCATION**

#### **Issue**

To monitor provision and standards in RE

#### **Action**

1. The local authority through its SACRE writes to schools to congratulate those that have good or very good standards in RE in their inspection report. This year letters were sent to 2 primary schools. With the lack of specific reference to subjects, including RE under the new Common Inspection Framework SACRE resolved at its Summer meeting to use school self evaluation as a means of fulfilling its statutory responsibility to monitor provision and standards in RE. SACRE to receive an overview of findings on an annual basis.
2. SACRE requests the action plan of those schools that have grade 3 or below in RE. No action plans were requested this year.
3. Primary and secondary schools receive a full programme of INSET to address issues of concern to RE and to support the raising of standards in RE.
4. SACRE writes to Estyn to highlight any errors in reporting procedures in inspection reports, where these occur. This was not necessary in the academic year 2010-11
5. SACRE analyses examination results over a three year period and identifies trends in performance benchmarked against All Wales data. Schools informed of the outcomes of this analysis and this year schools were congratulated on their achievements.
6. The local authority and its SACRE gather and analyses data regarding KS3 Teacher Assessment in RE. This information is shared with teachers through the distribution of the end of year SACRE Annual report and during Heads of Department meetings.

### **THE AGREED SYLLABUS FOR RE**

#### **Issue**

To fulfil the legal requirement to review the agreed syllabus for RE on a five yearly basis and ensure the agreed syllabus is being implemented in schools

#### **Action**

1. In 2008 Standing Conference endorsed and adopted a new agreed syllabus for the Authority's schools, which was implemented from September 2008. All schools received a programme of INSET in the Summer 2008 and received a comprehensive package of support materials to exemplify the new syllabus including *Schemes of Work*.
2. A programme of in-service training has been made available to schools to support teachers in their understanding of agreed syllabus requirements.
3. The local authority has circulated *Progress in Learning at KS3* files to support schools in creating their own KS3 portfolios. All secondary schools have received training over the last few years on KS3 assessment in preparation for the WJEC moderation and INSET has been offered to primary schools on assessment in RE.

## TEACHING MATERIALS

### Issue

To ensure that schools are informed of suitable resources

### Action

1. SACRE has discussed the DCELLS document *Religious Education: Guidance at KS2 and KS3* and resolved to inform schools of the availability and usefulness of this resource.
2. Materials to support schools with the implementation of the Caerphilly Agreed Syllabus for RE have been made available on the LA advisory service website. ([www.esis.org.uk](http://www.esis.org.uk))
3. All schools were informed of the 2011 theme 'Untold Stories' and that Holocaust Memorial Day resources can be found on their website [www.hmd.org.uk](http://www.hmd.org.uk) - including a CD ROM of material about listening to survivors talking about their experiences.
4. Schools have been informed of the RE Festival 2011 website and of the excellent resources available to teachers on that website [www.celebratingre.org](http://www.celebratingre.org)
5. Secondary schools have been informed of the REsilience Project and encouraged to visit the website [www.re-silience.org.uk](http://www.re-silience.org.uk). Those wishing to be part of the project will receive Gateway documents and other support materials.
6. Schools annually receive a Calendar of Religious Festivals to support planning. The *Calendar of Religious Festivals 2010 - 2011* was circulated to all schools.
7. Schools have been informed through INSET and networking meetings of the most recent resources to support the teaching of religious education.

## TRAINING FOR TEACHERS

### Issue

To ensure that teachers are able to access appropriate CPD

### Action

1. A full range of in- service training, both primary and secondary is provided through the advisory service (ESIS) and the attendance registers and evaluation of courses are reported to SACRE. (see Appendix 6)

## COLLECTIVE WORSHIP

### Issue

To ensure that schools fulfil statutory requirements for collective worship and provide a worthwhile experience for pupils.

### Action

1. SACRE monitors the sections of inspection reports that are concerned with collective worship and SMSC and writes to schools to congratulate those that fulfil statutory requirements and promotes good SMSC. SACRE resolved to send a letter to four primary schools to express their satisfaction at the comments in their reports on SMSC and collective worship.

2. SACRE resolved at its summer meeting that it would fulfil its statutory responsibilities to monitor fulfilment of statutory requirements, provision and quality of collective worship by taking advantage of the self evaluation practices currently used by headteachers and teachers and invite schools to share their self evaluation of Collective Worship with SACRE.
3. There was no necessity this year to request the action plan of any primary or secondary school for non - compliance with statutory requirements regarding collective worship.
4. Schools have been informed by SACRE of appropriate resources and websites that support collective worship in schools.
5. Guidance materials on collective worship have been made available to schools on the LA advisory service website [www.esis.org.uk](http://www.esis.org.uk). The materials include Estyn's updated (Sept 2010) *Supplementary Guidance on Inspecting Collective Worship in Non-Denominational Schools* and WASACRE's *Guidance on Collective Worship Post 16*.

## **SECTION 2                   ADVICE ON RELIGIOUS EDUCATION**

### **2.1     THE LOCALLY AGREED SYLLABUS**

In 2008 the Standing Conference endorsed and adopted a new agreed syllabus for the Authority's schools to be implemented from September 2008. The agreed syllabus closely relates to the National Exemplar Framework for RE (DCELLS). A yearly programme of INSET has continued and specific training on the agreed syllabus has been offered. Comprehensive support materials, including *Schemes of Work* and electronic *Progress in Local Learning* files for secondary schools, have already been issued to schools.

### **2.2     STANDARDS IN RE**

SACRE has adopted a number of strategies for monitoring standards being achieved in religious education in the Authority's schools that include the following.

- **School Inspection Reports /Self Evaluation**

SACRE scrutinises the relevant sections of local authority school inspection reports on a twice-yearly basis during the Autumn and Summer Term meetings. At its December meeting SACRE received reports from 5 schools inspected during the Summer term 2010. Three schools had a short or standard inspection and RE was not inspected. Standards in religious education were inspected in two schools and standards were judged to be a grade 2 (good features, no important shortcoming) in both schools.

#### **Good features**

- Pupils develop a good knowledge and understanding of Christianity and other world religions.
- Visits made to places of worship in the local community.
- Good understanding of the use and significance of religious artefacts.
- Opportunities provided for pupils to discuss and to reflect on religious and moral issues especially environmental issues.

#### **Shortcomings**

No shortcomings were identified in the reports where RE was inspected as a subject.

From Autumn 2010- Spring 2011 eight schools were inspected under the revised Common Inspection Framework consisting of one infant, one junior and six primary schools. These were considered from the point of view of comments made about collective worship and spiritual development. The new Estyn Common Inspection Framework no longer makes specific reference to subjects, including RE, and SACRE considered using school self evaluation as a means of fulfilling its statutory duty to monitor provision and standards in RE. In consultation with the local authority education directorate it was agreed at its summer meeting that a pro forma be used as a tool for monitoring using the schools self evaluation report. Discussion is still ongoing with schools as to the frequency of completion of this monitoring form for SACRE. An overview of findings to be reported to SACRE on an annual basis

SACRE resolved to continue to capitalise on the opportunities offered by schools to host SACRE meetings and receive presentations on RE in the school.



SACRE was informed of the meeting of the WASACRE Executive with the Minister for Education (March 2011) where the issue of Estyn conducting a thematic review of RE was taken up with the Minister. The Minister's response was a positive one and the Minister agreed to support the inclusion of a thematic review of religious education in Estyn's next remit. SACRE look forward to using this information as a benchmark to assess standards in RE in the LA.

#### **Action**

1. SACRE resolved that a letter be sent to primary schools inspected Summer 2010 to congratulate them on the good standards in RE identified in their inspection report.
2. The LA to ask primary and secondary schools to submit a summary of the school's self evaluation at a frequency decided by the LA and its SACRE in consultation with schools.

#### **• Examination Results 2010**

Examination results for GCSE and GCE AS /Advanced Level achieved by pupils at secondary schools within the Authority have been analysed and considered. The results are compared with results of the previous 3 years. Cohort entry numbers in comparison to All - Wales figures are also analysed.

In **GCSE Religious Studies** eleven schools entered 575 pupils. This is a decrease in entry numbers and schools entering over 2009.

The overall % of **A\*-C** grades for Caerphilly was 76.9%. This is a very good result and better than last year's performance and better than the All-Wales figure of 74.3%.

The overall % of **A\*-G** grades for Caerphilly was **99.8%**. This again is a very good result and shows year on year an excellent pass rate comparable with the All Wales figure of 99%

The overall % of **A\*-A** grades for Caerphilly was 30.4% and is very good although below last year's performance and the All Wales figure of 32%. There has been a consistency in a significant % of pupils achieving this top grade over a three-year period.

SACRE was very pleased with this performance because the results this year are very good at all grades. Schools are to be commended at maintaining such good examination results.

**At GCSE Short Course in Religious Education** there continues to be good entry numbers. There were 1295 entries this year from 12 schools. Numbers have remained consistent.

The overall % of **A\*-C** grades for Caerphilly was **58.5%** and is the best performance of the last three years and comparable to the All Wales figure of 59.7%

The overall % of **A\*-G** grades for Caerphilly was **96.4%** and is comparable with previous performance and with the All-Wales figure of 97.7%

The overall % of **A\*-A** grades for Caerphilly was 22% and is the best performance of the last three years and comparable to the All Wales figure of 21.1%

It should be noted that in some schools more able pupils are entered for two short courses and their results are shown in the full course results. However, this does have implications for Short Course results particularly at A\*-A and A\*-C in those schools.

SACRE is very pleased to see 96.7% of pupils receiving some kind of accreditation for their studies at KS4.

At **GCE Advanced Level** there were 73 candidates from 8 schools - this shows an increase in entry figure and in number of schools entering. There has been a year on year increase in entries.

Those pupils achieving **A** grade were 20.5% and although below 2009 performance is comparable with the All Wales figure of 21.7%

Grades **A - C** maintains excellence with 84.9% pass rate and exceeds the All Wales figure of 78.5%

The % pass rate for grades **A - E** was very good again this year at 97.3% and is comparable with the All-Wales figures of 97.5%.

At **AS level** there were a total of 122 candidates from 9 schools. This figure has risen year on year and the number of schools entering for AS have also increased. At **A** grade the pass rate was 19.7% and although below 2009 excellent performance is better than the All Wales figure of 17%.

At **A-C** the pass rate was 71.3% and this is comparable with previous performance and significantly exceeds the All Wales figure of 48.1%

At **A-E** the pass rate was very good at 95.9%% and comparable with last year's very good result, and significantly exceeds the All Wales figure of 83% and

At all grade boundaries results are very good and are better than the All Wales figures. SACRE is extremely pleased with the AS / A level results this year.

It should be noted that definitive conclusions cannot be drawn because the figures represent raw scores and do not necessarily reflect the selectivity of the entry and in some cases the numbers are too small to be statistically significant.

A detailed table of examination results is found in Appendix 4.

SACRE also noted the results of Coleg Gwent (Cross Keys campus) for A and AS level.

### **Action**

SACRE resolved that schools within the Borough be informed of the outcomes of the SACRE analysis and congratulations expressed to staff and pupils in their achievements.

#### ▪ **Analysis of KS3 Teacher Assessment 2009 and 2010**

The local authority, through its advisory service, conducts an analysis of teacher assessment at the end of key stage 3. Comparisons are made with previous performance in religious education and also with Core and Foundation subjects of the National Curriculum. Pupils' (boys and girls) achieving L5+ was 68.4% and L6+ was 29.2%. Results have improved this year at L5+ and remain unchanged for L6+. The gap in performance between boys and girls at L5+ had narrowed in 2009 (12%) but increased to 16% in 2010. This gender gap in performance is also evident in English and History. The gap in performance between boys and girls at L6+ has remained consistent at 10% over the last three years.

## **SECTION 3 ADVICE ON COLLECTIVE WORSHIP**

### **3.1 SCHOOL INSPECTION REPORTS**

SACRE scrutinises relevant sections of school inspection reports on a twice yearly basis.

SACRE has examined 13 primary inspection reports and one secondary inspection report for the period Summer 2010-Spring 2011.

The provision for collective worship and SMSC is as follows:

At **primary** level the provision for collective worship meets statutory requirements.

The inspection reports identify positive features in relation to collective worship in many of the schools inspected.

#### **Good features:**

- Most schools promote learners' spiritual, moral, social and cultural development effectively
- Collective worship makes a positive contribution to pupils' spiritual and moral and personal development.
- Opportunities are provided for pupils to reflect.
- There is a strong emphasis on values and learners' needs.
- Acts of CW promote racial equality and respect for diversity well through themes such as harvest festivals in countries around the world.

#### **Shortcomings:**

No shortcomings are noted in the inspection reports in relation to collective worship.

At **secondary** level one school was inspected and they meet the statutory requirement to provide a daily act of collective worship for all pupils.

Comments on SMSC and collective worship include:

#### **Good Features:**

- Pupils make very good progress in their moral development
- The exceptional quality of the ethos within the school enables pupils to express and explore their viewpoints openly and honestly, and they respect the views of others.
- They develop their own personal values and learn to appreciate the values of others.
- Learning experiences contribute particularly well towards developing the learners' personal, moral, spiritual, social and cultural development.

#### **Shortcomings:**

- Collective worship does not always contribute effectively to pupils' spiritual development.

SACRE welcomed the aspects of the reports, which identified good practice, and also the identification of the shortcomings, so providing an agenda for improvement.

The new ESTYN Common Inspection Framework (Autumn 2010) provides limited information on collective worship and spiritual development. SACRE resolved to continue to use inspection reports to monitor statutory requirements are being met and to use whatever comments are applicable. SACRE considered how it could fulfil its statutory duty to monitor quality and provision of collective worship in the light of less evidence from Estyn reports. In consultation with the local authority education directorate it was agreed that a pro forma be used as a tool for monitoring collective worship and an overview of findings reported to SACRE on an annual basis

### **3.2 COLLECTIVE WORSHIP RESOURCES**

Schools were informed of appropriate resources and websites that support collective worship in schools.

Guidance materials on collective worship have been made available to schools on the LA advisory service website [www.esis.org.uk](http://www.esis.org.uk). The materials include Estyn's *Supplementary Guidance on Inspecting Collective Worship in Non-Denominational Schools* and WASACRE's *Guidance on Collective Worship Post 16*. Schools have also been sent copies of these documents.

## SECTION 4 OTHER ISSUES

### 4.1 WASACRE

SACRE has continued to affiliate to WASACRE and representatives have attended its meetings. Caerphilly SACRE took great pleasure in hosting the meeting of the Association in Autumn 2010. During the 2010-11 academic year issues considered at WASACRE meetings have been fully reported back to SACRE and full discussions have taken place. SACRE welcomes the pro-active work of WASACRE in taking up issues that have implications for RE and keeping member SACREs fully informed. SACRE is represented on the WASACRE Executive committee by cc Michael Gray as Chairperson of WASACRE and their professional adviser Mrs Vicky Thomas and receive regular feedback from them. Councillor Gray and Mrs Thomas were part of the WASACRE deputation to meet the Minister for Education at the Welsh Assembly Government to put to the Minister some questions of concern to SACREs and the Wales Association.

### 4.2 REVIEW OF RELIGIOUS EDUCATION IN CAERPHILLY SECONDARY SCHOOLS

The local authority as part of its Review and Development programme with its advisory service reviewed 14 out of the 16 schools in Caerphilly in the academic year 2010-2011. The focus for the review was Teaching and Learning and Assessment for Learning in religious education. The findings are as follows:

- 20 lessons were observed.
- 85% of lessons were graded Excellent or Good for Teaching and Learning
- 85% of lessons were graded Excellent or Good for Assessment for Learning
- The breakdown of lesson grades was:

The LA and its SACRE were informed of the outcomes and each school was given a report on its areas of strength in religious education and recommended areas for development. SACRE was pleased with the very good outcomes from the review of RE.

### 4.3 HOLOCAUST EDUCATION

Caerphilly SACRE was informed of the 2011 Holocaust Memorial Day theme '*Untold Stories*' and that Holocaust Memorial Day resources can be found on their website [www.hmd.org.uk](http://www.hmd.org.uk) – a CD ROM of material is also included about listening to survivors talking about their experiences.

SACRE discussed how some schools were embracing the issues raised by HMD very seriously and reference was made to some primary and secondary schools who were conducting activities and acts of collective worship to commemorate the day.

SACRE was informed that Wales had been included in the Lessons from Auschwitz programme for 2011. SACRE was invited to receive a presentation from students at Bedwas High School on their experiences of attending the LFA visit to Auschwitz in 2010.

#### **4.4 THE RELIGIOUS EDUCATION FESTIVAL MARCH 2011**

SACRE has been fully involved in organising and participating in events to celebrate the National RE Festival for England and Wales that took place in March 2011. The purpose of the festival was to celebrate and publicise the value and importance of RE for schools and communities. It provided an opportunity for schools in the authority to showcase all the good practice that takes place in RE and for schools to develop and strengthen links with their local community to encourage and develop community cohesion. SACRE ensured schools were fully informed of the events and directed to the national website [www.celebratingre.org](http://www.celebratingre.org) for further information and a range of ideas for classroom activities.

Caerphilly SACRE members attended the 'Celebrating RE' National Launch at the Vale of Glamorgan on March 2<sup>nd</sup> 2011. The Chair of Caerphilly SACRE cc Michael Gray (also Chair of the Association) attended the launch of the RE Festival in England at Westminster on behalf of the SACREs of Wales.

Schools and SACRE members from Caerphilly, were involved in the Central South Consortia event held at Ty Dysgu in Treforest on March 10<sup>th</sup> 2011. This was very well attended by over 200 teachers, pupils and SACRE members. It was an opportunity for schools and SACREs to celebrate together and showcase the good practice found in schools. There were a number of presentations and performances from primary and secondary schools in the consortium. Caerphilly schools taking part included Cwrt Rawlin Primary and St Gwladys Primary who performed dance routines on the themes of Chinese New Year and the Genesis story of Creation. Ysgol Gyfun Cwm Rhymmni also took part. It was a wonderful spectacle of schools presenting what they have done in religious education lessons and included dance, raps and songs including the singing of the national song '*Place of Trust/ Hafan Ffydd*'. The Directorate for the authorities introduced their schools and an enjoyable time was had by all present.

Two primary schools, Hendre Junior School and St James' Primary School, entered the WASACRE National RE Competition and they were judged by a delegation from Caerphilly SACRE and the winning entry forwarded to WASACRE for final judging by the Association.

#### **4.5 THE RESILIENCE PROJECT**

SACRE and schools have been informed of the REsilience project managed by the RE council of England and Wales under contracts with DCELLS (Wales) and DCSF (England). Its purpose is to support teachers of religious education in maintained secondary schools whilst also supporting the government's community cohesion strategy. It has been initiated to equip RE teachers with the knowledge and skills to increase their confidence in addressing contentious issues which arise in classrooms - particularly those that relate to religion, belief, ethnicity, negative stereotyping and religious extremism. It funds support for departments or individuals to deal with such contentious issues through the use of a mentor to support each school, identifying a catalogue of resources, with 'gateway' documents which give a brief overview of a contentious issue and 'signposts' pointing to reliable and relevant resources for the teacher to research further.

SACRE informed secondary schools of the project and encouraged them to register their interest by registering online at their website [www.RE-silience.org.uk](http://www.RE-silience.org.uk). Some Caerphilly schools have registered to take part in the project and the roll out to

schools has been extended to the end of the summer term 2011. A presentation from Heolddu Comprehensive entitled '*The Resilience Project: A School's Perspective*' has been arranged for the autumn 2011 meeting of SACRE.

#### **4.6 RELIGIOUS EDUCATION: GUIDANCE FOR KEY STAGES 2 AND 3**

SACRE examined and discussed the DCELLS guidance, published March 2011. These documents have already been sent to schools. It provides some key messages for planning learning and teaching. It comes with an accompanying CD ROM containing PDF versions of the National Exemplar Framework for RE and The Skills Framework. It also contains some 'Additional Guidance: Exemplifying learner profiles at Key Stages 2 and 3 in religious education'. They are part of a series of materials that help teachers at KS2 and KS3 to implement the revised curriculum and its associated assessment arrangements.

Both documents are for reference when teachers wish to:

- Review their learning plans and activities
- Consider the standards set out in the National Exemplar Framework for RE for 3-19 year olds in Wales and locally agreed syllabus for RE
- Work with other teachers to reach a shared understanding of the level descriptions
- Prepare and make judgments at the end of the key stage
- Develop their own learner profiles
- Support transition from KS2-KS3.

#### **4.7 TRAINING OF SACRE MEMBERS**

As part of it's training for members SACRE proposed the following:

To keep members updated on developments in RE through regular presentations to SACRE members. This year SACRE received two presentations.

- (1) Lessons from Auschwitz Programme- presentation by sixth form students at Bedwas High School
- (2) Presentation on the work of VALREC (*Valleys Racial Equality Council*) by Mr Darren Ralph

SACRE, where possible, would hold meetings at places of worship in the Borough and this year visits were made to the United Reform Church, Van Road in Caerphilly and Cross Keys Methodist Church.

SACRE, where possible, would hold meetings at schools in Caerphilly for members to familiarise themselves with RE and collective worship in schools. Two meetings were held this year at Bedwas High School and Ysgol Penallta (the new Welsh Medium primary school) where members observed an act of collective worship. SACRE wishes to extend their thanks to the schools for hosting the meeting.

SACRE is very appreciative of these opportunities for training and visits and would like to extend their appreciation to all concerned. A special note of thanks is extended to the current clerk to SACRE (Emma Sullivan) and the previous clerk to SACRE (Rebecca Thomas) for all their hard work in making such arrangements this year.
