WASACRE STATEMENT TO SACRES

The WASACRE Executive Committee is aware that SACRES in Wales and England have recently received an email from the British Humanist Association, relating to Humanist representation on SACRES.

This was discussed at the WASACRE Executive Committee meeting on 5 October 2011, and it was agreed that clarification would be sought from the Welsh Government in relation to the legal statements made in the email. The results of this exercise will be reported back to SACRES. This matter will also be discussed at the next meeting of the Association in Cardiff on Thursday, 24 November 2011. The Executive Committee recommends that SACRES delay their response to this email until WASACRE has made its enquiries and this matter has been discussed at the Association's meeting on 24 November, where it is hoped that all SACRES in Wales will be represented.
