1.1 To discuss monitoring of Religious Education through school self-evaluation

2.1 SACRE has resolved to use school self-evaluation as a monitoring tool. As schools become more self-evaluative and adept at writing self-evaluation reports and as internal structures and systems for monitoring become more systematic and robust then more constructive critical analysis by schools may now be in place. Schools will be asked to complete the self-evaluation pro forma on RE and Collective Worship once during their inspection cycle. An analysis of the outcomes to be presented to SACRE.
