1. PURPOSE OF REPORT

1.1 To inform Members of the updated RE;Quest Resources for teaching Christianity in schools.

2. SUMMARY

2.1 RE:Quest one of the largest online resources for teaching about Christianity in schools in the UK has recently updated their website.

3. LINKS TO STRATEGY

3.1 SACRE's have a statutory duty under Section 391 of the 1996 Education Act to monitor and develop the provision of Religious Education and Collective Worship in schools and the CCBC Strategic Equality Plan 2012.

4. THE REPORT

- 4.1 RE:Quest is one of the largest online resources for teaching about Christianity for schools in the UK. In the summer of 2013 the web site was re-launched with a new design and new material.
- 4.2 It is a free resource for teachers and pupils, giving access to up-to-date resources for the exploration of Christianity within Religious Education and Religious Studies for all age groups primary and secondary.
- 4.3 Material includes films, images, interactive features and age appropriate text. The Teachers' Toolkit contains lesson plans, schemes of work, video clips and downloadable materials. It also contains multi-media resources and training material from educational professionals including Lat Blaylock makes the site not only a resource for RE but also provides support for teaching staff.
