## 1. DECLARATIONS OF INTEREST

Declarations of interest were received at the start of the meeting as follows:

- (1) Councillor R.W. Gough declared an interest in the application from Llanbradach Community Centre because he is a member of the committee.
- (2) Councillor K. Lloyd declared an interest in the application from Trinant Sports Club RFC because a family member is the club's secretary.
- (3) Councillor Mrs E.M. Aldworth declared an interest in the application from St Barrwg's Church, Bedwas because she is a member of the church.

## 2. TO APPOINT A CHAIRMAN

Councillor J.O. Evans was appointed Chairman for the ensuing year.

## 3. TO APPOINT A VICE-CHAIRMAN

Councillor R. Bidgood was appointed Vice-Chairman for the ensuing year.

## 4. MINUTES

Members noted the minutes of the Grants to the Voluntary Sector Panel meeting held on 23rd March 2009 (minute nos. 1 - 9 on page nos. 1 - 3).

## 5. FINANCIAL ASSISTANCE – AMENDMENTS TO CRITERIA

The panel agreed to consider the amendments to funding criteria prior to the applications for financial assistance.

Members noted the reduced overall available budget resulting from an increase in Discretionary Rate Relief (6.12%) verses the inflationary increase (2%). The need to revise the criteria or format of the panel was debated. Members were keen for the panel to remain in order to offer financial assistance to the most vulnerable people/groups in the borough such as the young and elderly. However it was acknowledged that to achieve this, changes had to be made. A general debate followed in which members considered the following:

- Requesting an up-to-date bank statement to ensure funds were allocated to the most needy;
- Reviewing community first group funding as alternative funds were available;
- Possible reduction of set funding awards to national groups;
- Possible removal of double payments for initial applications;
- Review of ceiling limit for credit unions.

Officers were asked to collate additional information for members to fully consider the available options. This was to include the following:

- Possible reduction in the percentage of rate relief offered;
- Ascertainment of alternative funding schemes available.

The panel agreed to hold a further meeting in late September to debate the necessary review and that any changes made in relation to Discretionary Rate Relief would come into effect from April 2010, whilst others would have an immediate effect.
