# 1. DECLARATIONS OF INTEREST

Declarations of interest were received at the start and during the course of the meeting as follows:-

# 2. MINUTES

Members noted the minutes of the Grants to the Voluntary Sector Panel held on 14th July 2011 (minute nos. 1 - 7, on page nos. 1 - 3).

# 3. MATTERS ARISING

# **Declarations of Interest (Minute Reference 1(3))**

It was noted that Councillor Mrs G.D. Oliver's declaration should read that she was as a Member of the Pontlottyn Old Age Pensioners Association (11/GVS/022) rather than the Gilfach Old Age Pensioners Association (11/GVS/032).

# Welsh Church Acts Fund (Minute Reference 6.3.5)

Members were informed that Monmouthshire County Council had confirmed that payments could be made to allotments, subject to a lease on the land being present.

#### 4. APPLICATIONS FOR FINANCIAL ASSISTANCE

4.1 Members noted that with the carried forward balance from 2010-2011 of £75,393.75, the available budget for 2011-2012 is £153,200.95. Total amount requested, as detailed within the report, is £8,162.75.

Members voiced their concerns regarding the reduced number of applications received and the significant level of unspent monies each year. The Grants Co-ordinator advised that GAVO was to contact previous applicants and that there would shortly be a campaign to publicise the availability of grants. It was hoped these activities would encourage future applications.

The Group Accountant (Revenue Advice and Support) suggested a number of interim and long term solutions that could assist the expedient payment of awarded grants and help reduce any underspend. The Panel responded positively on the understanding that applications outside the general criteria would still be presented to the group for consideration.

In addition, Members requested that a list of all applications, agreed under the general criteria, be e-mailed to them, so they may notify officers of any declarations of interest.

It was agreed that the Group Account write a report for the Panel to consider increasing the value of grants for a one year period, with effect from April 2012. Consideration would also be given to revising the amount given to groups with a number of members, such as Scout Groups or sport teams. Additionally, Members agreed to promote the availability of financial assistance.

#### 4.2 Welsh Church Acts Fund

Members were advised that additional funding of £30,697 had once again increased the normal annual allocation to give a fund for 2011-2012 of £76,742. However, following discussions with Monmouthshire County Council, the underspend from previous years (£93,829) was to be carried forward, resulting in a total available budget of £170,571.

The total of amount requested in accordance with the agreed criteria is £11,948.

Members reiterated their concerns regarding the reduced number of applications received and the significant level of underspend each year. Following a discussion, it was agreed that the Group Account should approach Monmouth County Council to ascertain if the percentage of grant aided can be increased from a third to a half of the total cost for smaller projects and that grants for projects of £4,500 and over be increased from £1,500 to £2,000.
