Councillor Poole provided an update on the collaborative working arrangement to deliver pest control services to Blaenau Gwent County Borough Council and advised that the Pest Control Service has received a number of positive comments from both residents and Members of Blaenau Gwent County Borough. The Members had been particularly complementary about the presentation they had received at its inception and were pleased with the results that have already been achieved. He advised that the agreement will be effective for five years (from 15th April 2013, expiring on 31st March 2018) and outlined the TUPE arrangements that are in place for staff from Blaenau Gwent County Borough Council.
