 - Week 4 The draft FWP is published on the Council website and sent to key Stakeholders inviting comments.

- Week 5 Scrutiny Leadership Group considers the draft FWP along with consultation responses and agrees the final version.
- Week 6 Final Forward Work Programmes are published on Council Website.
