SUBJECT: WELSH ASSEMBLY GOVERNMENT DEVELOPMENT CONTROL

**QUARTERLY SURVEY (JANUARY - MARCH 2012)** 

REPORT BY: CHIEF EXECUTIVE

#### 1. PURPOSE OF REPORT

1.1 The purpose of this report is to update Members on development control matters, as requested at the Performance Management meeting of the Scrutiny Committee on 9th December 2010.

1.2 The report was presented to the Planning Committee on 20th June 2012.

#### 2. THE REPORT

2.1 Welsh Assembly Government publishes reports on the development control performance of Local Planning Authorities. The data for Caerphilly compared to the Wales average is outlined below.

2.2 Percentage of planning applications determined within eight weeks of receipt:

The overall performance continues to be above the national average with Caerphilly twelfth out of 25 authorities in the last quarter.

The number of applications submitted in the last quarter was similar to that submitted in same quarter in 2011, and there are no signs at present that the number of applications is going to increase. There was a decline in the percentage of minor applications determined within eight weeks but the performance in terms of householder applications continues to be above the Welsh average.

- 2.4 Of the 54 applications that were determined outside 8 weeks in the January to March quarter, in only 12 cases could it be said that there was no clear reason for the delay. The reasons in the other cases were: late submission of amended plans and information (30), application reported to committee (6), awaiting the completion of an s106 agreement (3), and the need to refer an application to Cadw (3).
- 2.5 With regard to improving the quality of development in the borough, of the 161 planning permissions granted in the January to March quarter, in 24 cases (15%) improvements were sought through the submission of amended plans and in 3 cases (2%) through a section 106 agreement before a decision was made. Such improvements ranged from amended designs and layouts for residential extensions and housing development, to securing highway improvements through section 106 agreements. However, securing the quality of development does not stop with the granting of planning permission: of the 161 consents given, in 131 cases (81%) additional conditions were added over and above the standard conditions that define when the development should start and which plans were approved. Those extra conditions cover such matters as materials, landscaping, the protection of trees, the provision of parking, hours of operation and the decontamination of land.
- 2.6 Twenty-six applications were refused permission because they did not comply with the local planning authority's policies and other material planning considerations. Of the 7 appeal decisions received, 5 (71%) were in the Council's favour.
- 2.7 Details are set out below of the performance of the enforcement team during the January to March quarter of this year, in dealing with unauthorised development. The performance indicators below attempt to mirror the development control process by imposing two main measures on the enforcement system: the percentage of cases where it is decided within eight weeks what type of action should be taken, and the percentage of cases that are resolved within twelve weeks.
