SUBJECT: REPORT FROM PUBLIC SERVICES OMBUDSMAN FOR WALES

REPORT BY: MONITORING OFFICER

1. PURPOSE OF REPORT

1.1 To note the report from the Public Services Ombudsman for Wales on a maladministration complaint made against Caerphilly County Borough Council.

2. LINKS TO STRATEGY

2.1 The Authority is under a statutory duty to consider reports from the Ombudsman and to give effect to their recommendations. The duty to oversee this is within the terms of reference of this Committee.

3. THE REPORT

- 3.1 Since 1st April, 2006 the Public Services Ombudsman for Wales ("the Ombudsman") has had jurisdiction under the Public Services Ombudsman (Wales) Act 2005. This Act has superseded but not completely repealed the previous legislation (Local Government Act 1974) and deals with maladministration complaints made to the Ombudsman.
- 3.2 There are two forms of report Under Section 16 which is the form of report which needs to be formally considered by the Authority and Section 21 where the Ombudsman feels that a public report is not required and the matter has been satisfactorily resolved.
- 3.3 This report before Members is in relation to an Ombudsman report under Section 21 and the report is attached at Appendix 1.
- 3.4 The maladministration complaint arose from a complaint lodged by Ms. A about the service provided for her by the Council when she was, as one of the Council's registered foster carers, caring for two children placed with her. Her complaint concerned the Council's placement decisions, the support given to her, reimbursement for damage to her property and her fostering allowance payments. She also indicated that she was dissatisfied with the Council's response to the support aspect of her claim.
- 3.5 The complaint was investigated by the Ombudsman who issued his Report in the form of a letter dated 8th September, 2010.
- 3.6 Members will note that the Ombudsman did not uphold those parts of Ms. A.'s complaint that involved the Council's placement decisions and reimbursement for property damage.
- 3.7 The Ombudsman did however uphold those aspects of Ms. A.'s complaint relating to the fostering allowance and the general handling by the Council of her complaint.
- 3.8 The Ombudsman's recommendations are set out on page 6 of the Report.

3.9 Relevant Officers were consulted on the Report and the recommendations of the Ombudsman have been accepted and implemented.
