### 1. APOLOGIES

Apologies for absence had been received from Councillors A. Higgs, R. Saralis and Mrs E. Stenner.

### 2. DECLARATIONS OF INTEREST

There were no declarations received at the beginning or during the course of the meeting.

### 3. MINUTES – 13TH JULY 2016

The minutes of the Grants to the Voluntary Sector Panel held on 13th July 2016 (minute nos. 1 - 10) were received and approved as a correct record.

### 4. APPLICATIONS FOR FINANCIAL ASSISTANCE

#### 4.1 Statement of Expenditure

Members noted the budget available for 2016-2017 as £102,814.71, which included the estimated reduction for Discretionary Rate Relief (£151,516.85), budget carried forward and Grant allocations to date. If all awards in the report be agreed the remaining budget would be £97,184.71.

#### 4.2 Welsh Church Act Fund

Members noted the Welsh Church Act Fund applications received and approved by officers since the last meeting in accordance with the agreed criteria as set out in Appendix 3. The total allocated amounts to £7,630.00.

Monmouthshire County Council have advised that the allocation of £61,600.00 is available for 2016-17 and the underspends of £174,518.33 could be carried forward, resulting in a total available budget for 2016/17 of £236,118.33. Members noted that if all awards spend to their maximum allocation there would be a remaining balance of £228,198.33.

At the last meeting, the Panel requested that Officers seek information from other Local Authorities on their allocation processes for the Welsh Church Fund and provide a report to Members for consideration and make recommendations to Cabinet. Since the last meeting, information has been sought by the Interim Head of Corporate Finance and advise has been provided by the Head of Legal Services and Monitoring Officer that any proposed changes to the current process and criteria would need approval of Cabinet. The Panel therefore agreed to seek a steer from Cabinet through PDM, feedback and seek the views of the Panel, prior to a recommendation to Cabinet for approval.

Members noted the applications received since the last meeting totalling £7,630.00, as listed in Appendix 3, which are in accordance with the agreed criteria and to be processed by officers.

#### 4.3 Applications for Financial Assistance: Panel Awards

Members were asked to consider the application listed in Appendix 1 to the report and to make appropriate recommendations to the Interim Head of Corporate Finance for approval.

RECOMMENDED that the following application for financial assistance be referred to the Interim Head of Corporate Finance for approval under delegated powers:-

(a) St Andrew's Church £500.00

#### 4.4 Applications for Financial Assistance: General Criteria Awards

Members noted the applications received since the last meeting totalling £5,130.00, as listed in Appendix 2, which are in accordance with the agreed criteria and to be processed by officers.

## GRANTS TO THE VOLUNTARY SECTOR PANEL – 19TH JULY 2017

**SUBJECT: APPLICATIONS FOR FINANCIAL ASSISTANCE**

### 1. PURPOSE OF REPORT

- 1.1 To present the Panel with the applications for financial assistance received to date for the current financial year.

### 2. SUMMARY

- 2.1 The report advises Panel members of the budget allocations for both the Voluntary Sector budget and the “Welsh Church Fund” and provides details of applications received.

### 3. LINKS TO STRATEGY

- 3.1 Voluntary and Community Sector organisations make an important contribution to public service provision across the borough and are key participants in the Community Strategy implemented through the Single Integrated Plan Caerphilly Delivers. The Single Integrated Plan has the following priority outcomes: Prosperous Caerphilly; Safer Caerphilly; Learning Caerphilly and Healthier Caerphilly.
- 3.2 This report links to the following Well-Being Goals within the Well-Being of Future Generations (Wales) Act 2015:
- A Wales of cohesive communities
  - A prosperous Wales
  - A healthier Wales

### 4. REPORT

#### 4.1 ASSISTANCE TO VOLUNTARY SECTOR BUDGET

- 4.1.1 The Panel's budget for 2017/2018 is as follows:

Budget 2017-18	£175,817.00
Less Discretionary Rate Relief (Estimated)	£158,515.45
Remaining Budget	£17,301.55
Carry forward balance from 2016-17	£90,422.65
Total Available Budget 2017-18	£107,724.20
Total 2017-18 Grants awarded to date	£0.00
Balance Remaining	<b>£107,724.20</b>

- 4.1.2 The projected Discretionary Rate Relief for 2017-18 is £158,515.45. Allowing for the projected spend on the Discretionary Rate Relief, the available balance for schemes is £107,724.20 which includes the carry forward balances.
- 4.1.3 The total maximum amount requested in respect of the applications listed in Appendix 1 is **£3,799.96 (4 No.)**. These applications do not meet the criteria as set out in Appendix 5. Panel Members are asked to consider these applications and make appropriate recommendations to the Interim Head of Corporate Finance for approval or otherwise under delegated powers.
- 4.1.4 Appendix 2 details those applications that meet the criteria set out in Appendix 5 that have been approved by officers (but not actioned). These total **£5,500.00 (37 No.)**.
- 4.1.5 The balance remaining if all grants requested are awarded as set out in Appendix 1 and Appendix 2 will be £98,424.24.
- 4.1.6 As previously agreed by the Panel grants awarded during the 2017/18 financial year that exceed the budget allocation will be funded from the brought forward balances.

## 4.2 WELSH CHURCH ACT FUND

- 4.2.1 At previous meetings of the Panel it was decided that the following criteria would apply when considering applications for assistance from the Welsh Church Fund:-
- (i) A grant of no more than £2,000 to be given to partly fund projects of £6,000 and over;
  - (ii) Smaller projects less than £6,000 be grant aided up to a third of the total cost;
  - (iii) All organisations receiving grants produce the necessary financial records to show the expenditure has been incurred;
  - (iv) No organisation is allowed to apply in consecutive years.
- 4.2.2 At the meeting of 13th July 2009 Members agreed that in future, officers would approve applications meeting the Welsh Church Act Fund criteria, using delegated powers. Such decisions would then be reported to the Panel for information, where Members could ask for further information if required.
- 4.2.3 Caerphilly County Borough Council has received written confirmation from Monmouthshire CC that the 2017/18 budget allocation is **£61,600.00**. Monmouthshire CC have confirmed that the underspends from previous years of **£218,568.33** can be carried forward, resulting in a total available budget for the current year of **£280,168.33**.

- 4.2.4 The total amount requested in respect of the applications listed in Appendix 3 is **£2,000.00 (1 No.)**. This application requires a Panel decision as the applicant is a Community Interest Company (CIC) and the building is used to run a business. Panel Members are asked to consider this application and make appropriate recommendations to the Interim Head of Corporate Finance for approval or otherwise under delegated powers.
- 4.2.5 Details of applications received since the last meeting that meet the Welsh Church Act Fund criteria are set out in Appendix 4. The total of amounts requested in accordance with the agreed criteria is **£3,466.67 (2 No.)**.
- 4.2.6 If all awards approved to date spend to their maximum allocation there will be a balance of £274,701.66 remaining.
- 4.2.7 Appendix 6 contains a list of previously approved applications that have exceeded the 18 month time limit to claim funding as set out in the Terms and Conditions. These applicants have been advised the grant has now been withdrawn. These withdrawn grants total £2,215.00 (2 No).
- 4.2.8 Members will recall that the Panel has previously agreed that officers should seek information from other Local Authorities on their allocation processes for the Welsh Church Fund and provide a report for Panel Members to consider and make recommendations to Cabinet. Much of this information has now been received and the Interim Head of Corporate Finance has been advised by the Interim Head of Legal Services & Monitoring Officer that any proposed changes to the current process and criteria will need to be approved by Cabinet. The Panel will be consulted in due course on any proposed changes prior to consideration by Cabinet.

## 5. WELL-BEING OF FUTURE GENERATIONS

- 5.1 Grants awarded from the Grants to the Voluntary Sector budget and the Welsh Church Fund contribute to the following Well-Being goals:-
- A Wales of cohesive communities – Through financially supporting community groups.
  - A prosperous Wales – By helping organisations to be financially resilient.
  - A healthier Wales – Through encouraging participation in sports.
