1. TO APPOINT THE CHAIR AND VICE-CHAIR FOR THE ENSUING YEAR

It was moved and seconded that Councillor G. Oliver be appointed as Chair of the Grants to the Voluntary Sector Panel for the ensuing year and by a show of hands this was unanimously agreed.

RESOLVED that Councillor G. Oliver be appointed Chair of the Grants to the Voluntary Sector Panel for the ensuing year.

It was moved and seconded that Councillor R. Gough be appointed as Vice Chair of the Grants to the Voluntary Sector Panel for the ensuing year and by a show of hands this was unanimously agreed.

RESOLVED that Councillor R. Gough be appointed as Vice Chair of the Grants to the Voluntary Sector for the ensuing year.

2. APOLOGIES

Apologies for absence had been received from Councillors M. Davies, D. Hardacre, M.P. James, A. Higgs, Mrs A. Leonard, D.W.R. Preece and R. Saralis.

3. DECLARATIONS OF INTEREST

Councillor Lyndon Binding declared an interest in Agenda Item 5 (Applications for Financial Assistance) Appendix 4. Details of the declarations are recorded with the relevant item.

4. MINUTES – 23RD NOVEMBER 2016

The minutes of the Grants to the Voluntary Sector Panel held on 23rd November 2016 (minute nos. 1 – 4.4) were received and approved as a correct record.

5. APPLICATIONS FOR FINANCIAL ASSISTANCE

5.1 Assistance to the Voluntary Sector Budget

Members noted the budget available for 2017-2018 is £107,724.20, which included the estimated reduction for Discretionary Rate Relief (£158,515.45) and budget carried forward from 2016-2017 (£90,422.65). If all awards in the report are agreed the remaining budget would be £98,424.24.

5.2 Members were asked to consider the applications listed in Appendix 1 to the report and to make appropriate recommendations to the Interim Head of Corporate Finance for approval.

RECOMMENDED that the following applications for financial assistance be referred to the Interim Head of Corporate Finance for approval under delegated powers:-

(a)	Croespenmaen Baptist Church	£200.00
(b)	Cambrian Educational Foundation for Deaf Children	£200.00
(c)	Cascade Keyboard Group	£200.00
(d)	Black Vein Miners Memorial Society	£500.00

In addition, Members noted that Cambrian Educational Foundation for Deaf Children make an annual application, as a result, it was requested that they provide additional information to supplement any future application. Furthermore, Members requested that Black Vein Miners Memorial Society be advised to also apply for funding under the Welsh Church Act Fund.

5.3 Applications for Financial Assistance: General Criteria Awards

Members noted the applications received since the last meeting totalling £5,500.00, as listed in Appendix 2, which are in accordance with the agreed criteria and to be processed by officers.

5.4 Welsh Church Act Fund

Councillor Lyndon Binding declared an interest in Appendix 4 Application 17/WCF002, The Benefice of Eglwysilan and Caerphilly St Ilan's Church as the application refers to a Church he attends.

Monmouthshire County Council have advised that the allocation of £61,600.00 is available for 2017-18 and the underspends from previous years totalling £218,568.33 could be carried forward, resulting in a total available budget for 2017/18 of £280,168.33. Members noted that if all awards spend to their maximum allocation there would be a remaining balance of £274,701.66.

Members were asked to consider the application listed in Appendix 3 of the report and make the appropriate recommendation to the Interim Head of Corporate Finance for approval, as this is the first application received by a "Community Interest Company".

RECOMMENDED that the following application for Welsh Church Act Fund assistance be referred to the Interim Head of Corporate Finance for approval under delegated powers:-

(a)	Libanus Lifestyle (Wales) CIC	£1,878.06

Members noted the applications received since the last meeting that meet the Welsh Church Act Fund criteria, as outlined in Appendix 4 of the report, which totalled £3,466.67.

In addition, Members noted Appendix 6, which outlines the previously approved applications that have exceeded the 18 month time limit to claim funding, whom have now been advised that the grant has been withdrawn.

In discussing the allocation of the Welsh Church Act Fund, Officers highlighted that there have been significant underspends in previous years. Following consideration and discussion, the Panel supported the Officers proposal to seek a steer from Cabinet on revising the award criteria in future years. The Panel will be consulted on any proposed changes before they are formally agreed.

The meeting closed at 5.29 p.m.

GRANTS TO THE VOLUNTARY SECTOR PANEL – 22ND NOVEMBER 2017

SUBJECT: APPLICATIONS FOR FINANCIAL ASSISTANCE

REPORT BY: ACTING DIRECTOR OF CORPORATE SERVICES & SECTION 151 OFFICER

1. PURPOSE OF REPORT

- 1.1 To present the Panel with the applications for financial assistance received to date for the current financial year.

2. SUMMARY

- 2.1 The report advises Panel members of the budget allocations for both the Voluntary Sector budget and the “Welsh Church Fund” and provides details of applications received.

3. LINKS TO STRATEGY

- 3.1 Voluntary and community sector organisations make an important contribution to services to the public across the borough and are key participants in the Compact Agreement between the public and third sector.
- 3.2 This report links to the following Well-Being Goals within the Well-Being of Future Generations (Wales) Act 2015:
- A Wales of cohesive communities
 - A prosperous Wales
 - A healthier Wales

4. REPORT

4.1 ASSISTANCE TO VOLUNTARY SECTOR BUDGET

- 4.1.1 The Panel's budget for 2017/2018 is as follows:

- 4.1.2 The projected Discretionary Rate Relief for 2017-18 is £141,647.54. Allowing for the projected spend on the Discretionary Rate Relief and the grants awarded to date, the available balance for schemes is £118,192.11 which includes the carry forward balances and the returned award.
- 4.1.3 The total amount requested in respect of the applications listed in Appendix 1 is **£3,300.00 (4 No.)**. These applications do not meet the criteria as set out in Appendix 4. Panel Members are asked to consider these applications and make appropriate recommendations to the Interim Head of Corporate Finance for approval or otherwise under delegated powers.
- 4.1.4 Appendix 2 details those applications that meet the criteria set out in Appendix 4 that have been approved by officers (but not actioned). These total **£7,140.00 (45 No.)**.
- 4.1.5 The balance remaining if all grants requested are awarded as set out in Appendix 1 and Appendix 2 will be £107,752.11.
- 4.1.6 As previously agreed by the Panel grants awarded during the 2017/18 financial year that exceed the budget allocation will be funded from the brought forward balances.

4.2 WELSH CHURCH ACT FUND

- 4.2.1 At previous meetings of the Panel it was decided that the following criteria would apply when considering applications for assistance from the Welsh Church Fund:-
- (i) A grant of no more than £2,000 to be given to partly fund projects of £6,000 and over;
 - (ii) Smaller projects less than £6,000 be grant aided up to a third of the total cost;
 - (iii) All organisations receiving grants produce the necessary financial records to show the expenditure has been incurred;
 - (iv) No organisation is allowed to apply in consecutive years.
- 4.2.2 At the meeting of 13th July 2009 Members agreed that in future, officers would approve applications meeting the Welsh Church Act Fund criteria, using delegated powers. Such decisions would then be reported to the Panel for information, where Members could ask for further information if required.
- 4.2.3 Caerphilly County Borough Council has received written confirmation from Monmouthshire CC that the 2017/18 budget allocation is **£61,600.00**. Monmouthshire CC have confirmed that the underspends from previous years of **£218,568.33** can be carried forward, resulting in a total available budget for the current year of **£280,168.33**.

- 4.2.4 Details of applications received since the last meeting that meet the Welsh Church Act Fund criteria are set out in Appendix 3. The total of amounts requested in accordance with the agreed criteria is **£9,650.40 (5 No.)**.
- 4.2.5 If all awards approved to date spend to their maximum allocation there will be a balance of £265,173.20 remaining.

- 4.2.6 Members will recall that the Panel has previously agreed that officers should seek information from other Local Authorities on their allocation processes for the Welsh Church Fund and provide a report for Panel Members to consider and make recommendations to Cabinet. Much of this information has now been received and the Interim Head of Corporate Finance has been advised by the Interim Head of Legal Services & Monitoring Officer that any proposed changes to the current process and criteria will need to be approved by Cabinet.
- 4.2.7 The Interim Head of Corporate Finance has discussed this matter with the Leader and it has been agreed that a report will be prepared for Cabinet early in the New Year outlining potential changes to the Welsh Church Fund in terms of the level of funding that can be awarded. Any changes agreed by Cabinet will then be implemented from April 2018. The Grants to the Voluntary Sector Panel will be consulted prior to any proposals being presented to Cabinet.

5. WELL-BEING OF FUTURE GENERATIONS

- 5.1 Grants awarded from the Grants to the Voluntary Sector budget and the Welsh Church Fund contribute to the following Well-Being goals:-
- A Wales of cohesive communities – Through financially supporting community groups.
 - A prosperous Wales – By helping organisations to be financially resilient.
 - A healthier Wales – Through encouraging participation in sports.

6. EQUALITIES IMPLICATIONS

- 6.1 There are no direct equalities implications arising from this report so no Equality Impact Assessment has been carried out.
