## 1. APOLOGIES FOR ABSENCE

### 3. HACKNEY CARRIAGE/PRIVATE HIRE VEHICLE LICENCES

It was noted that XXXX had failed to supply evidence on a 6 - monthly basis (as a condition of his licence) to demonstrate compliance with the Intended Use Policy.

The Taxi and General Sub Committee unanimously RESOLVED that for the reasons outlined at the meeting, hackney carriage licence no. XXX, registration no. XXXX, held by XXXX of XXXX, Bristol, be revoked for failure to satisfy the Sub Committee that he had been working entirely and predominantly within the Caerphilly area contrary to the Council's Intended Use Policy, and in the event that the hackney carriage plates are not returned, legal proceedings be instigated.

# 4. HACKNEY CARRIAGE/PRIVATE HIRE VEHICLE DRIVER'S LICENCE

The Taxi and General Sub Committee unanimously RESOLVED that for the reasons outlined at the meeting and to the applicant when present, of existing hackney carriage/private hire

vehicle drivers' licence no. XXX, held by XXXX of XXXX, XXXX, Bargoed, be allowed to continue, subject to a final letter of warning as to her future conduct being sent.

## 5. APPLICATION FOR HACKNEY CARRIAGE LICENCES

The Taxi and General Sub Committee unanimously RESOLVED that: -

For the reasons outlined at the meeting and to the applicant when present (and following inspection of the vehicle), the application of XXXX of XXXX, XXXX Caerphilly to licence a vehicle (registration no.
