Brexit.	<p>RESOLVED that subject to an amendment to paragraphs 7.2 and 10.1.2 that the figure quoted should be £20.08m and an additional two recommendations to include <i>both Leaders from the Opposition Groups be invited to join the recently established internal Brexit Working Group and any emergency spends authorised under delegated powers will be reported retrospectively to the appropriate Committee</i>, and for the reasons contained in the Officer's report: -</p> <ul style="list-style-type: none"> <li>(i) the contents of the report, be noted;</li> <li>(ii) a recommendation to Council that £1m be set-aside in an earmarked reserve as a contingency to meet any short to medium-term financial implications arising from the Brexit process (funded from the £20.08m unallocated reserves identified in the 'Update on Reserves' report that was presented to the Policy and Resources Scrutiny Committee on the 15th January 2019), be endorsed;</li> <li>(iii) a recommendation to Council that delegated powers be granted to the Leader and Interim Chief Executive to jointly approve expenditure from the earmarked reserve as and when required, be endorsed;</li> <li>(iv) both Leaders from the Opposition Groups be invited to join the recently established internal Brexit Working Group;</li> <li>(v) any emergency spends authorised under delegated powers will be reported retrospectively to the appropriate Committee.</li> </ul>
