SUBJECT: MUSIC SERVICE

REPORT BY: CORPORATE DIRECTOR, EDUCATION AND CORPORATE SERVICES

1. PURPOSE OF REPORT

1.1 To provide Members with an overview of Caerphilly Music Service and to provide a summary of key strengths and priorities for improvement that are identified as a result of the self-evaluation process.

2. SUMMARY

2.1 There is a range of evidence to indicate that the music service provides an effective contribution to the attainment and achievement of all pupils and provides value for money.

3. RECOMMENDATIONS

3.1 That Members note the contents of the report.

4. REASONS FOR THE RECOMMENDATIONS

4.1 To ensure members are informed of the improvement and priorities identified by Caerphilly Music service through self-evaluation processes.

5. THE REPORT

- 5.1 Introduction
- 5.1.1 The music service undertakes the following duties:
 - Provides subsidised music tuition for individuals, small groups and whole classes to all schools across the Local Authority.
 - Provides free instrument loans to all pupils.
 - Offers free access to county ensemble groups in collaboration with Bridgend, Rhondda Cynon Taf and Merthyr Local Authorities.
 - Provides weekly instrumental and vocal ensembles at no cost to pupils.
 - Where capacity in schools is limited, the music service provides additional support to pupils with both the practical and theory elements of GCSE and A-Level music examinations.

- Offers a programme of whole class vocal and instrument tuition across a range of disciplines including brass, percussion, woodwind and strings. This allows pupils in participating primary schools to have the opportunity to learn one discipline for at least one term and in some schools for an academic year.
- Provides performance opportunities in a range of venues including Llandaff Cathedral, St Woolos Cathedral, St David's Hall and the Royal Albert Hall.
- Provides continuing professional development opportunities for teachers across Caerphilly.
- Provide bursaries for more able and talented pupils to attend the Junior Conservatoire at the Royal Welsh College of Music and Drama.

5.2 How has the music service improved over the last twelve months?

- Increased leadership capacity has improved the quality of service. The LA Strategic Lead
 for School Improvement remains the Head of Service. However, two management
 positions have been created that provide better models of distributed leadership.
- All staff undertook a programme of continuing professional development to further enhance their skills. Shadowing opportunities were provided to enable all staff to reflect on their practice and consider opportunities to further improve.
- Planning, preparation and assessment time (PPA) was reorganised to increase the opportunities to share best practice amongst staff.
- All staff have received training on the revised 'Professional Standards for Teaching and Leadership' (2017) to ensure that all are aware of expectations within the role and the ambition and aspiration within Caerphilly Music Service.
- A programme of induction was implemented for new members of staff to ensure that there
 is robust and consistent guidance and support.

5.3 How good is provision provided by the music service?

- Caerphilly Music service currently teaches approximately 1350 pupils in individual and group lessons each week. In addition, approximately 885 pupils currently participate in whole class delivery of lessons. This equates to a total of 2235 pupils currently accessing music tuition from Caerphilly Music Service on a weekly basis.
- In 2018/19, schools were provided with £215680.06 of free tuition for the academic year via a subsided service level agreement. There has been an increase in the number of hours requested by schools in the last financial year, indicating satisfaction with the service.
- Verbal feedback from Head teachers has been very positive.
- There has been an increase in the number of Caerphilly pupils attending the 4 Counties ensembles.
- Lesson observations, undertaken recently, indicates that the quality of teaching is identified overall as 'good'.

5.4 How does Caerphilly Music Service impact on pupil attainment?

- Associated Board and Trinity Guildhall examinations organised by Caerphilly Music Service in 2017-18 had a 98.5% pass rate. Appendix 1 identifies the range of grades achieved by pupils.
- Although the music service does not deliver GCSE and A Level across the Local Authority, many tutors provide additional support for a range of practical and theory lessons. In 2018:
 - There was a 4.76pp increase in the number of pupils achieving A-E in music GCSE.
 Trends over three years indicate an increase in the percentage of pupils, entered for music GCSE, achieving A-E. 93.55% for 2016, 95.24% for 2017 and 100% for 2018.
 - There was a 22.95pp increase in the number of pupils achieving A-C in music GCSE. Trends over three years indicate an increase in the percentage of pupils, entered for music GCSE, achieving A-C. 80.65% for 2016, 61.90% for 2017 and 84.85% for 2018.

- There was no increase or decrease in the number of pupils achieving A*-A in music GCSE.
- Trends over three years indicate an increase in the percentage of FSM pupils, entered for music GCSE, achieving A-E. 50% in 2016, 100% in 2017 and 100% in 2018. Trends over three years indicate an increase in the percentage of FSM pupils, entered for music GCSE, achieving A-C. 50% in 2016, 66.67% in 2017 and 2018.
- 5.5 Current actions to improve the quality of service provided by Caerphilly Music Service.

The operational plan is reviewed on a termly basis and updated annually. It is an accurate evaluation of progress and required actions for improvement for the service. Current targets are as follows:

- Improve tracking and monitoring of data with reference to FSM pupils. Make effective use
 of the data to improve performance of this vulnerable group.
- Support self-evaluation processes by undertaking extensive stakeholder survey. Use the
 outcome of stakeholder engagement activities to ascertain strengths and areas for
 development within Caerphilly Music service.
- Improve the quality of teaching and learning with specific focus on the teaching of skills.
