SUBJECT: STANDING CONFERENCE (AGREED SYLLABUS)

A PURPOSE OF REPORT

To inform Members of the requirements to review the agreed syllabus on a five yearly basis.

B BACKGROUND

The aim of this Standing Conference is to review and re-adopt the 2008 agreed syllabus for religious education. The agreed syllabus sets out the requirements that schools should follow in order to meet statutory requirements. In June 2013 Standing Conference endorsed the readoption of the Caerphilly Agreed Syllabus for Religious Education with an understanding that the syllabus would be reviewed once further information is received in relation to the assessment and national curriculum review.

SACRE has been updated on a termly basis of developments with the National Curriculum review and the development of the Humanities curriculum. Schools should follow the current agreed syllabus until further notice. It is prudent at this time for all Standing Conferences across Wales to re-adopt the existing Agreed Syllabus, given that the new curriculum is not due to be implemented until 2022.

C RECOMMENDATION

For Standing Conference Members to consider re-adopting the current agreed syllabus until the implementation of the new curriculum in 2022.
