#### 1 TO RECEIVE APOLOGIES FOR ABSENCE.

Apologies for absence were received from Councillors D.W.R. Preece and D. Hardacre. It was noted that Councillor M. Adams was attending as substitute for Councillor D.W.R Preece.

#### 2 DECLARATIONS OF INTEREST.

Councillor W. David sought advice in relation to the need to declare an interest as the Head Teacher of the school associated with this application was a close relative, however the applicant was not known to him. The Head of People Services advised that as the applicant was not know to him and was employed by the Infrastructure Division not the school there was no need to declare but this was a matter for the individual member.

Councillor W. David wished it to be noted that he declared a personal but not prejudicial interest for the reason stated.

4 APPLICATION FOR EARLY RETIREMENT BY MUTUAL CONSENT ON GROUNDS OF BUSINESS EFFICIENCY IN THE INFRASTRUCTURE DIVISION, COMMUNITIES DIRECTORATE.
