Land for Sale at Pontymister Industrial Estate.	<p>Considered by Environment and Sustainability Scrutiny Committee on 17th September 2019.</p> <p>RESOLVED that for the reasons contained in the Officers Report:</p> <ul style="list-style-type: none"> <li>i) the sale of the land to the owners of the adjoining Pontymister Industrial Estate be agreed, subject to planning consent and “stopping up” the highway and otherwise on terms to be agreed to enable the construction of a ‘drive thru’ for Costa Coffee;</li> <li>ii) that the approval of terms of sale of the land be delegated to the Interim Head of Property Services in consultation with the Cabinet Member for Homes and Places.</li> </ul>
