MINUTES OF THE MULTI-LOCATIONAL MEETING HELD AT PENALLTA HOUSE AND VIA MICROSOFT TEAMS ON THURSDAY 14TH JULY 2022 AT 5.00 P.M.

RECORDING AND VOTING ARRANGEMENTS

The Chair reminded those present that the meeting would be live-streamed and a recording made available to view via the Council's website, except for discussions involving confidential or exempt items - [Click here to view](#). The Committee was advised that voting on decisions would be taken via Microsoft Forms.

1. TO APPOINT A CHAIR FOR THE ENSUING YEAR

It was moved and seconded that Councillor M. Chacon-Dawson be appointed as Chair. By way of Microsoft Forms (and in noting there were 8 votes for, 0 votes against and 0 abstentions) this was agreed.

RESOLVED that Councillor M. Chacon-Dawson be appointed as Chair of the Grants to the Voluntary Sector Panel for the ensuing year.

2. TO APPOINT A VICE CHAIR FOR THE ENSUING YEAR

It was moved and seconded that Councillor T. Heron be appointed as Vice Chair. By way of Microsoft Forms (and in noting there were 10 votes for, 0 votes against and 0 abstentions) this was agreed.

RESOLVED that Councillor T. Heron be appointed as Vice Chair of the Grants to the Voluntary Sector Panel for the ensuing year.

3. APOLOGIES

Apologies for absence were received from Councillors P. Cook, J. Rao, J. E. Roberts and J. Taylor, together with S. Harris (Head of Financial Services and Section 151 Officer).

4. DECLARATIONS OF INTEREST

There were no declarations of interest received at the commencement or during the course of the meeting.

5. MINUTES – 3RD MARCH 2022

It was moved and seconded that the minutes of the meeting held on 3rd March 2022 be approved as a correct record.

RESOLVED that the minutes of the Grants to the Voluntary Sector Panel held on 3rd March 2022 (minute nos. 1 – 4) be approved as a correct record.

6. APPLICATIONS FOR FINANCIAL ASSISTANCE

The Policy Officer presented the report to inform the Grants to the Voluntary Sector Panel of the applications for financial assistance received between 1st February and 31st March 2022, relating to the 2021/22 financial year and the applications for financial assistance received between 1st April and 31st May 2022, relating to the 2022/23 financial year. Panel views were sought on an application for financial assistance from an organisation which did not meet the General Criteria.

The Panel was also informed of the applications for Welsh Church Acts Fund received between 1st February and 31st March 2022, relating to the 2021/22 financial year and the applications for Welsh Church Acts Fund received between 1st April and 31st May 2022, relating to the 2022/23 financial year. Panel views were sought on one application from an individual in relation to the Welsh Church Acts Fund.

Members were advised of the budget allocations for the Voluntary Sector budget. Details of the applications received and approved by the Head of Financial Services and S151 Officer under delegated powers between 1st February and 31st May 2022 were outlined.

A number of concerns were expressed regarding the Grants to the Voluntary Sector Fund, particularly in relation to the amount remaining in the budget, accessing the funding and the level of grants available. A request was made for a review of the application process, and it was suggested that the minimum amount awarded is raised from £100 to £200. During the course of discussion, it was noted that the latest revision of the General Criteria was 15th July 2015 and a further request was made for it to be reviewed. In response, the Policy Officer advised the Panel that the application form will be made available on the Caerphilly County Borough Council website very shortly and the Caerphilly Cares Team will support community groups or individuals in completing the form. It was also agreed that wider promotion of the Grants to the Voluntary Sector Fund would be advantageous. The Policy Officer further clarified that the grant scheme offers very small grants as a contribution towards the running costs of an organisation, there is no formal grant criteria and instead grants are allocated according to a set of 'General Criteria'.

Reference was made to the Welsh Church Acts Fund and a discussion took place surrounding the amount remaining in the budget, the level of grant available and the application process and criteria.

In conclusion to the previous discussions, it was moved and seconded that the principle of establishing a Task and Finish Group to review the criteria and processes for the Grants to the Voluntary Sector Fund and Welsh Church Acts Fund be recommended to S. Harris (Head of

Financial Services and Section 151 Officer). By a show of hands this was agreed by the majority present.

The Panel was referred to Appendix 2 of the report and requested to make a recommendation for approval or otherwise in relation to an application for financial assistance from an organisation which did not meet the General Criteria. In response to a Member's query, the Policy Officer provided clarification and further details on the purpose for which the grant was sought and how much is being sought from or provided by other sources.

Following consideration of the report it was moved and seconded that the recommendations be approved. By way of Microsoft Forms (and in noting there were 8 votes for, 0 votes against and 1 abstention) this was agreed by the majority present.

The Grants to the Voluntary Sector Panel:

- (i) Noted the applications received that met the criteria for Financial Assistance and the Welsh Church Acts Fund, which have already been approved by the Head of Financial Services and S151 Officer under delegated powers, and which are reported to the Panel for information.
- (ii) Made a recommendation for approval in relation to an application for financial assistance from an organisation which did not meet the general criteria. This recommendation to be considered and approved or otherwise by the Head of Financial Services & S151 Officer under delegated powers.

RECOMMENDED to the Head of Financial Services and Section 151 Officer:

To approve the application for financial assistance from Kids Cancer Charity in the sum of £1,650.

The Policy Officer continued to present the report and Members were advised of the budget allocations for the Welsh Church Acts Fund. Details of the applications received and approved by the Head of Financial Services and S151 Officer under delegated powers between 1st February and 31st May 2022 were outlined. A Member drew particular attention to the report which detailed the total Welsh Church Act Funds budget available for 2021/22. The Policy Officer responded to the queries raised and provided clarification on the figures and budget headings.

The Panel was advised that between 1st April and 30th June 2022, one application was received from an individual in relation to the Welsh Church Acts Fund, attached as Appendix 3. Panel Members were asked to consider the application and make a recommendation as to whether to support the application and if so, the level of grant to be awarded. The recommendation will then be considered and approved or otherwise by the Head of Financial Services and S151 Officer under delegated powers.

PUBLIC INTEREST TEST

The Grants to the Voluntary Sector Panel considered the Public Interest Test, in relation to Appendix 3 of the report, and concluded that on balance the public interest in maintaining the exemption outweighed the public interest in disclosing the information.

RESOLVED that in accordance with Section 100(4) of the Local Government Act 1972 the public be excluded from the remainder of the meeting because of the likely disclosure to them of exempt information as defined in paragraph 12 and 14 of Schedule 12A of the Local Government Act 1972.

EXEMPT MATTER

Following consideration of the report it was moved and seconded that the recommendation be approved. By way of Microsoft Forms and verbal confirmation (and in noting there were 10 votes for, 0 votes against and 0 abstentions) this was unanimously agreed.

The Grants to the Voluntary Sector Panel made a recommendation for approval in relation to one application from an individual under the Welsh Church Acts Fund. This recommendation to be considered and approved or otherwise by the Head of Financial Services and S151 Officer under delegated powers.

RECOMMENDED to the Head of Financial Services and Section 151 Officer:

To approve the application from an individual in relation to the Welsh Church Acts Fund.

The meeting closed at 6.20 pm.

1. PURPOSE OF REPORT

- 1.1 To inform the Panel of the applications for Financial Assistance received between 1st June and 30th September 2022.
- 1.2 To inform the Panel of the applications for Welsh Church Acts Fund received between 1st June and 30th September 2022.
- 1.3 To inform the Panel of one application received from an individual in relation to the Welsh Church Acts Fund received between 1st June and 31st October 2022, and to seek a recommendation for approval or otherwise.

2. SUMMARY

- 2.1 The report advises Panel members of the budget allocations for both the Voluntary Sector budget and the Welsh Church Acts Fund budget for 2022/23. It also provides details of applications received and approved by the Head of Financial Services & S151 Officer under delegated powers between 1st June and 30th September 2022.
- 2.2 The report also asks Panel members to consider an application received from an individual in relation to the Welsh Church Acts Fund, and to make a recommendation for approval or otherwise.

3. RECOMMENDATIONS

- 3.1 Panel members note the applications received that meet the criteria for Financial Assistance and the Welsh Church Acts Fund, which have already been approved by the Head of Financial Services & S151 Officer under delegated powers, and which are reported to the Panel for information.
- 3.2 Panel Members make a recommendation in relation to an application received from an individual in relation to the Welsh Church Acts Fund. This recommendation will be approved under delegated powers by the Head of Financial Services/S151 Officer.

4. REASONS FOR THE RECOMMENDATIONS

- 4.1 To ensure that the applications received under this report are determined in accordance with the Council's scheme of delegation criteria.

5. THE REPORT

5.1 GRANTS TO THE VOLUNTARY SECTOR BUDGET

- 5.1.1 The Grants to the Voluntary Sector budget for 2022/23 is shown in the table below:

- 5.1.2 The projected Discretionary Rate Relief for 2022/23 is **£187,367**, which leaves a budget of **£8,319** available for 2022/23. Allowing for the projected spend on Discretionary Rate Relief, the available balance for schemes is **£119,201.67**, which includes carry forward balances.

- 5.1.3 Between 1st June and 30th September 2022, 33 new General Criteria awards have been made totalling **£5,330**. These have been approved by the Head of Financial Services & S151 Officer under delegated powers and are reported to the Panel for information only. The awards are summarised in the table below:

5.1.4 No applications were received between 1st June and 30th September 2022 which were outside the General Criteria.

- 5.1.5 After the awards detailed in the table above have been considered, the amount remaining in the current financial year is **£110,081.67**.
- 5.1.6 As previously agreed by the Panel, grants awarded during the 2022/23 financial year that exceed the budget allocation will be funded from the brought forward balances.

5.2 WELSH CHURCH ACTS FUND

- 5.2.1 The total Welsh Church Acts Fund budget available for 2022/23 is **£247,003.32**. This consists of the annual allocation from Monmouthshire County Council (**£57,760**), unallocated sums from previous years (**£105,175**) plus an additional **£80,836.45** held by Monmouthshire County Council in relation to previous unallocated underspends.
- 5.2.2 In addition, since the last Panel meeting a project previously approved in 2020-21 (RCK UK Risca Covid Group **£3,231.87**) will not be progressing, so the value of this award has been recycled back into the funding pot.

**SUBJECT: APPENDIX 2 – APPLICATION FROM AN INDIVIDUAL IN RELATION TO THE WELSH
CHURCH ACTS FUND**

REPORT BY: HEAD OF LEGAL SERVICES AND MONITORING OFFICER

I have considered grounds for exemption of information to be presented to the Committee and make the following recommendations to the Proper Officer:-

EXEMPTIONS APPLYING TO THE REPORT:

Information relating to a particular individual(s) – paragraph 12 Schedule 12A Local Government Act 1972.
Information relating to the financial or business affairs of any particular person – paragraph 14.

FACTORS IN FAVOUR OF DISCLOSURE:

There is a public interest in the way in which the Council awards its grant funding.

PREJUDICE WHICH WOULD RESULT IF THE INFORMATION WERE DISCLOSED:

The report contains detailed personal and financial information relating to a particular individual.

MY VIEW ON THE PUBLIC INTEREST TEST IS AS FOLLOWS:

That paragraphs 12 and 14 should apply. My view on the Public Interest Test is that whilst there is a need to ensure transparency and accountability of a Public Authority for decisions taken in relation to the award of grant funding, this must be balanced against the fact that these matters have not yet been concluded and there is a reasonable expectation of an individual that personal and financial information will remain private. It is considered that this outweighs the need for the information to be made public.

The information is not affected by any other statutory provision which required the information to be made publicly available.

On that basis I feel that the public interest in maintaining the exemption outweighs the public interest in disclosing the information. Members are asked to consider this factor when determining the public interest test, which they must decide when considering excluding the press and public from the part of the meeting when it considers Appendix 2 to the report.

RECOMMENDED DECISION ON EXEMPTION FROM DISCLOSURE:


On that basis I feel that the public interest in maintaining the exemption outweighs that in disclosing the information, and that the report should be exempt.
