# MINUTES OF THE MEETING HELD AT PENALLTA HOUSE, TREDOMEN PARK ON WEDNESDAY, 26TH NOVEMBER 2014 AT 5.00 PM

# 1. APOLOGIES

Apologies for absence had been received from Councillors Mrs G. Oliver, M. Prew, R. Saralis, Mrs E. Stenner and Mrs J. Summers.

# 2. DECLARATIONS OF INTEREST

D. Roberts, Councillors A. Higgs and K. Lloyd declared an interest in Appendix 2 – General Criteria Awards. Councillors L. Ackerman and K. Lloyd declared an interest in Appendix 5 – Welsh Church Fund Grants Withdrawn. Details are minuted with the respective item.

## 3. MINUTES - 16TH JULY 2014

The Panel received and approved the minutes of the Grants to the Voluntary Sector Panel held on 16th July 2014 (minute nos. 1 - 7).

The Panel were asked to note that the Parent Network had not responded to the Panel's queries.

#### 4. DISCRETIONARY RATE RELIEF

Mr S. Harris, Interim Head of Corporate Finance, provided the Panel with an update on the Discretionary Rate Relief Policy.

The Council is able to assist a wide range of voluntary and sporting organisations by granting rate relief. Under the Council's Scheme of Delegation, applications for discretionary rate relief submitted to the Council are determined by the Council's Head of Corporate Finance. The determination is exercised following consideration of the Council's Policy on discretionary rate relief supplemented by guidance from Welsh Government and Central Government.

Mr Harris explained that the current Policy is being reviewed and that a report will be presented to the Policy & Resources Scrutiny Committee in January 2015, prior to consideration by Cabinet in February 2015. Due to the need to serve notice, any agreed changes to the Policy would be effective from April 2016. The Panel were assured that they would be consulted throughout the process.

The draft savings proposals for 2015/16 agreed by Cabinet on the 29<sup>th</sup> October 2014 include a proposed £30,000 reduction in the GTVS budget. As any savings arising from the change in the Discretionary Rate Relief Policy will not be realised until April 2016, Mr Harris proposed that grants awarded by the Panel during the 2015/16 financial year should be funded from previous years underspends.

The Panel were in agreement with the proposal and thanked the officer for the update.

# 5. Statement of Expenditure

Members noted the available budget for 2014-2015 together with the total amounts requested, as detailed within the report.

#### 6. Welsh Church Act Fund

Councillor L. Ackerman and K. Lloyd declared a personal interest in Appendix 5 - Friends of the Navigation, due to having involvement with the organisation.

The report highlighted that Caerphilly County Borough Council has received written confirmation that the 2014/2015 budget allocation is £40,084.00. Monmouthshire County Council have confirmed that the underspends from previous years of £132,720.00 can be carried forward, resulting in a total available budget for the current year of £172,804.00. Members noted that it has been highlighted that due to the present economic climate, allocations in the future could be reduced considerably due to declining returns on investments

Members noted the Welsh Church Act Fund applications received and approved by officers since the last meeting in accordance with the agreed criteria as set out in Appendix 3. The total allocated amounts to £4,000.00.

Members' attention was directed to Appendix 5, which provided a breakdown of applications that have exceeded the 18-month time limit to claim funding as set out in the terms and conditions. Members noted this amount totalled £4,400.00 and that the applicants have received notification that the grant has now been withdrawn. Officers highlighted that the Friends of the Navigation have requested a new application for this fund.

Members noted the process and the information contained within the report.

### 7. Applications for Financial Assistance: Panel Awards

Members were asked to consider the applications listed in Appendix 1 to the report and to make appropriate recommendations to the Interim Head of Corporate Finance for approval.

# **GRANTS TO THE VOLUNTARY SECTOR PANEL – 25TH MARCH 2015**

### 1. PURPOSE OF REPORT

- 1.1 To present the Panel with the applications for financial assistance received to date for the current financial year.
- 1.2 To provide details of indicative budget allocations for the 2015/16 financial year.

# 2. SUMMARY

2.1 The report advises Panel members of the budget allocations for both the Voluntary Sector budget and the "Welsh Church Fund" and provides details of applications received.

# 3. LINKS TO STRATEGY

3.1 Voluntary and Community Sector organisations make an important contribution to public service provision across the borough and are key participants in the Community Strategy implemented through the Single Integrated Plan Caerphilly Delivers. The Single Integrated Plan has the following priority outcomes: Prosperous Caerphilly; Safer Caerphilly; Learning Caerphilly and Healthier Caerphilly.

#### 4. REPORT

# 4.1 Assistance To Voluntary Sector Budget

4.1.1 The Panel's budget for 2014/2015 is as follows:-

Less Discretionary Rate Relief (Estimated)	£223,095.00

Carry forward balance from 2013-14	£83,258.00
Total Budget 2014-15	£115,383.00

- 4.1.2 The Discretionary Rate Relief for 2014-15 is now forecast to be £223,095.00; this is a decrease from the last panel meeting projections of some £11,830.00. This now leaves a projected budget allocation of £32,125.00for Grants to the Voluntary Sector. Together with the carry forward from previous years of £83,258.00 this gives a total budget allocation of £115,383.00. To date grant awards for 2014/15 total £15,035.00. Budget remaining for allocation is £100,348.00.
- 4.1.3 The total amount requested in respect of the applications listed in Appendix 1 is £2,740.00 (3 No.). These applications do not meet the revised criteria agreed by Panel at the July 2015 meeting, as set out in Appendix 4. Panel Members are asked to consider these applications and make appropriate recommendations to the Interim Head of Corporate Finance for approval under delegated powers.
- 4.1.4 Appendix 2 details those applications that meet the criteria out set in Appendix 4 that have been approved by officers (but not actioned). These total £7,720.00 (45 No.).
- 4.1.5 The balance remaining if all grants requested are awarded as set out in Appendix 1 and Appendix 2 will be £89,888.00. This balance will be now be carried forward to 2015/16 financial year.
- 4.1.6 Any further applications received before the 31<sup>st</sup> March 2015 will now be considered in the 2015/16 financial year.
- 4.1.7 The indicative budget allocation for 2015/16 has been agreed at £229,048, of which the projected Discretionary Rate Relief is £228,592. This leaves a projected budget allocation of £456 (which will increase by the final balance to be carried forward from 2014/15).

4.1.8 As previously agreed by the Panel grants awarded during the 2015/16 financial year will be funded from the brought forward balances.

#### 4.2 Welsh Church Act Fund

- 4.2.1 At previous meetings of the Panel it was decided that the following criteria would apply when considering applications for assistance from the Welsh Church Fund:-
  - (i) A grant of no more than £2,000 to be given to partly fund projects of £6,000 and over;
  - (ii) Smaller projects less than £6,000 be grant aided up to a third of the total cost;
  - (iii) All organisations receiving grants produce the necessary financial records to show the expenditure has been incurred;
  - (iv) No organisation is allowed to apply in consecutive years.
- 4.2.2 At the meeting of 13<sup>th</sup> July 2009 Members agreed that in future, officers would approve applications meeting the Welsh Church Act Fund Criteria, using delegated powers. Such decisions would then be reported to the Panel for information, where Members could ask for further information if required.

4.2.3 Caerphilly County Borough Council has received written confirmation from Monmouthshire CC that the 2014/15 budget allocation will be £40,084.00. Monmouthshire CC have confirmed that the underspends from previous years of £132,720.00 can be carried forward, resulting in a total available budget for the current year of £172,804.00.

- 4.2.5 No further grant awards have exceeded the 18 month time limit to claim funding as set out in the Terms and Conditions.
- 4.2.6 We have been advised by Monmouthshire County Council that the provisional allocation for 2015-16 will be £49,334 i.e an increase of £9,286 on this year's allocation. We have also been advised that we will be allowed to carry-forward the unspent allocations.
