Myself and the two other ward councillors are trying to reinvigorate how we engage with our residents, we've set up a website, we will soon be printing a quarterly leaflet and we'll be opening monthly surgeries in the Blackwood St John Ambulance Hall. Our surgeries will also be open to people who don't need advice and we aim to create an environment where residents can come for a chat and a cup of tea just to put the world to rights if need be.

I have not kept a full record of my casework for the year; however I've advocated a number of enquiries for residents to the council and the list is pretty extensive. From nuisance neighbours, to sinks falling off the wall, pot holes, bushes needing trimming, dead road kill etc.

There has also been 2 occasions where I have advocated for individuals outside of matters

of the councils remit.

Following a serious incident that happened on my estate and to reassure residents myself and the local police inspector organised a street surgery.

In Palmer Place I've worked with the residents to combat anti-social behaviour and organised a street surgery. I've also posted advice letter to direct the resident to ring their local area housing office and 101.

I've raised a total of £300 for a local autism group and a further £100 for the Rainbows and Brownie Group.

Currently I am going to support residents in their representations against the proposed closure of Cefn Forest Leisure Centre and the building of houses on Cwm Gelli.

Finally Nigel Dix, Pat Cook and myself want to do something special for Blackwood and together with the local community we hope to bid for funding to bring a social enterprise to the town that will provide the community with a social hub, possibly better access to the credit union, affordable produce and other locally sourced goods and a food bank for those in need. Hopefully this will be open by 2017.
