CONSTITUENCY ACTIVITY

Have worked with my fellow Ynysddu Ward Councillor on the following:

- ► Held joint Police and Councillor Street Surgeries through the valley.
- ▶ Published regular newsletters to constituents, which have been hand-delivered throughout the valley.
- ► After fighting for many years for a drainage scheme throughout the valley the £210k drainage scheme for the back of Glen View Terrace is now completed.

- ▶ Initiated and continue to hold an annual Flood Prevention Committee for residents of 'Over the Bridge' Ynysddu as this low lying ground needs regular maintenance to the flood defences and the best people to make sure this happens is the ones who live there.
- ▶ Reconvened and continue to ensure an annual meeting is held to monitor and receive regular updates on a quarry above Ynysddu in which industrial waste was deposited back in the 1950's.
- ► Worked with local residents to organise play activities throughout the summer in the valley. Also, free tennis during the summer holidays on the Ynysddu tennis courts.
- ► Worked with parents and Primary school to fight withdrawal of the free primary school bus from Wattsville to Cwmfelinfach. This issue is still ongoing!
- ▶ Residents complained of 'flicker' from the newly installed wind turbine overlooking Ynysddu and Cwmfelinfach. Highlighted this in the Councillors newsletter and asked for residents to come forward with their experiences. As a result, residents came forward and Council officers are now investigating.
- ▶ Listened to residents when they objected to the loss of the flowerbeds on the green in Ynysddu when they had been grassed over. Their suggestion that wildlife friendly flowers and trees be planted was forwarded to the appropriate Council department and this is now being done.
- ▶ Met with residents to discuss the candidate site submissions for the Local Development Plan (LDP) to build houses around our villages. Held village meetings in Wyllie and submitted my objections to the housing proposals.
