### CONSTITUENCY ACTIVITY

Some examples of constituency activities are below:

I am working with Officers of the Council, Cllr Colin Mann and Members of the Llanbradach Partnership to try and have lighting installed under the railway bridge on Station Road.

I am working with Cllr Colin Mann and the Aneurin Bevan Health Board to try and build a new health centre in the village.

Working with Cllr Colin Mann and officers of the council to install a children's play area at Plasturtwyn playing field.

I am trying to resolve issues of dumping of rubbish in rear lanes also the parking of vehicles on the highway for advertising purposes.

Working to resolve issues with increased numbers of untaxed vehicles parked on village streets. I am also trying to deal with residents complaints relating to illegal parking of vehicles on double yellow lines and crossing zig zag markings as this is an ongoing issue of concern.

Still working on registration of footpath from Coedybrain to Graddfa Road. Refurbishment of section of footpath south of entrance of Lonyrafon.

Also dealing with complaints of people throwing dog litter bags into brambles and hedgerows instead of placing them in dog litter bins.
