SUBJECT: KEY STAGE 4 / KEY STAGE 5 PERFORMANCE 2017

#### 1. PURPOSE OF REPORT

1.1 To inform Members of pupil performance at Key Stage 4 (Age Range 14-16) and Key Stage 5 (Age Range 16-18).

#### 2. SUMMARY

2. 1 This report presents Members with the final published 2017 performance data for key stage 4 and 5.

## 3. LINKS TO STRATEGY

- 3.1 The attainment results published in this report contribute towards the following Well-being Goals within the Well-being of Future Generations Act (Wales) 2016:

- 3.2 This is because 'a prosperous Wales' is about developing a well-educated and skilled population and 'a more equal Wales is defined as a 'society that enables people to fulfil their full potential no matter what their background or circumstances, education attainment is a part of fulling that potential.

# 4. **KEY STAGE 4 (AGE RANGE – 14-16)**

4.1 At Key Stage 4, the following key performance measures are used to evaluate and compare the full range of achievement within and across local authorities:

- 4.2 This year it is not possible to meaningfully compare regional or local authority results to previous years. This is due to significant revisions to examinations that means they focus in part on different skill sets and knowledge than in previous years. Despite this the region is already working with schools to track individual pupil performance over time. This will mean that school leaders and our local authorities are well positioned to gauge where schools are progressing well or where they may need additional support.
- 4.3 Communications from the examination awarding body and the regulator throughout this academic year indicated that this variability was to be expected, and this is reflected in regional results. As in previous years we have been talking to post-16 providers to ensure that no learner is disadvantaged and that they are provided with appropriate pathways following results.

## 4.5 Level 2 threshold inclusive of English/Welsh and Maths

The proportion of pupils achieving the Level 2 threshold inclusive of English/Welsh first language and mathematics is now 49.9%. Last year performance at this measure was 53.0%, so there has been a drop of 3.1pp. Across Wales performance fell by 5.6pp to 54.6%.





## 4.6 Performance against Targets

Schools set statutory targets in the Autumn term each year. During the year secondary schools report the progress they believe learners are making towards achieving target on 3 occasions. The last collection is in June. When comparing results against June predictions, out of the 13 secondary schools in Caerphilly, four schools performed in line or above prediction, two reported performance more than 10 percentage points (pp) below June prediction. Six schools reported performance within 5 pp of their June estimates (46%).

## 4.7 Free School Meals (FSM) Pupils - L2 inclusive threshold performance

- 4.8 L2 inclusive threshold performance of FSM pupils in 2017 has declined by 5.6 pp to 24.5%. The FSM/non FSM gap has widened by 0.8 pp. In comparison, the national FSM average declined by 7 pp from 35.6% to 28.6%, and the gap has also widened, so Caerphilly FSM gap is narrower than across Wales.
- 4.9 There were 4 schools with improved FSM performance this year.
- 4.10 There were declines at all indicators except for 5A\*/As. All indicators are still below the Wales average.







## 4.11 Gender Differences


The gender gap in Caerphilly has fluctuated over the past 5 years, and for the Level 2 threshold inclusive of English/Welsh first language and mathematics is now 12.8 percentage points, an increase from 11.8 percentage points in 2016, and remains above the Wales average of 8.1 percentage points. Performance of both boys and girls declined from 2016, but boys declined by more than girls.

# 4.12 Performance of eFSM / non-eFSM Pupils

The FSM/non FSM gap widened in 2017 for the Level 2 threshold inclusive of English/Welsh first language and mathematics from a 30.8pp gap in 2016 to a 31.6pp gap in 2016, which is below the Wales average of 32.4pp. The gap is still wider than it was in 2013 & 2014.

## 4.15 Free School Meal Benchmark Summary

When FSM benchmark data is used to compare the performance of similar schools, the number of Caerphilly schools above the median has increased for all indicators and subjects except Welsh 1<sup>st</sup> language and science. There is only one Welsh medium secondary school, and performance has been in quarter 4 in each of the past 3 years. The number of schools in the bottom quarter has increased for science.



Individual school benchmark performance is presented in Appendix A.

## 4.16 Welsh Government Modelled Expectation

Caerphilly exceeded the LA benchmarks for performance modelled on FSM entitlement and actual performance at the Level 2 threshold including English/Welsh and mathematics. For capped point 9 Caerphilly narrowed the gap to 4.1 points below the expected achievement.

- When vocational qualifications are taken into account and the Welsh Government's main indicator of post-16 performance, the Level 3 threshold, is considered, performance decreased slightly from 97.1% to 96.6%.
- This 0.5pp decrease is narrower than the 1.5pp decrease across the EAS region, and 0.9pp across Wales.

#### 5. WELL-BEING OF FUTURE GENERATIONS

- 5.1 This report content (Education attainment) contributes to the Well being Goals as noted and explained in 3.1.
- This report is for information only and so does not analyse the 5 ways of working in terms of decision making but it does recognise that going forward interventions that are put in place to improve attainment must take a **long term** view as part of its impact on life chances, employment and quality of life. One of the principles of the 5 ways of working is to look at how we can **prevent** problems occurring and to do this we need to understand what the causes are. Causes within attainment are complex although one of the main ones is deprivation. The measure that is commonly used to measure deprivation is a pupil's eligibility to receive Free School Meals. The data provides an insight into the performance of all pupils in comparison to the pupils in receipt of Free School Meals and the gap in performance increases throughout school life (para 4.7). One of the Council's Well-being Objectives is to 'Improve outcomes for all learners but we want to particularly focus on those vulnerable to underachievement. We have an action plan to achieve this and it we will **involve and collaborate** with a range of partners such as schools, parents, governors and children to raise aspiration and attainment.

#### 6. EQUALITIES IMPLICATIONS

6.1 There is no specific equalities impact in relation to the content of this report. When performance information is discussed with schools as part of the monitoring, challenge, support and intervention programme, equalities issues, such as gender and ethnicity are taken into account.
