consort, Councillor Mike Adams and his wife for acting as his deputy and for their support over the last twelve months. Particular thanks were paid to the Civic Office Team for their patience and hard work. In concluding his address Councillor Bevan thanks all those who supported his charity appeal for Cancer Research Wales and CRY in memory of Jack Thomas which had raised £7,000 to date.

# 11. LEADER OF THE MAIN OPPOSITION GROUP - COUNCILLOR C.P. MANN

It was noted that Councillor C.P. Mann will receive a senior salary payment as Leader of the main opposition group.

## 12. LEADER'S STATEMENT

Councillor D.V. Poole as part of his statement presented a video montage which outlined some of the 600 plus services that this Council delivers, every hour of every day.

He paid tribute to the scale and variety of services delivered to residents in the face of significant budget cuts, increasing demands and expectations upon limited resources. The positive impact that had been made over the past 12 months making our communities better places to live, work and visit was acknowledged and he placed on record his thanks to the hard working staff of Caerphilly County Borough.

Councillor Poole referenced the Corporate Plan recently approved by Council and the key priorities set out within that document. These priorities would be underpinned by a suite of Cabinet Commitments and the Medium Term Financial Plan principles in order to achieve a resilient and sustainable Council going forward. The challenges of austerity and the tough financial times ahead were referenced and assurances given on the commitment of Cabinet to drive this agenda forward and turn these principles into actions.

This commitment included engagement events such as the recent staff roadshows delivered by the Interim Chief Executive. These roadshows gave staff the opportunity to find out more about future plans and the pivotal role each and every staff member has in shaping them. Councillor Poole referred to recent key senior management appointments and emphasised the importance that they would play in ensuring the continued provision of high quality public services for the future. In recognising future provision he recognised the need to rethink the way in which services will be delivered and to this end a programme of conversations with communities would be undertaken in the next year.

Educational attainment was confirmed as one of the key priorities over the next twelve months. Therefore a Board would be set up over the next few months to provide additional pace and focus on the improvement that is needed. The 21st Century Schools Band B proposals would see a further £110m of investment in schools over the next 7 years delivering huge benefits across the county borough. He pledged his commitment to securing greater equity of quality of life across the county, closing the gap between poverty and prosperity.

Regional working would also be a priority and Members were advised that the Cardiff Capital Region City Deal continues to make good progress and assured them that he would continue to ensure that Caerphilly's voice is heard in the discussions between the 10 partner authorities. Housing and the WHQS programme would continue to be a focus and it was noted that to date over 75% of internal works and over 40% of external works have been completed and the 2020 target for completion remains fully achievable.

In relation to sports and leisure the Leader reference the ambitious Sport and Activity Strategy which would set out an integrated approach to promoting wellbeing and physical activity across all communities over the next ten years. In terms of Waste Management it was noted that a review of waste collection services would also be undertaken in order to assure recycling performance and value for money are achieved and sustainable.

Social Services priorities would be to continue to secure positive outcomes for service users maintaining the of care and support provided day in day out as demand increases and funding decreases. Opportunities for collaboration and the implications of new legislation would also be explored in more detail over the next year.

Members were advised that underpinning this ambition programme of change is the Business Improvement Programme focusing on leadership and management, engagement and communication and strategic project development is already making good progress.

In relation to Local Government reorganisation and the new green paper Councillor Poole reaffirmed his commitment to this authority and the message that Caerphilly is a big enough, strong enough and resilient enough to stand on its own and this would very much be the impetus for his discussion the Welsh Government.

In conclusion Councillor Poole accepted that there were challenging but also exciting times ahead for Caerphilly but there would also be difficult decision to make but firmly believed that this authority was well prepared for them.

# 13. CONSTITUTION MATTERS

Consideration was given to the report which outlined matters in accordance with the Council Procedural Rules and provided an update on changes to Part 3 of the Scheme of Delegation, the Report Template and sought delegate authority for the Interim Monitoring Officer to make the necessary changes to the Council's Constitution.

Members were advised that the Council's Procedural Rules require the Annual Meeting to appoint at least one Overview and Scrutiny Committee, a Standards Committee and such other Committees; the Council consider appropriate to deal with matter which are neither reserved to the Council nor are executive functions. It was noted that there are no proposed changes to be made to the current Committee structure, including the number of Members allocated to each Committee; the current arrangements reflect a fair political balance and Members were therefore asked to note existing arrangements. Members were also asked to note that there were no changes to the terms of reference for committees and there has been no change to the political balance of the Authority and therefore committee allocations remain as present.

In terms of the scheme of delegation Members were advised that following consultation with all Heads of Service, minor changes have been attached as at Appendix 1 of the Officer's report and are identified in bold and italics. The changes represent updates regarding legislation together with changes to job titles and responsibility of relevant functions.

In relation to changes to the report template as attached at Appendix 2 of the Officer's report, Members were referred to paragraph 3 of the report entitled Links to Strategy which will now include reference to the Corporate Plan. In conjunction with this proposed change, Officers will develop guidance to sit alongside the new paragraph and will trial the new template for a period of three months prior to full implementation. In addition a conclusion paragraph will be incorporated into the template.

It was moved and seconded that the recommendations in the report be approved. By a show of hands this was unanimously agreed.

RESOLVED that for the reasons contained in the report: -

- (i) the information contained in the report be noted;
- (ii) the recommendations set out at paragraphs 5.2, 6.1, 7.3, 8.2 and 9.2 be approved.

## 14. ELECTRONIC VOTING AT FULL COUNCIL

Consideration was given to the report which sought the endorsement of Council to reintroduce the electronic voting system.

The report had previously been considered by the Democratic Services Committee and Members comments were noted. Mrs Forbes-Thompson (Interim Head of Democratic Services) referred Members to section 1.3 of the report and the procedures contained therein.

In terms of re-introduction of the system the Officer referred to recommendation 2.2 of the report and give consideration to implementing a transition period whereby electronic voting would be introduced incrementally over 4 meetings.

Members welcomed the re-introduction of the system and clarification was sought in relation to which items on the agenda would be subject to electronic voting during the transition period. The Officer confirmed that the last item on the next Council agenda would taken by electronic voting and from then the last two items and so on, after 4 meetings all decision making would be taken using the system.

It was moved and seconded that the recommendation contained in the report be approved. By a show of hands and in noting there was 1 against this was agreed by the majority present.

RESOLVED that for the reasons contained in the report: -

- (i) all meetings of Full Council should utilise the electronic voting system for all votes taken be approved;
- (ii) the procedure agreed by Council on 7th October as detailed within the Officer's report be reinstated;
- (iii) a transition period, whereby the electronic voting is introduced incrementally over 4 meetings be approved.

#### 15. PROPOSED DISSOLUTION OF THE BRYN COMPOST LIAISON GROUP

Consideration was given to the report which sought Council approval to dissolve the Bryn Compost Liaison Group.

The Bryn Compost Liaison Group was established by Council in March 2010 in order to address complaints of odour associated with the In Vessel Composting (IVC) process. The IVC has now been decommissioned and replaced with an Anaerobic Digestion Plant (AD) at the site which eliminated the source of the food waste composting odours. Consequently there is no need to continue with meetings of the Liaison Group.

As a result of consultation with Local Ward Members the report proposes that an informal group be established for a period of twelve months in order to address other concerns raised by local residents. It was noted that the group would be comprised of St Cattwg Ward Members, the Cabinet Member for Neighbourhood Services and relevant Officers.

The Local Ward Members for St. Cattwg welcomed the dissolution of the Liaison Group and cited the improvements made since the introduction of the AD Plant and expressed his hope that issues would finally been resolved. In this regard he was of the opinion that progress could not be achieved without input from the site operator and owner and asked Members to consider an amendment to recommendation 10.2 to invite the operator to attend group meetings.

The Local Ward Member from Nelson supported the recommendations but expressed concern with regard to the impact of the high volumes of traffic and pollution generated by the truck and lorry movements associated with the sites operations which passed through the centre of the village. It was explained that this 'B' road was the main corridor road from the site to the A472 and A470. The Member asked that for the sake of the wellbeing of local residents that the impact on the highway system be taken into consideration for any future expansion or developments.

The Cabinet Member for Economy, Infrastructure and Sustainability shared the concerns raised by the Member and provided assurance that safety measures were being looked at and invited the Member to attend a forthcoming meeting with highways engineering in order to discuss heavy traffic movements.

It was moved and seconded that the recommendations at 10.1 and 10.2 of the report be approved subject to the addition of the site operator/owner to the group's membership and by a show of hands this was unanimously agreed.

RESOLVED that for the reasons given in the Officer's report: -

- (i) the Bryn Compost Liaison Group be dissolved;
- (ii) an informal discussion group be established comprising the St Cattwg ward members, the Cabinet Member for Neighbourhood Services and representative from Bryn Compost and relevant officers for a period of twelve months.
