#### CONSTITUENCY ACTIVITY

These are the issues that I have worked on over the past year many of which are ongoing: -

Anti-social behaviour has been one of the major issues over the last year, with over twenty eight wheelie bins being stolen and burnt. The consequences have a massive impact on the lives of the residents here in Hengoed as the cost to replace these bins falls to them. I am currently working on a project with Gelligaer Community Council, and the local Police, we hope to alleviate the number of these incidents in the near future. I urge residents to report any of these incidents to the police on 101 so that we can monitor and respond.

I have helped with and responded to several issues some of which are listed below.

- 3 Education queries.
- 6 Households reporting anti-social neighbours.
- 1 Abandoned vehicle.
- 5 Housing queries including, repairs and asbestos removal.
- 4 Dog fouling.
- 3 Tree enquiries / issues.

I have facilitated the new access to the welfare playground at Cefn Road, and a dropped pavement at Bryn Terrace for disabled access.

I have been actively campaigning for the completion of the cycle track at Cwm Calon and will keep residents updated as this has been a complicated journey but not without hope of completion.

I have attended two public meetings regarding a proposed housing estate next to Carn Gethin.

I have reported overgrown pavements, hedges and brambles.

This has been my first year as a County Councillor, I have enjoyed my role and although this year has been difficult personally after losing my mother in November and having

pneumonia in June and again at Christmas, I have fulfilled my duties in a timely manner to the best of my ability, with just one regret Mr L you know who you are and I am sorry I did not respond fully to you as promised.
