#### **CONSTITUENCY ACTIVITY**

That is not to say that we can't relook at this issue in the future when economic conditions improve. I continue to volunteer in our community and I remain a trustee for Fleur de Lys Community Centre and the Ecopark and organise Pengam Scale Modellers Club on the first Wednesday of every month. I am very excited about the potential for the Cardiff Capital Region City Deal and what it might achieve for our county borough in terms of improving wellbeing, now and for future generations.
