WARD ACTIVITY

During lockdown I continued carrying out my role as a Councillor, representing my community and providing assistance during a difficult time.

Events

- Helped and supported the Aberbargoed Youth Hanger Community Centre.
- Attended the Aberbargoed Armistice Day and wreath laying event.
- Attended the Aberbargoed Primary School Year 6 Leaver event.

Activities

- I worked with the Area Housing Manager, Deputy Area Housing Manager and the Housing Team to address and resolve 26 issues regarding repairs and various other issues concerning housing.
- I worked closely with the Renovations Manager to address and resolve over 30 issues regarding the Renovations Programme in Aberbargoed.
- During the COVID-19 pandemic, I helped and supported many Aberbargoed residents who are elderly and self-isolating; delivered their shopping and newspapers, attended local Medical Centres on their behalf and worked with the relevant team to have food parcels delivered for those residents in need.
- Together with the housing team and local police we dealt with an issue regarding a property.
- I worked with the relevant team with regard to the renewal of the Blue Clock in Commercial Street which was damaged in a recent winter storm. This is still ongoing.

- I worked closely with our local policing team around a serious issue regarding illegal quad bikes and this issue has now been resolved.
- There was a particular issue where large lorries were parking and blocking access to the residents; this issue has now been resolved.
- There are serious speeding and traffic calming issues in three particular areas of Aberbargoed and these issues are currently under review.
- I worked with the Civil Parking Enforcement Team and resolved various issues concerning illegal parking on double yellow lines in specific areas of Aberbargoed.
- I went door to door around Aberbargoed to encourage Foster Parenting.
- I worked closely with our local Policing Team and the Tenancy Enforcement Team to address numerous issues of criminal activity and anti-social behaviour – all of which have now been addressed and resolved.
