WARD ACTIVITY

During lockdown I continued carrying out my role as a Councillor, representing my community and providing assistance during a difficult time.

Traffic, parking and highways

I have continued to report issues, attend meetings and represent residents' views about parking, traffic and highways concerns, including at Mabon Road, Bwl Road, Shingrig Road and Caerphilly Road. I have provided information to residents on parking enforcement and traffic regulation orders.

Housing

I have assisted individual residents with housing issues, including availability of suitable rental properties, refurbishment works, and issues with neighbouring properties.

Planning and development

I have continued to monitor proposals for the Ty Du site and investigated residents' concerns regarding flooding and future risk of flooding. I met with the chief engineer for drainage and the planning officer and reported back to residents through my Facebook page and other social media channels. Throughout the year I have lobbied for more community involvement in the Ty Du development process. I monitor weekly planning applications received for the Nelson area.

Environment

I have liaised with council officers to arrange for areas of the village to be cleaned-up, cutback and maintained. I continue to report instances of fly-tipping and dumping as and when they occur. Where possible, I continue to raise concerns about Eglwysilan Common.

Community events

As a community councillor, I have continued to help organise and run the regular programme of community council events, including the 2019 fun day, summer show, and children's Christmas event. Since the emergence of covid-19, I've been assisting with arrangements for online meetings, and preparing for the summer show to be run online in 2020.

Education

I am an LEA appointed governor at Llancaeach Juniors and vice chair of governors. During the early part of the year, I regularly attended governor meetings, and various events at the school. Since the covid-19 disruptions, I have liaised with the head teacher and chair of governors to ensure the school has supported pupils and kept parents informed. I keep up to date with educational developments through governor training and the Governors Network.

Council services

During the year I assisted a number of residents with accessing council services and resolving issues. As part of the council's public consultation on the medium-term financial plan, I was in attendance at the Nelson Library council-run session to hear residents' concerns in person, and I ran a separate evening session at the institute for those unable to attend the library. In order to protect Nelson residents' interests more broadly, I ensure that I keep abreast of new developments by regularly attending briefings and seminars on council strategies and proposals.
