4.4 Units not visited by Members during July - September 2014:-

Ty Iscoed Residential Home for Older People, Springfield Community Resource Centre, Brooklands Resource Base, Oaklands Day Centre, Markham Resource Centre, Ebenezer Resource Centre, Retirement Project, Brodawel Resource Centre, Ty Gwilym Residential Respite Care, Caerphilly Day Centre, Min-Y-Mynydd Resource Centre, Tŷ Ni Childrens Home, Castle View Residential Home for Older People, Ty Clyd Residential Home for Older People, Gwerin Resource Base, 14 Graig Road, Ystrad Mynach Resource Base, Twyn Carn Day Centre.

4.5 The following is a sample of comments made by Members for the visits undertaken:-

- 4.5.1 One Member commented "everybody seemed happy and content, fully staffed."
- 4.5.2 One Member observed there was a good range of activities for users but external railings waiting to be painted. The Facilities Team advised that the external railings would be painted in July.
- 4.5.3 Another Member commented "excellent atmosphere at this centre, regular fire drills monthly. Flat kitchen is due to be updated. The Facilities Team advised that the flat kitchen is being updated and likely to be completed by the end of July.
- 4.5.4 One Member commented "wonderful improvement on Heol Aneurin, space and location has made management of the young people so much better."
- 4.5.5 One Member observed that while the building itself is fine, warm and comfortable etc, there is a major problem with access outside the building itself. The Facilities Team have advised that this issue is being progressed by Traffic Management.
- 4.5.6 One Member observed outside room 16 and laundry room needs attention and painting.


 While bedroom 21 required additional equipment and a shower room required upstairs rather than 2 bathrooms. The Facilities Team have now addressed these issues.
- 4.5.7 One Member commented "If I was in a position that my parent needed a residential home I would have no hesitation in placing them at this centre".
- 4.5.8 One Member observed that training and cover for long term sickness of a member of the small management team should be considered. The Service Manager has advised that a Senior Care Officer from Residential Services has been offering support at this home due to sickness absence of the postholder.
- 4.6 For comparison, the rota visits completed in 2013 and the first nine months of 2014 are shown below:-
