

# EDUCATION SCRUTINY COMMITTEE – INFORMATION ITEM

SUBJECT: EDUCATION CAPITAL 2021/22

REPORT BY: HEAD OF EDUCATION PLANNING AND STRATEGY

### 1. PURPOSE OF REPORT

1.1 To inform Members on proposals for the 2021/22 Education Capital Programme, prior to consideration by Cabinet on 7<sup>th</sup> April 2021.

### 2. SUMMARY

2.1 The report identifies proposals for the allocation of Education Capital Budgets for the 2021/22 financial year in the context of the 3 year Capital Programme 2020/21 – 2022/23.

### 3. **RECOMMENDATIONS**

3.1 To inform members on the proposals to utilise the Education Capital Budget for 2021/22 prior to consideration by Cabinet.

### 4. REASONS FOR THE RECOMMENDATIONS

4.1 To ensure members are kept informed of the individual schools identified as part of the 2021/22 Education Capital Programme.

### 5. THE REPORT

- 5.1 Special Council, at its meeting on 20th February 2020 considered its medium term financial strategy 2020/21 2022/23. This included a 3 year forward capital programme for Education.
- 5.2 The proposals for the 2021/22 budget are outlined in detail below. Education colleagues have worked closely with both the Council's Health & Safety and Building Consultancy teams when determining the priority projects.

### 5.3 Additional Accommodation £221k

- 5.3.1 The annual capital allocation of £221k equates to circa 1 additional classroom per annum.
- 5.3.2 A two year investment into the Glanynant Pupil Referral Unit through a double classroom extension and play area was agreed in 2020/21 due to the current and increasing demand for specialist provision requiring an increase to the current capacity.

### 5.4 Asset Management £420k

5.4.1 The following schemes have been identified through consultation with Health and Safety, Property Services and relevant schools:

### 5.8 Revenue/Capital – to be funded from balances

5.8.1 A budget of £333k for the 2021/22 revenue capital balance was included in the draft budget proposals to Cabinet on the 13<sup>th</sup> January 2021 and are subject to approval by Council on the 24<sup>th</sup> February 2021

## 5.8.2 Subject to approval to use these balances, it is proposed to utilise these monies to support schemes funded 50/50 with schools, as below:

### 5.9 **Conclusion**

The above proposals result in uncommitted sums of £174.3K against Health & Safety budget, £8.6K against the Schools Security budget, £4k against Asset Management and £42K against School Boiler budget and £105.5k against the Revenue 50/50.

This will allow for any small project variations and due to Covid and other areas taking priority at present, monies will be kept in the balance as a contingency for any urgent spends or in year projects.

#### 6. ASSUMPTIONS

6.1 The above figures are indicative costs based on input from the Building Consultancy team and Health and Safety. The assumption is made that the actual cost of the works will come in line with the estimates. A contingency has been factored in as part of the uncommitted sums as summarised in 5.9 for any unforeseen factors.

### 8. WELL-BEING OF FUTURE GENERATIONS

- 8.1 The Well-Being of Future Generation (Wales) Act 2015 is about improving the social, economic, environmental and cultural wellbeing of Wales. It requires public bodies to think more about the long-term, working with people and communities, looking to prevent problems and take a more joined up approach. This will create a Wales that we all want to live in, now and in the future. The Act puts in place seven well-being goals:
  - A prosperous Wales.
  - A resilient Wales.
  - A healthier Wales.
  - A more equal Wales.
  - A Wales of cohesive communities.
  - A Wales of vibrant culture and thriving Welsh Language.
  - A globally responsible Wales.
- 8.2 The Act sets out the sustainable development principle against which all public bodies in Wales should assess their decision-making. The aim of the legislation is to ensure the well-being of future generations through maximising the contribution public bodies make towards the well-being goals. In using the sustainable development principle, it is incumbent that the authority considers the whole of the

population it serves and considers the effect of its actions on future generations. The principle, also known as the five ways of working, is assessed below:

- **Long Term** Forecasting of pupil numbers has been utilised to identify the demand for school places to ensure sufficient Educational places in our schools. This information has been used to prioritise schools within the SOP.
- **Prevention** Improving the quality of the Education estate generally will support pupils in their long-term education and skills outcome in that they are more likely to succeed if their Educational experience is positive.
- Integration The 21<sup>st</sup> Century Schools Programme is subject to BREEAM and Community Benefits of individual proposals are assessed and monitored for their impact on the Welsh economy. The proposals are also part of a strategy to promote Welsh Language and Culture.
- Collaboration The 21<sup>st</sup> Century Schools Programme is collaboration between the Council and Welsh Government to improve the quality of the Education estate.
- **Involvement** Through the consultation process the Council will ensure that there is full engagement with all relevant stakeholders, e.g. parents, pupils and the local community. Collaborative partnership working between 21<sup>st</sup> Century Schools and the Early Years Division who work with the voluntary sector.

- 9.1 Many of the initiatives contained within the Education capital budget seek to address equality issues.
