#### WARD ACTIVITY

Over the past year I have continued carrying out my role as a Councillor, representing my community and providing assistance during a difficult time.

### Traffic, parking and highways

I have continued to report issues, attend meetings and represent residents' views about parking, traffic and highways concerns, including at Bwl Road, Shingrig Road, Wern Cresent High Street and Thomas Street. I have provided information to residents on parking enforcement, resident parking permits and traffic regulation orders.

#### Housing

I have assisted individual residents with housing issues, including availability of suitable rental properties, and rodent infestations.

#### Planning and development

I monitor weekly planning applications received for the Nelson area. I have continued to monitor proposals for the Ty Du site and in particular the future risk of flooding. I reviewed proposals for the trial one-way system at Bwl Road and raised residents' concerns about signage and initial problems with the new layout.

#### Environment

I have liaised with council officers to arrange for areas of the village to be cleaned up, cutback and maintained. I continue to report instances of fly-tipping and dumping as and when these occur. Where possible, I continue to raise concerns about Eglwysilan Common.

#### **Community events**

As a community councillor, I have continued to help organise and run the regular programme of community council events, including the 2020 online summer show, and the Halloween,

Christmas and Easter competitions. I've contributed to the proposals to re-open the public toilets, and taken an active part in the recruitment of a new clerk. I have lobbied and liaised with the Health Board to correct an oversight whereby Nelson had not received the Clinical Futures booklet. I have been assisting with arrangements for online meetings and keeping the council's Facebook page updated.

## Education

I am an LEA appointed governor at Llancaeach Juniors and vice chair of governors. I have regularly attended governor meetings. I keep up to date with educational developments through governor training and the Governors Network. I continue to monitor proposals for the new school building and merger of the infants and junior schools.

## **Council services**

During the year I assisted a number of residents with accessing council services and resolving issues. In order to protect Nelson residents' interests more broadly, I ensure that I keep abreast of new developments by regularly attending briefings and seminars on council strategies and proposals.
