CONSTITUENCY ACTIVITY

I do not hold surgeries my constituents prefer to contact me by telephone, email, and post or in person. Once contacted I investigate every complaint and endeavour to resolve their problems, I always provide an answer and feedback.

Several residents who were concerned with the effects of the benefit changes have contacted me; I was able to direct them to the relevant council department who were able to resolve their queries.

Many residents have contacted me concerning dog fouling, I have arranged for officers from the Environment Department to investigate the issue and for the areas to be monitored by wardens.

I received regular complaints/queries regarding road cleaning, grass cutting and maintenance; I liaised with relevant officers to resolve them.

Residents have contacted me regarding vandalism to their parked cars. I have liaised with Police and Community Safety Wardens to increase patrols and deter this anti social behaviour and detect those responsible.

Residents contacted me regarding the need for and the pace of their council housing repairs, I assist with their resolution. Residents who report potholes in the highway regularly contact me, I ensure the matters are dealt with by appropriate council departments and rectified. I have been dealing with the issue of flowerbeds within my community, which were overgrown and unkempt. I have arranged for them to be weeded and filled with fresh bedding plants and perennials. I am supporting the local rugby club in their wish to build a new changing rooms and viewing facility. I have been liaising between the club and council regarding a lease of land for the building.

I supported the development of a new library for the Abercarn ward.

My fellow Ward Councillor and I worked with the local community to provide a memorial to commemorate residents killed in the Llandow air disaster 1953.

I regularly attended meetings of the Cwmcarn Residents Association and try to help them resolve issue that are raised by residents.

I have been contacted regarding over age groups using junior sized football pitches. I have approached the correct Council departments and this issue has been resolved.

As Chairman of the local Primary School Governors I have been involved with the resolution of parental complaints at the school.
