Appointment was cancelled on two occasions due to MOT station equipment was broken down .

It is very thoroughly done at ccbc and that's is the best thing for MOT not any old garage

When I come into my 2i day wi xow if d it hard to get a slot

I think it should be put out to tender

To be called the day before or on the day to say they have cancelled you appointment at the testing station, is really not appropriate. People plan their day/week around appointments, and especially 1 as important as an mot test for your vehicle, and in the past it has been difficult to get an appointment that fits in with out schedule, hence why I always try booking in with plenty of time.

Because it is always difficult to re arrange tests and get a test when it is needed and I believe the equipment and process needs to be updated

In the 16 years I have held a taxi licence I have never encountered a problem.

I feel confident that the test centre will give my vehicle a honest test. Because the test centre is safety orientated not profit making I feel the mechanic will be honest when testing the vehicles.

I worry that having the ability to use a personal garage of a drivers choice is going to open the doors to backhanded MOT's that are not properly inspected and put public at risk, current taxis under go so much wear and tear and should be held up to the highest possible level of MOT inspection. Moving it is going to open flood gates to potential exploiting the system.

Difficult to get an appointment when plating is due

The process in place is working well and I have never had a problem booking my vehicles in for their plating.

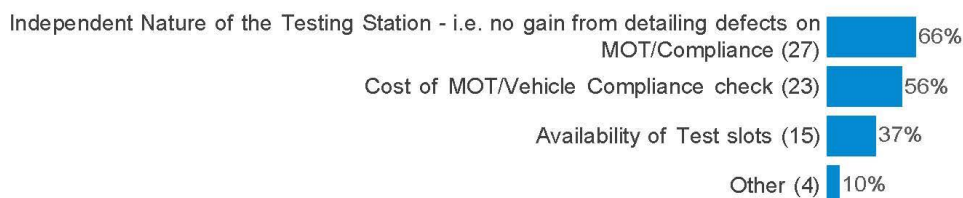
it is hard to get a test time to fit in around daily commitments

in my opinion it can not, has it works very well.

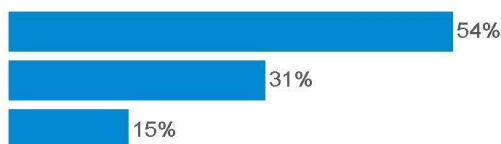
i deal solely with one garage and he deals with all my maintenance and repairs and if something is wearing out he advises me before it develops into a major problem

Better testers

Personally I would overhaul testing of vehicles earlier than 2010 and abolish them vehicles to improve standard of vehicles inside and outside looks as I think some of them give the taxi trade dis-credit to the ones clean and look after their vehicles.

I would prefer to keep in house testing but second choice would be to have a list of approved testing stations.

Any mot station in ccbc, if council contacted them and asked to carry out the compliance check on all licensed vehicles and be given guidance by council on how to do this. This will be a major cost cutting for licensing with no need for tenders and expense.

If we can arrange our own mot test it relieves the pressure on myself

It should be kept to the council to keep the in house car license with regards MOT ..other Mot stations may be just may be a little more laxed with the strict allowances of taxis ..so on that point it's a no from me to other stations

All covered by vosa

List of approved by the Council as its a wider option than the waiting times that we have at Tirybirth, council approved garages would be better because that way we still have the strict mot rules but a wider variety

This will insure that vehicles are tested under the same conditions and standards.

When you are looking after your car like we always have it should be anyone approved Like it was in lock down

Think it be far to go to any approved M.O.T testing stations

If the council had extra ramps/testers available then none of these would need to be changed.

The only benefit would be a reduction in the cost of the MOT. I see no merit in option 3 as this would require a second appointment.

I feel unhappy and worried about taking my vehicle to another testing site because they are profit making whereas the council garage is safety oriented. Also I worry if the garages tendering have they got the right qualifications.

Local garages will be more convenient and don't change for re-testing.

All mot testing centers are approved by vosa, being able to use any mot testing center will make it easier to get vehicles mot tested wherever they are in the borough and be able to have any work required carried out at the same time.

i think that having a choice of testing stations would be an advantage to taxi operators but they should be checked to make sure all vehicles are tested properly, to maintain the safety standard needed to keep all taxis safe
