WARD ACTIVITY

Shortly after being elected for St Cattwg Ward in May 2022 my County and Community Council colleagues and I distributed a card to every dwelling giving our contact details so that all constituents would know how to contact us.

I have conducted numerous walking clinics and visits to all the villages within the St Cattwg Ward accompanied by my County and Community Council Colleagues knocking doors and ensuring the people of the ward are aware of who I am and how to contact me.

I have assisted residents with planning issues, complaints about overgrown and littered paths and lanes, cleaning up of paved areas, removal of fly-tipped rubbish, housing questions and issues, drainage, nuisance parking and dog fouling.

I have assisted local volunteers in the setting up of a football club for the children of their village and acted as a point of contact for areas that the council have been able to assist in. In addition, I have attended meetings with various agencies and assisted in completing funding bids for the club.

We have distributed newsletters to the villages within the ward informing residents of the work we have been involved in and again supplying contact information for the residents to get in touch with us. We ran an information campaign to inform residents of the LDP proposals close to the areas they live in.

As a member of Environmental and Sustainability Scrutiny committee I have raised issues and asked questions on various issues.

I have been a member of the Task and Finish Group on the implications of any changes to the existing Resident's Parking Policy.

I am also a member of the Bryn Group Liaison Committee and have commented on the various planning applications that the Bryn Group have submitted, both on my own account and through Gelligaer Community Council, of which I am a member.

As a Governor of Glyngaer school I have attended meetings and school events. I have also been a founding member of a Community Speed Awareness Group within St Cattwg that is involved in actively monitoring and recording vehicle speeds within the local area.

I am a member of the Local Football Club Committee, Secretary for Ladies Football, liaising with the FAW on behalf of the team that plays in the second tier of Welsh football.

I am also the secretary for Cascade Community Centre Committee and Chairman of the local CISWO committee.
