Good Afternoon

Environmental Health have considered the information submitted by Mr White in support of the application, and have the following comments to make:

General detail of the work to be undertaken is welcomed and it's likely to result in reduced noise emission from use of the brewery yard in comparison to pre-works (without mitigation). However, concerns still exist over the proof and efficacy of the mitigation proposed based on the following:

- The main concern is that the "acoustic performance" of 71dB, is very unlikely to be achievable in real world conditions, where sound emanates hemi-spherically; the yard isn't a sealed area and noise would escape through any openings, including over the walls and through the gate.
- The information doesn't detail the real-world reductions that would be expected; this would be identified through a more detailed acoustic assessment.
- The application hasn't provided detailed installation plans for the mitigation; this should include how the provisions are to be fitted and sealed to ensure optimum performance.
- There are also concerns over whether the insulation will be weather-proof and be able to exist and perform in the long-term.
