CONSTITUENCY ACTIVITY

- ► Have worked with my fellow Ynysddu Councillor on the following:
- ▶ Held joint Police and Councillor Street Surgeries throughout the valley.
- ▶ Published regular newsletters to constituents, which have been hand-delivered throughout the valley.
- ► Fought for many years for drainage schemes throughout the valley to stop houses being flooded. The latest is a £210k drainage scheme for the top road Ynysddu.
- ▶ Highlighted the problem of cyclists not using bells or any sort of warning sound when near pedestrians on countryside park paths. As a result of my intervention, education sessions will be held in local primary schools and an article placed in Newsline to draw attention to this issue. Also have contacted our local MP who has been in correspondence with the Home Secretary over this problem.
- ▶ Reconvened a residents committee to investigate and ask questions, following a leachate of industrial liquid waste from a quarry above Ynysddu and requested the Council increase

testing and monitoring. Also, request the Council publish a newsletter with an up to date report to be published in the autumn.

- ► Kept residents on an estate in Wattsville updated on the actions taken by the Council's Legal Department in a dispute over resurfacing.
- ► Worked with local residents to organise play activities throughout the summer in the valley. Also, free tennis during the summer holidays on the Ynysddu tennis courts.
- ► Worked with Council Officers and Youth Leaders in Ynysddu Youth Club to provide new furniture, equipment and a face-lift. The club now feels revitalized with increased attendance by the young people of the surrounding villages.
- ► Fought for two drainage schemes in Wyllie where the mountain lane opens onto Heol-y-coed and on the slip road leading from Pen-y-cwarel Road to The Glades the scheme saved houses from flooding last winter.
- ▶ Reported a foul smelling discharge on the cycle path near Pont Lawrence, Cwmfelinfach. Natural Resources Wales carried out an investigation into the cause, which was a blockage and carried out tests to ensure there was no danger to public health.
- ▶ Tree planting and landscaping at the back of Glen View Terrace and Caerllwyn Terrace has now been completed with the help of our local primary schools and a bench has been installed, funded by the local Partnership Committee.
