| <p>I wish to lodge my objections to the road closures on Sunday 14 June 2015. I feel that Caerphilly County Borough Council have yet again decided to stop Christians going to their place of worship without any consultation whatsoever with the Caerphilly Council of Churches. This will mean that two Sundays running people will be unable to travel throughout Caerphilly Town because on Sunday 21 June we have the roads closed for the Caerphilly 10K run. The majority of people worshipping in churches are elderly and have to be taken to their chosen church by car and on both Sundays this will not be possible. A great deal of these people will have social interaction removed from them and hence they will be alone and unable to speak with friends.</p> <p>In addition it is obvious that Caerphilly County Borough Council have not even discussed this with the likes of Caerphilly Town Council because on the 12/13 & 14 of June the Annual Caerphilly Flower Festival is taking place and this is now supported by Caerphilly Town Council after Caerphilly County Borough Council withdrew funding two years ago. A number of churches and organisations within the town undertake a great deal of work to make this event a success with people travelling from Cardiff, Newport and further afield to view the displays. The road closures will surely mean the open top bus will be unable to travel between the displays and therefore reducing the number of visitors to be able to view the displays on the Sunday. Informing people at the beginning of April of a fait accompli for ten weeks later is not acceptable. | <p>Thank you for including me, as representative of the British Horse Society in your consultation. I apologise for the delay in responding, I have been waiting the hope of getting more information from the Velothon Customer Service helpline - but with no success so far.</p> <p>Hopefully, this event is going to bring a great deal of good publicity and, potentially, more business to the County Borough.</p> <p>As the Regional Access and Bridleways Officer for the BHS in Wales I represent the horse riders in the area. The BHS ACCIDENT WEBSITE http://www.horseaccidents.org.uk/ shows that by far the greatest number of accidents/incidents involving ridden horses are Road Traffic Accidents and most of these occur on minor roads and country lanes.</p> <p>There are many riding horses kept at livery in the Caerphilly Mountain area (between 100 and 200) and many more in the Rudry and Bedwas area, all of which are likely to be affected by drivers looking for alternative routes to those roads which will be closed for the Velothon.</p> <p>The owners/riders of these horses/ponies are most likely to ride at weekends because they are at work or in school during the week - and the bridleways and other routes that are used by these horses are usually only accessible from the local roads.</p> <p>I feel that plenty of advance warning should be given about the use of alternative routes by motorists who find that the Mountain Road B4263 and the A469 ARE CLOSED - and</p> | Equestrian Group | 21/04/2015 | <p>Comments noted.</p> <p>In order to facilitate a safe event, full road closures are necessary. advice given that they should use alternatives such as Nantgarw Road and the A470 rather than allowing them to drive up the bypass road and then having to turn off along Waunwaelod Way or Blackbrook Road because the road ahead is closed. Unfortunately neither of these lanes currently have any reduced speed limit on them and vehicles already drive along them far too fast for the conditions on these very narrow and twisting country lanes.

Warning signs should also be placed on the lanes themselves for the day (or preferably even longer) stating that drivers should be prepared that they may meet horse riders, walkers and leisure cyclists on these roads. There should also be SLOW signs. It would also be good if some speed restrictions could be imposed. The most dangerous section of Waunwaelod Way is where drivers coming too fast downhill from the mountain, come to the blind bend at the bottom and if they meet anything coming towards them there is danger of a collision - or, if they try to take avoiding action, the vehicle ends up crashing through the hedge.

As a resident of Waunwaelod Way, I am also concerned that many motorists who will want to go to the mountain to watch the Velothon will also want to park their cars as close as possible and, as has happened in the past, they will park along Waunwaelod Way, blocking entrances to properties and making the road so narrow that it will be impossible for two vehicles to pass anywhere along the road or to turn when they decide to go home.

I am also concerned about the 'elite' race in the afternoon which states 'that it will use additional loops of Caerphilly Mountain which will involve wider road closures I have phoned the Velothon Customer helpline several times but there was never anyone there who could help. I have left my phone number 3 times with the promise that 'someone would get back to me' but no-one ever has. Neither have they responded to the e.mail I sent them.
